creation and duties of school support teams for certain public schools designated as needing improvement; and providing other matters properly relating thereto.

Assembly Bill No. 461—AN ACT relating to management of land; authorizing the Division of State Lands of the State Department of Conservation and Natural Resources to establish and carry out programs to conserve certain sagebrush ecosystems; requiring the Division to coordinate the establishment of a program to improve certain sagebrush ecosystems; establishing the Account to Restore the Sagebrush Ecosystem in the State General Fund; establishing the Sagebrush Ecosystem Council within the Department; prescribing the duties of the Council; and providing other matters properly relating thereto.

The Committee on Escort, in company with The Honorable Mark Amodei, United States Representative from Nevada, appeared before the bar of the Assembly.

The Committee on Escort escorted the Representative to the rostrum.

The Speaker of the Assembly welcomed Representative Amodei and invited him to deliver his message.

Representative Amodei delivered his message as follows:

MESSAGE TO THE LEGISLATURE OF NEVADA  
SEVENTY-SEVENTH SESSION, 2013

Thank you, Madam Speaker. For those of you that leave the way I usually left at this point, please feel free to do so.

Madam Speaker, Mr. President, Chief Clerk, Secretary of the Senate, Governor, Judge. I've just been in time-out in the Speaker's office for a while, and I haven't been in time-out in the Speaker's office since 2003. It was a bit of an intimidating thing. So thank you all for coming.

I've got to tell you, it's fairly embarrassing to be here to give one of these talks which I routinely skipped for the majority of my legislative career. I'm sure it comes as no secret what my plan was. They always brought the person in through that door, so I sat in the empty desk up there with my picture— it doesn't get better when it's bigger, does it? I just slipped right out that door. I was very bipartisan; I left for the Democrats and Republicans alike, so I was never picking on anybody.

First of all, thank you for your kind words and your remembrances of my mother. That means a lot, and I don't know if I'll ever be able to repay you. I can assure you that you've got an overweight left-hander in Carson City Who has your back if you ever need anything.

You don't need to get too comfortable because I'm not a total hypocrite; I'm not going to keep you here very long for this. So you can time Heller and see if he or Reid went longer or Horsford or Titus, but we're moving and getting out of here.

As the only member of the delegation having served in both houses, I look up there and see the Eisen seat, which was my seat when I was here and where they put the troublemakers in the back row on that side—so I hope you're upholding the tradition—and then think about going to the Senate for 12 years with the rookie class of Maggie Carlton and Terry Care and myself. There's a rumor out that Maggie Carlton is chairing some fairly important committee in the Assembly. You know, it's amazing what you can do without a high school education. The both of us are just doing great, aren't we, Madam Chair?

Of course, I remember that living over my back fence was now—Majority Leader Horne and—I'm having a hard time with this—*Senator Atkinson*? How are you doing, baby? I just got to do this because I think, no matter what kind of shape those of you from out of the Carson City area keep your bedrooms in—and even if there's a picture of how you keep house while you're here during the legislative session in the paper—you can still continue to be

reelected and prosper and succeed in the Nevada Legislature. So go back to—I don't know if it was the *Nevada Appeal* or the *Reno Gazette-Journal*—but these guys let a photographer into their house, and they took pictures. Mo, keep an eye on him. I hope someone is keeping his picture appointments.

One of the reasons I used to skip this is that I really didn't need somebody from the federal delegation coming in and telling me what to do. Thanks a lot, but come walk in my shoes; come feel my pain, that sort of stuff. I've just got a couple things I want to share with you. One is—and it's hard to do while you're doing it, and I know I didn't do it—value your process. Value your process. For as much as all of the pundits and the folks that get paid to write and blog and Twitter and tweeter and whatever all that other stuff is. The fact that you have a finite time limit and when you leave, despite whatever fights you engaged in, you have a balanced budget; and the fact that you have the intimacy with your colleagues that you do in this process, is something you should value. I think it allows a state like ours to get the work done, with asterisks, in our procedure and our process. I can tell you that in reflecting on my time here in terms of the work done in committee and on the floor with the issues, the depth that is brought to bear in the Nevada Legislature on the north and south sides of the building has, most days, much more depth than what I experience in another place about 2,500 miles east of here. I know that it's going to be hard to do at times, but please take that for what it's worth.

I don't have to tell any of you that our state is 86 percent owned by the federal government, so whether you are talking about economic development, natural resources, or the tax base, that is a challenge that no other state in the lower 48 faces. Every time we want to do something—whether you agree or not—that involves land use or resources, we are coordinating with someone in the federal government for the most part. Governor, hats off to your administration and your folks, the Leo Drozdoffs, the Colleen Crippses, the Jason Kings, the folks that work in resources in the state—phenomenal resources. While I didn't always agree with them, they do a great job, and their credibility is outstanding.

I commit to you that as long as I am there, we will continue to do everything in our power every day, in an oversight sense, to make sure that the input from the state level, the county level, and the community level on the issues that these people deal with is something that is taken into account. We have several pieces of legislation that we are going to try to do more than take it into account—say that if you haven't got the association of counties on board with you or the state administrative folks, then your decision doesn't stand. Now I'm sure there won't be any opposition to that in a town like Washington, D.C., but you know what? We're going to have the conversation and we're going to start pushing it. We're also going to push for more federal land to go through an auction process that is similar in many ways to the Southern Nevada Public Lands Management Act that we had great success with so that we can return jurisdiction over planning and zoning in our urban and city areas to the people who are elected in Nevada to deal with those issues. We're not going to tell you what decision to make—just going to say it's our decision and that it should be a decision that is taken in Nevada.

I can tell you that each and every day that we wake up, if the federal government is trying to take control of ground water in Nevada we will win that battle or they will be carrying us out on our shield if we lose it. Absolutely, positively, the biggest lever we've got—jealously guard it, please—we ought to be making those decisions, and that's our best lever.

Finally, I want to say this: We are a resource. This is a service business, just like yours, and I hope you will never wake up on the day where somebody says, "Here's what Amodei's office is trying to tell us what to do." That is not our place. Our place is to make the federal government as responsible to the people of Nevada as possible and to return as much of the decision making process over resources and land use decisions to people in Nevada, and that's what we're going to do. So we're here to help you.

I'm looking forward to working with Steven Horsford—two of us on the Natural Resources Committee; Dina Titus—two of us on the Veterans' Affairs Committee. We occupy some

unique space in those committees with two members from a small western state, so we are looking forward to the ability to do something.

I want to say again thank you very much. I am sorry for keeping you as long as I did. Governor, I hope I didn't go too far over the agreed time.

You're almost at the halfway point, so I'll look forward to coming back and wandering around the building, although I was told to wait, Madam Speaker, in your conference room. I said, "I was in time-out in the Speaker's office before I came in here. I haven't been in time-out in the Speaker's office since the 2003 Session, so it's a little bit humbling." And then when you see some people that you know when you walk around the building and you're flanked by the Legislative Police, they're asking, "So are you the next one that's under arrest for something to do with whatever?" I said, "No, it's not like the old days." I think I stole everything I wanted out of the building when I was here as an officeholder. Check my pockets or whatever. But it's nice to come home. It's nice to see those new and not so new. I'm learning not to use the word *old*, Maggie, so please make a note of that.

Thank you very much for your courtesies and good luck in the rest of it. I look forward to working with you all.

(b) ***Provide for the appointment by the Board of Regents of a Student Regent to serve as a voting member of the Board of Regents, and provide the qualifications and term of office of the Student Regent;*** and ~~{define their}~~

(c) ***Define the duties*** ~~{}~~ ***of the Board of Regents.***
