PROCLAMATION

WHEREAS, Physicians have played an important role in the rich history of the State of Nevada, beginning in the early days of the State when doctors lived in a rugged country that was sparsely settled and had to be self-reliant in an environment without well-equipped hospitals or a corps of trained assistants; and

WHEREAS, The Legislature began regulating the medical profession in 1875, when it approved an act titled, “An Act to prevent the practice of medicine and surgery by unqualified persons,” which mandated that a physician or surgeon file a copy of a diploma or certificate of graduation with the county recorder and required the arrest of persons who did not comply; and

WHEREAS, In the same year, the Nevada State Medical Association was created in Virginia City, with the goals of improving health and well-being, and addressing the needs of patients, physicians, and the Nevada community by serving with responsibility and integrity as advocates for high-quality health care; and

WHEREAS, The medical profession became further regulated in 1899, when the Legislature created the State Board of Medical Examiners to license physicians to ensure that only well qualified, competent physicians received licenses to practice in Nevada; and

WHEREAS, Throughout the State’s history, Nevada’s physicians have played a vital role in our State, nation, and the world by tending to the health and well-being of their patients and by contributing to the reservoir of mankind’s scientific knowledge; and

WHEREAS, As Nevada’s population has grown to nearly 2.8 million people in 2012 and has become more diverse, the field of medicine has matured, with doctors now using state-of-the-art technology to serve the medical needs of this growing population; and

WHEREAS, The University of Nevada School of Medicine plays an important role in bringing high quality physicians to Nevada by offering medical degrees, residency programs, and fellowship programs throughout Nevada to serve the needs of both rural and urban populations; and

WHEREAS, Nevadans owe a debt of gratitude to physicians for the sympathy and compassion of physicians in ministering to the sick and in alleviating human suffering; now, therefore, be it

PROCLAIMED, That the Nevada Legislature commends and recognizes the important contributions of the Nevada State Medical Association and its members to improving the health and quality of life of all Nevadans and encourages all citizens of Nevada to express gratitude to physicians who serve their health needs; and be it further

PROCLAIMED, That April 25, 2013, is designated as “Physicians Day.”
