Senate Bill No. 226—AN ACT relating to firearms; requiring an eligible person who holds a permit to carry a concealed firearm to obtain a driver's license or identification card which designates that the person holds such a permit; authorizing such a person to hold an additional identification card which does not contain the designation; authorizing the Department of Motor Vehicles to establish regulations relating to such drivers' licenses and identification cards; revising the definition of "concealed firearm"; authorizing a person to obtain one permit to carry a concealed firearm for all handguns owned by the person; revising provisions relating to a person's demonstration of competence with certain firearms for the purpose of obtaining or renewing a permit to carry a concealed firearm; deleting certain provisions relating to the registration of firearms capable of being concealed; revising the applicability of certain provisions pertaining to the regulation of firearms by local governments; and providing other matters properly relating thereto.

Senator Settlemeyer moved that the bill be referred to the Committee on Judiciary.
