Remarks by Senators Ford and Cegavske.

SENATOR FORD:

Thank you, Mr. President. During the 2011 Legislative Session, the Legislature enacted Senate Bill 381, which revised the method by which certain counties issue marriage licenses. In a county with at least 100,000 residents but fewer than 700,000 residents (currently Washoe County), in which a commercial wedding chapel has been in business for five years or more, the bill required the County Commission either to ensure that a marriage license bureau is open

daily from 8 a.m. to midnight, including holidays, or provide for a program in which a chapel that has been in business for five years or more may issue marriage licenses when the marriage license bureau is closed. In a county whose population is less than 100,000 (currently all counties other than Clark and Washoe Counties), the bill allowed the Board of County Commissioners to establish such a program but does not require it to do so.

Senate Bill 381 required a chapel that is authorized to issue marriage licenses to file a registration form and a \$50,000 performance bond with the county clerk, refer any application for a marriage license requiring the signature of a parent or guardian to the county clerk, and comply with the same statutory requirements as the county clerk. The bill required the chapel to collect license fees and remit them to the clerk, and it provided that the chapel's marriage license records are public records.

Finally, Senate Bill 381 made permanent the authority for county offices to deviate from the required hours of operation, if approved by the respective Board of County Commissioners.

This measure was effective on June 13, 2011, and is scheduled to expire by limitation on June 30, 2013.

Senate Bill No. 77 removes the prospective expiration for provisions relating to the issuance of marriage licenses by certain commercial wedding chapels that were passed by the Legislature during the 76th Legislative Session.

SENATOR CEGAVSKE:

Thank you, Mr. President. I have some constituents who own wedding chapels in Las Vegas so I would like to verify, on the record, what I was told this morning, that there is a population cap that extends from the previous Session in one of the Senate Bills and that Senate Bill No. 77 only applies to the rural and northern counties.

The President appointed a Committee on Escort consisting of Senator Goicoechea and Assemblyman Grady to wait upon the Honorable Representative Mark Amodei and escort him to the Assembly Chamber.

Representative Mark Amodei delivered his message as follows:

MESSAGE TO THE LEGISLATURE OF NEVADA
SEVENTY-SEVENTH SESSION, 2013

Thank you Madam Speaker, Mr. President, Chief Clerk of the Assembly, Secretary of the Senate, Governor and Judge. Thank you all for coming. I have to tell you, it is fairly embarrassing to be asked to deliver an address to you because I routinely skipped them for the majority of my time serving in the Nevada Legislature. I am sure it is no secret that I would sit in the empty desk up there near where my picture now hangs, and slip right out the door. I was bipartisan; I left during both Democrat and Republican addresses.

Thank you all for your kind words and your remembrances of my dear mother, Joy. It means a lot. I don't know that I will ever be able to repay you.

You don't need to get too comfortable; I am not a hypocrite. I am not going to keep you here very long. You can time U.S. Senator Heller and see if he or Senator Reid, Representative Horsford or Representative Titus go longer than me.

Having served in both Houses, I look up and see Assemblyman Eisen's seat which was my seat when I was here. It is where they put the troublemakers—in the back row on that one side. I think about going to the Senate for 12 years with the rookie class of Senator Maggie Carlton and Senator Terry Care. Now there is a rumor out that Senator-now-Assemblywoman Carlton is chairing a fairly important committee in the Assembly. It is amazing what you can do with just a high school education; she and I both are just doing great aren't we Madam Speaker?

One of the reasons I used to skip these Congressional delegation addresses is I never felt we needed someone from the federal government coming in to tell me, as a State Legislator, what to do.

So I just have two things to share with you. One is, it is not easy but make sure you value your process. The pundits and those who get paid to write and blog about politics should take note that the Nevada Legislature has a finite time limit, and when you leave, despite your disagreements, you have a balanced budget. You have intimacy with your colleagues in this process and that should be valued. It allows a State like Nevada to get work done. In reflecting back on my time here in the Nevada Legislature, compared to my 18 months as part of Nevada's Congressional Delegation, I am reminded how we handled issues; the depth that is brought to bear is impressive. The work is hard to do at times but please keep up the good work.

Second, the State of Nevada is 86 percent owned by the federal government. Whether you are talking about economic development or natural resources, federal land ownership is a challenge that no other state in the lower 48 faces. Nearly every time you want to do something, whether you agree with it or not, if it involves land use or natural resources, it has to be coordinated through the federal government.

Governor, hats off to your administration and your agency staff including Leo Drozdoff, Colleen Cripps and Jason King. These folks work in natural resources in this State and they are phenomenal resource managers. While I didn't always agree with them, they do a great job and they are highly credible. I commit to you, as long as I am in Washington D.C., I will continue to do everything in my power, every day, to ensure that input from the State, counties and communities on the issues important to Nevada is heard. There are several pieces of legislation where we are looking to make sure the Association of Counties is on board, as well as the State administration, because those interests are important to the decisions being made.

I am pushing for more federal land to go through an auction process that is similar to that used as part of the Southern Nevada Public Lands Management Act. It has worked well in this State. I want to return jurisdiction over planning and zoning in our urban areas to the people who are elected in Nevada to deal with it. The federal government does not need to control groundwater decisions in Nevada; I am committed to keeping such decision making at the State level. My goal is to return as much as possible of the decision making process over our land use and natural resources to the people of Nevada.

Finally, I want to remind you that my office is a resource. I am in public service just like you. My office has its place in making the federal government as responsible to the people of Nevada as possible. We are here to help you.

I am looking forward to working with Representative Horsford as we are both on the Natural Resources Committee. Representative Titus and I are both on the Veterans Affairs Committee. Nevada occupies some unique space in Washington and we look forward to the ability to accomplish good things.

Thank you again for having me. It is nice to come home and see those of you I already know and meet some new faces. Good luck and I look forward to working with you all.
