[S.B. 7](#) Revises provisions governing the admission of persons with certain mental conditions to and the release of such persons from certain facilities. (BDR 39-64)

[S.B. 15](#) Requires a mental health professional to notify certain persons of explicit threats communicated by a patient in certain circumstances. (BDR 54-3)

[S.B. 35](#) Ratifies and enacts the Interstate Compact on Mental Health. (BDR 39-330)
