

SENATE BILL NO. 312—SENATOR MANENDO

SUMMARY—Makes various changes concerning victim impact panels. (BDR 43-888)

AN ACT relating to driving under the influence; revising provisions concerning impact panels of victims of crimes involving driving under the influence of intoxicating liquor or a controlled substance; providing a penalty; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Under existing law, a judge who sentences a defendant for a crime involving  
2 driving or being in actual physical control of a vehicle while under the influence of  
3 intoxicating liquor or a controlled substance is required to order the defendant to  
4 attend in person a live meeting of a panel of victims, unless such a meeting is not  
5 available within 60 miles of the defendant’s residence. The judge or judges in each  
6 judicial district are responsible for maintaining a list of the panels of persons who  
7 have been injured or have had members of their families or close friends injured or  
8 killed by a person who was driving or in actual physical control of a vehicle while  
9 under the influence of intoxicating liquor or a controlled substance and who have,  
10 by contacting the judge or judges in the district, expressed their willingness to  
11 discuss collectively the personal effect of those crimes. (NRS 484C.530)

12 **Sections 2-13** of this bill establish the requirements for victim impact panels to  
13 be sponsored and conducted by organizations, in lieu of or in addition to the panels  
14 held under the direction and supervision of the judges. In particular, **sections 2-13**  
15 make the Department of Motor Vehicles responsible for regulating the  
16 organizations that sponsor and conduct victim impact panels. **Section 6** requires  
17 organizations that wish to sponsor victim impact panels to be registered with the  
18 Department and establishes the requirements for such registration. **Section 7**  
19 requires that each meeting of such a victim impact panel be conducted by a  
20 qualified coordinator and specifies the training required to serve as a coordinator.  
21 **Section 8** requires victims who wish to make a presentation as a member of such a  
22 victim impact panel to submit to the sponsor information concerning the events that  
23 gave rise to the harms suffered by the victim and provides a criminal penalty for  
24 persons who make false statements in connection with such harms. **Section 9**

25 establishes requirements for meetings of such victim impact panels and requires  
26 that, if such a meeting is conducted in person, security personnel must be present at  
27 the site of the meeting. **Section 9** further authorizes a meeting of such a victim  
28 impact panel to be conducted by means of videoconferencing or other form of  
29 electronic communication. **Sections 10-12** establish various procedures for the  
30 receipt and disbursement of money generated from fees for attending meetings of  
31 panels, administrative fines and civil penalties. **Section 13** requires the Department  
32 to adopt regulations to carry out its duties relating to **sections 2-13**. **Section 14** of  
33 this bill adds references to the new requirements of **sections 2-13** to the existing  
34 requirements for victim impact panels, which remain in effect for panels held under  
35 the direction and supervision of the judge or judges of each judicial district.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 484C of NRS is hereby amended by adding  
2 thereto the provisions set forth as sections 2 to 13, inclusive, of this  
3 act.

4 **Sec. 2.** *As used in sections 2 to 13, inclusive, of this act,*  
5 *unless the context otherwise requires, the words and terms defined*  
6 *in sections 3, 4 and 5 of this act have the meanings ascribed to*  
7 *them in those sections.*

8 **Sec. 3.** *“Registered sponsor” means an organization in this*  
9 *State that is registered with the Department to sponsor meetings of*  
10 *victim impact panels.*

11 **Sec. 4.** *“Victim” means a person who has been injured or*  
12 *has had a member of his or her family or a close friend injured or*  
13 *killed by a person who was driving or in actual physical control of*  
14 *a vehicle while under the influence of intoxicating liquor or a*  
15 *controlled substance or who was engaging in any other conduct*  
16 *prohibited by NRS 484C.110, 484C.120, 484C.130 or 484C.430 or*  
17 *a law of any other jurisdiction that prohibits the same or similar*  
18 *conduct.*

19 **Sec. 5.** *“Victim impact panel” or “panel” means three or*  
20 *more victims who meet in the presence of persons who have been*  
21 *sentenced for crimes involving driving while under the influence*  
22 *of intoxicating liquor or a controlled substance to discuss*  
23 *collectively the personal effect on the victims of such crimes.*

24 **Sec. 5.5.** (Deleted by amendment.)

25 **Sec. 6. 1.** *An organization that wishes to sponsor meetings*  
26 *of victim impact panels pursuant to subsection 2 of NRS 484C.530*  
27 *and sections 2 to 13, inclusive, of this act, must be registered with*  
28 *the Department.*

29 **2.** *An application for registration must be submitted in the*  
30 *form prescribed by the Department. The application must include,*  
31 *without limitation:*



1 (a) *Proof that the organization is:*

2 (1) *A nonprofit organization that is recognized as exempt*  
3 *from taxation pursuant to section 501(c)(3) of the Internal*  
4 *Revenue Code, 26 U.S.C. § 501(c)(3), as amended, or a*  
5 *corporation for public benefit as defined in NRS 82.021; and*

6 (2) *Is registered with the Secretary of State, if registration is*  
7 *required by law.*

8 (b) *A list of the names of all victims who at the time of the*  
9 *application have:*

10 (1) *Expressed to the organization a willingness to serve as*  
11 *members of a panel; and*

12 (2) *Submitted the documentary or other information*  
13 *required pursuant to section 8 of this act.*

14 (c) *The name of at least one qualified coordinator who*  
15 *satisfies the requirements of section 7 of this act and who is*  
16 *available to conduct meetings of victim impact panels on behalf of*  
17 *the registered sponsor.*

18 (d) *If the sponsor intends to conduct a meeting of a victim*  
19 *impact panel by videoconference or other electronic means, a*  
20 *description of the facilities for such communication that the*  
21 *sponsor intends to use.*

22 3. *A registered sponsor must renew its registration annually*  
23 *in accordance with procedures established by the Department.*

24 4. *The Department may, at reasonable times and without*  
25 *notice, inspect the facilities and records of a registered sponsor.*

26 5. *If the Department determines that a person or organization*  
27 *has sponsored a victim impact panel without being registered*  
28 *pursuant to this section, the Department shall:*

29 (a) *Impose an administrative fine of not more than \$5,000 on*  
30 *the person or organization; and*

31 (b) *Refuse to accept an application for registration from the*  
32 *person or organization for 2 years after the date of the*  
33 *Department's determination.*

34 **Sec. 7. 1.** *Each meeting of a victim impact panel sponsored*  
35 *by a registered sponsor must be conducted by a qualified*  
36 *coordinator. A coordinator must have successfully completed*  
37 *specialized training in victim advocacy, including, without*  
38 *limitation, training offered by the National Organization for*  
39 *Victim Assistance or a comparable organization that is nationally*  
40 *recognized.*

41 2. *If the Department determines that a registered sponsor has*  
42 *violated any provision of this section, the Department shall revoke*  
43 *the registration of the sponsor.*

44 **Sec. 8. 1.** *Before a victim may make a presentation as a*  
45 *member of a victim impact panel in a meeting of the panel*



1 *conducted pursuant to sections 2 to 13, inclusive, of this act, the*  
2 *victim must submit to the registered sponsor documentary and*  
3 *other information concerning the events that gave rise to the*  
4 *harms suffered by the victim.*

5 *2. A registered sponsor shall verify the accuracy of the*  
6 *information provided by the victim and certify its accuracy to the*  
7 *Department.*

8 *3. A person who knowingly makes a false statement, certifies*  
9 *to an incorrect document or withholds information for the purpose*  
10 *of receiving or assisting another person in receiving victim*  
11 *compensation or some other benefit under subsection 2 of NRS*  
12 *484C.530 and sections 2 to 13, inclusive, of this act to which he or*  
13 *she is not entitled is guilty of a misdemeanor and shall be*  
14 *punished by a fine of not more than \$1,000 and the performance*  
15 *of not more than 100 hours of community service pursuant to the*  
16 *conditions prescribed in NRS 176.087.*

17 **Sec. 9. 1. A meeting of a victim impact panel conducted**  
18 **pursuant to sections 2 to 13, inclusive, of this act:**

19 **(a) Must include presentations by not fewer than three panel**  
20 **members.**

21 **(b) May be conducted in person or by videoconference or other**  
22 **electronic means approved by the Department; and**

23 **(c) Must, if conducted in person, have security personnel**  
24 **present during the meeting at the site of the meeting.**

25 *2. If the Department determines that a registered sponsor has*  
26 *violated any provision of this section, the Department shall*  
27 *suspend the registration of the sponsor for 1 year and may impose*  
28 *an administrative fine of not more than \$1,000.*

29 **Sec. 10. 1. A registered sponsor shall collect the fees**  
30 **established by the court pursuant to subsection 2 of NRS 484C.530**  
31 **from defendants who attend a meeting of a victim impact panel.**

32 **2. Of the money collected by a registered sponsor pursuant to**  
33 **this section:**

34 **(a) Not less than 20 percent must:**

35 **(1) If the Department adopts regulations providing for the**  
36 **conduct of programs of victim compensation by registered**  
37 **sponsors, be disbursed by the registered sponsor directly to a**  
38 **victim for services, including, without limitation:**

39 **(I) Funeral expenses;**

40 **(II) Medical expenses, expenses for psychological**  
41 **counseling and nonmedical remedial care and treatment rendered**  
42 **in accordance with a religious method of healing, which are**  
43 **actually and reasonably incurred as a result of the injury or death**  
44 **of a victim;**



1           (III) *Temporary assistance with the ordinary expenses*  
2 *of daily life, including, without limitation, housing, utilities and*  
3 *food;*

4           (IV) *Travel expenses, including, without limitation,*  
5 *airfare, car rental and hotel accommodations; and*

6           (V) *Other reasonable services for the victim; or*

7           (2) *Be remitted to the Department for deposit with the State*  
8 *Treasurer for credit to a separate account in the Fund for the*  
9 *Compensation of Victims of Crime created pursuant to NRS*  
10 *217.260 to provide compensation to victims of crimes involving*  
11 *driving while under the influence of intoxicating liquor or a*  
12 *controlled substance. Any money received pursuant to this*  
13 *subparagraph must be accounted for separately in the Fund in the*  
14 *separate account described in section 11 of this act.*

15           (b) *Not less than 10 percent must be disbursed by the*  
16 *registered sponsor in the form of grants to law enforcement*  
17 *agencies in this State to support activities relating to crimes*  
18 *involving driving while under the influence of intoxicating liquor*  
19 *or a controlled substance, including, without limitation, purchase*  
20 *of equipment, enforcement, specialized training and community*  
21 *education programs.*

22           3. *A registered sponsor shall, on a quarterly basis, submit a*  
23 *financial statement to the Department and shall submit an annual*  
24 *financial statement in connection with its application for the*  
25 *renewal of its registration. The financial statement must be in a*  
26 *format prescribed by the Department and include, without*  
27 *limitation:*

28           (a) *The name and address of each victim and law enforcement*  
29 *agency to which the registered sponsor made a disbursement;*

30           (b) *The amount of each disbursement;*

31           (c) *The date of each disbursement; and*

32           (d) *An itemization of the services or purposes for which the*  
33 *money was disbursed.*

34           ↪ *Each disbursement must be supported by a receipt or other*  
35 *evidence of the disbursement.*

36           4. *If the Department determines that a registered sponsor has*  
37 *violated any provision:*

38           (a) *Of this section, the Department shall suspend the*  
39 *registration of the sponsor for not more than 2 years; and*

40           (b) *Of subsection 1, the Department shall impose an*  
41 *administrative fine of not more than \$5,000.*

42           **Sec. 11.** *All administrative fines collected by the Department*  
43 *pursuant to sections 2 to 11, inclusive, of this act, must be*  
44 *deposited with the State Treasurer for credit to a separate account*  
45 *in the Fund for the Compensation of Victims of Crime created*



1 *pursuant to NRS 217.260 to provide compensation to victims of*  
2 *crimes involving driving while under the influence of intoxicating*  
3 *liquor or a controlled substance.*

4 **Sec. 12. 1.** *In addition to any other penalty provided by law,*  
5 *a person convicted of a violation of NRS 484C.110, 484C.120,*  
6 *484C.130 or 484C.430 is liable to the State for a civil penalty of*  
7 *\$5, payable to the Department.*

8 **2.** *Any money received by the Department pursuant to*  
9 *subsection 1 must be retained by the Department and used to*  
10 *defray the expenses incurred by the Department to administer the*  
11 *provisions of subsection 2 of NRS 484C.530 and sections 2 to 13,*  
12 *inclusive, of this act.*

13 **Sec. 13.** *The Department shall adopt regulations to carry out*  
14 *the provisions of sections 2 to 13, inclusive, of this act.*

15 **Sec. 14.** NRS 484C.530 is hereby amended to read as follows:  
16 484C.530 1. ~~The~~ *Except as otherwise provided in*  
17 *subsection 2, the judge or judges in each judicial district shall cause*  
18 *the preparation and maintenance of a list of the panels of persons*  
19 *who:*

20 (a) *Have been injured or had members of their families or close*  
21 *friends injured or killed by a person who was driving or in actual*  
22 *physical control of a vehicle while under the influence of*  
23 *intoxicating liquor or a controlled substance or who was engaging in*  
24 *any other conduct prohibited by NRS 484C.110, 484C.120,*  
25 *484C.130 or 484C.430 or a law of any other jurisdiction that*  
26 *prohibits the same or similar conduct; and*

27 (b) *Have, by contacting the judge or judges in the district,*  
28 *expressed their willingness to discuss collectively the personal*  
29 *effect of those crimes* **H** *at a panel held under the direction and*  
30 *supervision of the judge or judges at the courthouse.*

31 **➤** *The list must include the name and telephone number of the*  
32 *person to be contacted regarding each such panel and a schedule of*  
33 *times and locations of the meetings of each such panel. The judge or*  
34 *judges shall establish, in cooperation with representatives of the*  
35 *members of the panels, a fee, if any, to be paid by defendants who*  
36 *are ordered to attend a meeting of the panel. The amount of the fee,*  
37 *if any, must be reasonable. The panel may not be operated for profit.*

38 **2.** *In lieu of, or in addition to, a list of panels described in*  
39 *subsection 1, the judge or judges in each judicial district may*  
40 *cause the preparation and maintenance of a list of the registered*  
41 *sponsors of victim impact panels that are registered with the*  
42 *Department pursuant to section 6 of this act. The list must include*  
43 *the name and telephone number of the registered sponsor to be*  
44 *contacted regarding each such panel and a schedule of times and*  
45 *locations of the meetings of each such panel. The judge or judges*



1 *shall establish, in cooperation with the Department and*  
2 *representatives of the registered sponsors of the panels, the fees to*  
3 *be paid by defendants who are ordered to attend a meeting of the*  
4 *panel. The amount of the fees must be reasonable.*

5 3. Except as otherwise provided in this subsection, if a  
6 defendant pleads guilty or guilty but mentally ill to, or is found  
7 guilty or guilty but mentally ill of, any violation of NRS 484C.110,  
8 484C.120, 484C.130 or 484C.430, the court shall, in addition to  
9 imposing any other penalties provided by law, order the defendant  
10 to:

11 (a) Attend in person, at the defendant's expense, a live meeting  
12 of a panel ~~of persons who have been injured or had members of~~  
13 ~~their families or close friends injured or killed by a person who was~~  
14 ~~driving or in actual physical control of a vehicle while under the~~  
15 ~~influence of intoxicating liquor or a controlled substance or who~~  
16 ~~was engaging in any other conduct prohibited by NRS 484C.110,~~

22 (b) Pay the fee, if any, established by the court pursuant to  
23 subsection 1 ~~†~~ *or 2.*

24 ➤ The court may, but is not required to, order the defendant to  
25 attend such a meeting if one is not available within 60 miles of the  
26 defendant's residence.

27 4. A person ordered to attend a meeting pursuant to subsection  
28 ~~†~~ 3 shall, after attending the meeting, present evidence or other  
29 documentation satisfactory to the court that the person attended the  
30 meeting and remained for its entirety.

31 5. *As used in this section, "judge" means:*

32 (a) *A judge of a district court;*

33 (b) *A judge of a municipal court; and*

34 (c) *A justice of the peace.*
