SUMMARY—Revises provisions governing the employment, promotion, dismissal, demotion and suspension of state employees. (BDR 23-285)

AN ACT relating to the State Personnel System; requiring the Personnel Commission to adopt certain regulations governing the employment, promotion, dismissal, demotion or suspension of state employees; authorizing the Commission to adopt certain regulations relating to state employees with disabilities and applicants for positions affecting public safety; making various other changes relating to the State Personnel System; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 This bill makes various changes relating to the State Personnel System.
2 Existing law provides that certain promotional appointees who fail to attain
3 permanent status in the position to which they were promoted, or who are
4 dismissed for cause other than misconduct or delinquency, must be restored to the
5 positions from which the appointees were promoted. (NRS 284.300) **Section 1**
6 of this bill requires the Personnel Commission to adopt regulations setting forth the
7 circumstances under which such a promotional appointee may be: (1) restored to
8 the position from which he or she was appointed; (2) placed in a position other than
9 the position from which he or she was appointed; or (3) placed on an appropriate
10 reemployment list.

11 Existing law authorizes the Commission to adopt regulations which provide for
12 filling, under certain circumstances, positions in the classified service of the State
13 without competition. (NRS 284.305) **Section 2** of this bill authorizes the



14 Commission to adopt regulations that provide for filling positions in the classified
15 service without competition by the appointment of current employees with
16 disabilities to certain positions.

17 Existing law requires an appointing authority to make continued efforts to
18 retain an employee with a disability in state service by making reasonable
19 accommodations. Existing law also requires an appointing authority to consider
20 separation from service or disability retirement if an employee with a disability can
21 no longer perform the essential functions of his or her position with or without
22 reasonable accommodations. (NRS 284.379) **Section 3** of this bill requires an
23 appointing authority to also consider whether an employee with a disability can be
24 appointed to a position at or below the grade level of the employee's current
25 position before considering separation from service or disability retirement.

26 If a classified employee is dismissed, involuntarily demoted or suspended,
27 existing law requires the appointing authority to give the employee written notice
28 of that fact, delivered personally or mailed to the employee. (NRS 284.385) **Section**
29 **4** of this bill eliminates the requirement for delivery in person or by mail and
30 requires the Commission to adopt regulations setting forth the procedures for
31 properly notifying a classified employee of dismissal, involuntary demotion or
32 suspension.

33 Existing law provides, with limited exception, that an employee who consumes
34 or is under the influence of alcohol, a controlled substance or certain other drugs is
35 subject to disciplinary action or required to be referred to an employee assistance
36 program. (NRS 284.4062, 284.4063) **Sections 5 and 6** of this bill authorize the
37 Commission to adopt regulations setting forth the circumstances under which a
38 person who holds a valid registry identification card to engage in the medical use of
39 marijuana is subject to disciplinary action or required to be referred to an employee
40 assistance program.

41 Existing law authorizes, under certain circumstances, an appointing authority to
42 ask an employee who admits to consuming a controlled substance for the name of
43 the person who prescribed the use of the controlled substance. (NRS 284.4064)
44 **Section 7** of this bill authorizes an appointing authority to ask an employee who
45 admits to consuming marijuana for proof that the employee holds a valid registry
46 identification card to engage in the medical use of marijuana.

47 Existing law sets forth limited circumstances under which an appointing
48 authority may request an employee to submit to a screening test for alcohol or
49 drugs. (NRS 284.4065) **Section 8** of this bill adds an additional circumstance to
50 authorize an appointing authority to request that an employee submit to a screening
51 test if the employee has or is involved in a work-related accident or injury. **Section**
52 **8** also requires the Commission to define by regulation "work-related accident or
53 injury."

54 Existing law requires an appointing authority to screen an applicant for alcohol
55 and drugs before hiring the applicant for any position of employment that affects
56 public safety. (NRS 284.4066) **Section 9** of this bill authorizes the Commission to
57 adopt regulations relating to applicants for such positions whose screening test
58 indicates the presence of marijuana and who hold valid registry identification cards
59 to engage in the medical use of marijuana.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 284.300 is hereby amended to read as follows:
2 284.300 1. ~~[Any]~~ *The Commission shall adopt regulations*
3 *setting forth the circumstances under which a promotional*



1 appointee who fails to attain permanent status in the position to
2 which the appointee was promoted, or who is dismissed for cause
3 other than misconduct or delinquency on the appointee's part from
4 the position to which the appointee was promoted, either during
5 the probationary period or at the conclusion thereof by reason of the
6 failure of the appointing authority to file a request for the
7 appointee's continuance in the position, ~~{shall}~~ **may** be ~~{restored}~~ :

8 *(a) Restored* to the position from which the appointee was
9 promoted ~~{}~~ ;

10 *(b) Placed in a position other than the position from which the*
11 *appointee was promoted; or*

12 *(c) Placed on an appropriate reemployment list.*

13 2. Nothing contained in this section shall be construed to
14 prevent any employee of the classified service from competing for
15 places upon lists of persons eligible for original appointments.

16 **Sec. 2.** NRS 284.305 is hereby amended to read as follows:

17 284.305 1. Except as otherwise provided in subsection 2,
18 positions in the classified service may be filled without competition
19 only as provided in NRS 284.155, **284.300**, 284.307, 284.309,
20 284.310, 284.315, 284.320, 284.325, 284.327, 284.330, 284.375 and
21 284.3775.

22 2. The Commission may adopt regulations which provide for
23 filling positions in the classified service without competition in
24 cases involving:

25 *(a) The appointment of a current employee with a disability to*
26 *a position at or below the grade of his or her position if the*
27 *employee:*

28 *(1) Has successfully completed the probationary period for*
29 *any class of position he or she has held during continuous*
30 *classified service; and*

31 *(2) Becomes unable to perform the essential functions of*
32 *his or her position with or without reasonable accommodation;*

33 *(b) The demotion of a current employee;*

34 ~~{(b)}~~ *(c) The reemployment of a current or former employee*
35 *who was or will be adversely affected by layoff, military service,*
36 *reclassification or a permanent partial disability arising out of and in*
37 *the course of the employment of the current or former employee; or*

38 ~~{(e)}~~ *(d) The reappointment of a current employee.*

39 **Sec. 3.** NRS 284.379 is hereby amended to read as follows:

40 284.379 In the employment of a person with a disability in the
41 state service, continued efforts must be made to retain the person by
42 making reasonable accommodations that enable the person to
43 perform the essential functions of ~~{the}~~ **his or her current** position
44 and to enjoy the benefits and privileges of the ~~{person's}~~ position.



1 An appointing authority shall consider separation or disability
2 retirement if ~~ann~~ :

3 *1. An employee can no longer perform the essential functions*
4 *of the position with or without reasonable accommodations ~~[-]~~ ; and*

5 *2. The employee cannot be appointed to a position at or below*
6 *the grade of the employee's current position.*

7 **Sec. 4.** NRS 284.385 is hereby amended to read as follows:

8 284.385 1. An appointing authority may:

9 (a) Dismiss or demote any permanent classified employee when
10 the appointing authority considers that the good of the public service
11 will be served thereby.

12 (b) Except as otherwise provided in NRS 284.148, suspend
13 without pay, for disciplinary purposes, a permanent employee for a
14 period not to exceed 30 days.

15 2. Before a permanent classified employee is dismissed,
16 involuntarily demoted or suspended, the appointing authority must
17 consult with the Attorney General or, if the employee is employed
18 by the Nevada System of Higher Education, the appointing
19 authority's general counsel, regarding the proposed discipline. After
20 such consultation, the appointing authority may take such lawful
21 action regarding the proposed discipline as it deems necessary under
22 the circumstances.

23 3. A dismissal, involuntary demotion or suspension does not
24 become effective until the employee is notified in writing of the
25 dismissal, involuntary demotion or suspension and the reasons
26 therefor. The ~~notice may be delivered personally to the employee or~~
27 ~~mailed to the employee at the employee's last known address by~~
28 ~~registered or certified mail, return receipt requested. If the notice is~~
29 ~~mailed, the effective date of the dismissal, involuntary demotion or~~
30 ~~suspension shall be deemed to be the date of delivery or if the letter~~
31 ~~is returned to the sender, 3 days after mailing.]~~ *Commission shall*
32 *adopt regulations setting forth the procedures for properly*
33 *notifying the employee of the dismissal, involuntary demotion or*
34 *suspension and the reasons therefor.*

35 4. No employee in the classified service may be dismissed for
36 religious or racial reasons.

37 **Sec. 5.** NRS 284.4062 is hereby amended to read as follows:

38 284.4062 1. Except as otherwise provided in ~~subsection 3.]~~
39 *subsections 3 and 4*, an employee who:

40 (a) Consumes or is under the influence of alcohol while on duty,
41 unless the alcohol is an integral part of a commonly recognized
42 medication which the employee consumes pursuant to the
43 manufacturer's instructions or in accordance with a lawfully issued
44 prescription;



1 (b) Possesses, consumes or is under the influence of a controlled
2 substance while on duty, at a work site or on state property, except
3 in accordance with a lawfully issued prescription; or

4 (c) Consumes or is under the influence of any other drug which
5 could interfere with the safe and efficient performance of the
6 employee's duties, unless the drug is an integral part of a commonly
7 recognized medication which the employee consumes pursuant to
8 the manufacturer's instructions or in accordance with a lawfully
9 issued prescription,

10 ➤ is subject to disciplinary action. An appointing authority may
11 summarily discharge an employee who, within a period of 5 years,
12 commits a second act which would subject the employee to
13 disciplinary action pursuant to this subsection.

14 2. ~~[A]~~ *Except as otherwise provided in subsection 3, a* state
15 agency shall refer an employee who:

16 (a) Tests positive for the first time in a screening test; and

17 (b) Has committed no other acts for which the employee is
18 subject to termination during the course of conduct giving rise to the
19 screening test,

20 ➤ to an employee assistance program. An employee who fails to
21 accept such a referral or fails to complete such a program
22 successfully is subject to further disciplinary action.

23 3. *The Commission may adopt regulations setting forth the*
24 *circumstances under which a person who holds a valid registry*
25 *identification card to engage in the medical use of marijuana*
26 *pursuant to chapter 453A of NRS is subject to disciplinary action*
27 *pursuant to subsection 1 or must be referred to an employee*
28 *assistance program pursuant to subsection 2.*

29 4. Subsection 1 does not apply to:

30 (a) An employee who consumes alcohol in the course of the
31 employment of the employee while hosting or attending a special
32 event.

33 (b) A peace officer who possesses a controlled substance or
34 consumes alcohol within the scope of the peace officer's duties.

35 **Sec. 6.** NRS 284.4063 is hereby amended to read as follows:

36 284.4063 1. Except as otherwise provided in *subsection 2*
37 *and* subsection 5 of NRS 284.4065, an employee who:

38 ~~[1]~~ (a) Fails to notify the employee's supervisor as soon as
39 possible after consuming any drug which could interfere with the
40 safe and efficient performance of the employee's duties;

41 ~~[2]~~ (b) Fails or refuses to submit to a screening test as
42 requested by a state agency pursuant to subsection 1 or 2 of NRS
43 284.4065; or

44 ~~[3]~~ (c) After taking a screening test which indicates the
45 presence of a controlled substance, fails to provide proof, within 72



1 hours after being requested by the employee's appointing authority,
2 that the employee had taken the controlled substance as directed
3 pursuant to a current and lawful prescription issued in the
4 employee's name,

5 ↪ is subject to disciplinary action.

6 *2. The Commission may adopt regulations setting forth the*
7 *circumstances under which a person who holds a valid registry*
8 *identification card to engage in the medical use of marijuana*
9 *pursuant to chapter 453A of NRS is subject to disciplinary action*
10 *pursuant to this section.*

11 **Sec. 7.** NRS 284.4064 is hereby amended to read as follows:

12 284.4064 1. If an employee informs the employee's
13 appointing authority that the employee has consumed any drug
14 which could interfere with the safe and efficient performance of the
15 employee's duties, the appointing authority may require the
16 employee to obtain clearance from the employee's physician before
17 the employee continues to work.

18 2. If an appointing authority reasonably believes, based upon
19 objective facts, that an employee's ability to perform the employee's
20 duties safely and efficiently:

21 (a) May be impaired by the consumption of alcohol or other
22 drugs, it may ask the employee whether the employee has consumed
23 any alcohol or other drugs and, if so:

24 (1) The amount and types of alcohol or other drugs
25 consumed and the time of consumption; ~~and~~

26 (2) If a controlled substance *other than marijuana* was
27 consumed, the name of the person who prescribed its use ~~and~~; *and*

28 (3) *If marijuana was consumed, to provide proof that the*
29 *employee holds a valid registry identification card to engage in the*
30 *medical use of marijuana pursuant to chapter 453A of NRS.*

31 (b) Is impaired by the consumption of alcohol or other drugs, it
32 shall prevent the employee from continuing work and transport the
33 employee or cause the employee to be transported safely away from
34 the employee's place of employment in accordance with regulations
35 adopted by the Commission.

36 **Sec. 8.** NRS 284.4065 is hereby amended to read as follows:

37 284.4065 1. Except as otherwise provided in subsection 2, an
38 appointing authority may request an employee to submit to a
39 screening test only if the appointing authority:

40 (a) Reasonably believes, based upon objective facts, that the
41 employee is under the influence of alcohol or drugs which are
42 impairing the employee's ability to perform the employee's duties
43 safely and efficiently;



1 (b) Informs the employee of the specific facts supporting its
2 belief pursuant to paragraph (a), and prepares a written record of
3 those facts; and

4 (c) Informs the employee in writing:

5 (1) Of whether the test will be for alcohol or drugs, or both;

6 (2) That the results of the test are not admissible in any
7 criminal proceeding against the employee; and

8 (3) That the employee may refuse the test, but that the
9 employee's refusal may result in the employee's dismissal or in
10 other disciplinary action being taken against the employee.

11 2. An appointing authority may request an employee to submit
12 to a screening test if the employee:

13 (a) Is a law enforcement officer and, during the performance of
14 the employee's duties, the employee discharges a firearm, other than
15 by accident; ~~for~~

16 (b) During the performance of the employee's duties, drives a
17 motor vehicle in such a manner as to cause bodily injury to the
18 employee or another person or substantial damage to property ~~;~~ ;
19 *or*

20 (c) *Has or is involved in a work-related accident or injury.*

21 ➤ For the purposes of this subsection, the Commission shall, by
22 regulation, define the ~~term~~ *terms* "substantial damage to
23 ~~property.~~" *property*" and "*work-related accident or injury.*"

24 3. An appointing authority may place an employee who
25 submits to a screening test on administrative leave with pay until the
26 appointing authority receives the results of the test.

27 4. An appointing authority shall:

28 (a) Within a reasonable time after an employee submits to a
29 screening test to detect the general presence of a controlled
30 substance or any other drug, allow the employee to obtain at the
31 employee's expense an independent test of the employee's urine or
32 blood from a laboratory of the employee's choice which is certified
33 by the United States Department of Health and Human Services.

34 (b) Within a reasonable time after an employee submits to a
35 screening test to detect the general presence of alcohol, allow the
36 employee to obtain at the employee's expense an independent test of
37 the employee's blood from a laboratory of the employee's choice.

38 (c) Provide the employee with the written results of the
39 employee's screening test within 3 working days after it receives
40 those results.

41 5. An employee is not subject to disciplinary action for testing
42 positive in a screening test or refusing to submit to a screening test if
43 the appointing authority fails to comply with the provisions of this
44 section.



1 6. An appointing authority shall not use a screening test to
2 harass an employee.

3 **Sec. 9.** NRS 284.4066 is hereby amended to read as follows:

4 284.4066 1. Each appointing authority shall, subject to the
5 approval of the Commission, determine whether each of its
6 positions of employment affects the public safety. The appointing
7 authority shall not hire an applicant for such a position unless the
8 applicant submits to a screening test to detect the general presence
9 of a controlled substance. Notice of the provisions of this section
10 must be given to each applicant for such a position at or before the
11 time of application.

12 2. An appointing authority ~~may~~ *shall* consider the results of a
13 screening test in determining whether to employ an applicant. If
14 those results indicate the presence of a controlled substance ~~or~~ *other*
15 *than marijuana*, the appointing authority shall not hire the applicant
16 unless the applicant provides, within 72 hours after being requested,
17 ~~by the appointing authority,~~ proof that the applicant had taken the
18 controlled substance as directed pursuant to a current and lawful
19 prescription issued in the applicant's name.

20 3. An appointing authority shall, at the request of an applicant,
21 provide the applicant with the results of the applicant's screening
22 test.

23 *4. If the results of a screening test indicate the presence of a*
24 *controlled substance, the appointing authority shall:*

25 *(a) Provide the Administrator with the results of the*
26 *applicant's screening test.*

27 *(b) If applicable, inform the Administrator whether the*
28 *applicant holds a valid registry identification card to engage in the*
29 *medical use of marijuana pursuant to chapter 453A of NRS.*

30 *5. The Commission may adopt regulations relating to an*
31 *applicant for a position which affects the public safety who tests*
32 *positive for marijuana and holds a valid registry identification*
33 *card to engage in the medical use of marijuana pursuant to*
34 *chapter 453A of NRS.*

35 **Sec. 10.** NRS 284.4068 is hereby amended to read as follows:

36 284.4068 Except as otherwise provided in NRS 239.0115 ~~or~~
37 *and 284.4066*, the results of a screening test taken pursuant to NRS
38 284.4061 to 284.407, inclusive, are confidential and:

39 1. Are not admissible in a criminal proceeding against the
40 person tested;

41 2. Must be securely maintained by the *Division, the* appointing
42 authority, ~~or~~ the designated representative of the appointing
43 authority *and any other person authorized to receive the results*
44 separately from other files concerning personnel; and

45 3. Must not be disclosed to any person, except:



- 1 (a) Upon the written consent of the person tested;
2 (b) As required by medical personnel for the diagnosis or
3 treatment of the person tested, if the person is physically unable to
4 give the person's consent to the disclosure;
5 (c) As required pursuant to a properly issued subpoena;
6 (d) When relevant in a formal dispute between the appointing
7 authority and the person tested; ~~for~~
8 (e) As required for the administration of a plan of benefits for
9 employees ~~for~~; *or*
10 *(f) As may be authorized pursuant to regulations adopted by*
11 *the Commission.*

12 **Sec. 11.** 1. This section becomes effective upon passage and
13 approval.

14 2. Sections 2, 3, 5, 6, 7, 9 and 10 of this act become effective
15 on July 1, 2015.

16 3. Sections 1, 4 and 8 of this act become effective:

17 (a) Upon passage and approval for the purpose of adopting any
18 regulations and performing any other preparatory administrative
19 tasks necessary to carry out the provisions of this act; and

20 (b) On January 1, 2016, for all other purposes.
