INTRODUCTION, FIRST READING AND REFERENCE

By Assemblymen Fiore, Seaman, Dickman, Shelton, Oscarson, Armstrong, Dooling, Ellison, Gardner, Hambrick, Hansen, Jones, Kirner, Moore, O'Neill, Titus, Trowbridge, Wheeler and Woodbury; Senators Gustavson and Goicoechea:

Assembly Bill No. 148—AN ACT relating to concealed firearms; authorizing a sheriff to provide certain information concerning the availability of certain courses relating to firearm safety; authorizing a person who holds a permit to carry a concealed firearm to do so on certain property of a public airport and on the property of the Nevada System of Higher Education, a private or public school or child care facility under certain circumstances; authorizing the Police Department for the System to provide certain information concerning the availability of certain courses relating to firearm safety; and providing other matters properly relating thereto.

Assemblywoman Fiore moved that the bill be referred to the Committee on Judiciary.

Assembly Bill No. 149—AN ACT relating to common-interest communities; revising provisions governing retaliatory action by certain persons in common-interest communities; and providing other matters properly relating thereto.

Assemblywoman Shelton moved that the bill be referred to the Committee on Judiciary.

By Assemblymen Stewart, Carrillo, Flores and Nelson:

Assembly Bill No. 150—AN ACT relating to education; revising the eligibility criteria for a student to receive a Governor Guinn Millennium Scholarship; and providing other matters properly relating thereto.

Assemblyman Stewart moved that the bill be referred to the Committee on Education.

Motion carried.

By Assemblymen Araujo, Benitez-Thompson, Bustamante Adams, Flores and Neal; Senator Denis:

Assembly Bill No. 151—AN ACT relating to the adoption of children; revising provisions concerning orders and decrees of adoption; and providing other matters properly relating thereto.

Assemblyman Araujo moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Assemblymen Araujo, Diaz, Thompson, Benitez-Thompson, Carrillo, Flores, Joiner, Moore and Neal; Senators Denis and Woodhouse:

Assembly Bill No. 152—AN ACT relating to care of children; requiring the State Board of Health to adopt regulations prescribing requirements for meals and snacks provided to children at child care facilities; setting forth certain requirements for child care facilities relating to breastfeeding, physical activity and viewing media; and providing other matters properly relating thereto.

Assemblyman Araujo moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.

By Assemblymen Araujo, Diaz, Hambrick, Benitez-Thompson, Flores, O'Neill and Thompson; Senator Denis:

Assembly Bill No. 153—AN ACT relating to juveniles; providing that a sexually exploited child is a child in need of supervision for the purposes of juvenile court proceedings; revising provisions governing the detention of sexually exploited children; revising provisions governing juvenile court proceedings involving sexually exploited children; and providing other matters properly relating thereto.

Assemblyman Araujo moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By the Committee on Commerce and Labor:

Assembly Bill No. 154—AN ACT relating to the Nevada Employment Security Council; altering certain duties assigned to the Council; and providing other matters properly relating thereto.

Assemblyman Kirner moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By Assemblymen Thompson, Araujo, Hickey, Joiner, Silberkraus, Spiegel, Sprinkle and Wheeler; Senators Kihuen, Atkinson, Ford and Manendo:

Assembly Bill No. 155—AN ACT relating to special license plates; revising the provisions allowing issuance of a special license plate to certain applicants who are current or retired professional firefighters to include certain retired professional firefighters from other jurisdictions; and providing other matters properly relating thereto.

Assemblyman Thompson moved that the bill be referred to the Committee on Transportation.

Motion carried.

By Assemblyman Thompson:

Assembly Bill No. 156—AN ACT relating to public welfare; revising the manner in which the Director of the Department of Health and Human

Services determines whether a community is at-risk for purposes of provisions relating to family resource centers; requiring a family resource center to obtain input from certain elected officials when creating an action plan; requiring a case manager at a family resource center to collect and analyze data to monitor the performance of certain responsibilities by members of families receiving services from the family resource center; expanding the information included in the annual report prepared by family resource centers; and providing other matters properly relating thereto.

Assemblyman Thompson moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.

By Assemblymen Oscarson, Ellison, Armstrong, Titus and Wheeler; Senator Goicoechea:

Assembly Bill No. 157—AN ACT relating to service animals; making certain provisions relating to service animals and service animals in training applicable only when the animal is a dog or a miniature horse; allowing an employer to determine whether it is reasonable to allow an employee to keep a service animal that is a miniature horse at the place of employment; allowing a place of public accommodation or common carrier to determine whether it is reasonable to admit a service animal or service animal in training that is a miniature horse; and providing other matters properly relating thereto.

Assemblyman Oscarson moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.

By the Committee on Health and Human Services:

Assembly Bill No. 158—AN ACT relating to public health; authorizing certain entities to obtain auto-injectable epinephrine for use when a person experiences anaphylaxis; specifying the qualifications of persons authorized to provide or administer auto-injectable epinephrine; requiring certain entities that maintain auto-injectable epinephrine to report the circumstances surrounding each administration of auto-injectable epinephrine; providing immunity to certain persons for acts or omissions relating to the acquisition, possession or administration of auto-injectable epinephrine in certain circumstances; providing a penalty; and providing other matters properly relating thereto.

Assemblyman Oscarson moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.

By the Committee on Government Affairs:

Assembly Bill No. 159—AN ACT relating to public works; revising provisions concerning contracts with a public body for a public work and contracts by the awardee of certain grants, tax abatements, tax credits or tax

exemptions from a public body; and providing other matters properly relating thereto.

Assemblyman Ellison moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

By Assemblymen Ellison and Wheeler:

Assembly Bill No. 160—AN ACT relating to courts; revising provisions concerning the locations in which justice courts and municipal courts must be held; and providing other matters properly relating thereto.

Assemblyman Ellison moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Assemblywoman Bustamante Adams:

Assembly Bill No. 161—AN ACT relating to taxation; authorizing certain qualified businesses in this State that own, operate, manufacture, service, maintain, test, repair, overhaul or assemble an aircraft or any component of an aircraft to apply to the Office of Economic Development for a partial abatement from certain property or sales and use taxes; revising the provisions governing the administration of the sales and use taxes to change the manner in which the taxes are required to be paid on tangible personal property purchased in the performance of certain contracts; and providing other matters properly relating thereto.

Assemblywoman Bustamante Adams moved that the bill be referred to the Committee on Taxation.

Motion carried.

By Assemblymen Munford, Wheeler, Ohrenschall and Shelton:

Assembly Bill No. 162—AN ACT relating to peace officers; requiring certain peace officers to wear a portable event recording device while on duty; requiring certain law enforcement agencies to adopt policies and procedures governing the use of portable event recording devices; exempting the use of portable event recording devices from the provisions governing the interception of certain communications; exempting the use of portable event recording devices upon certain property; and providing other matters properly relating thereto.

Assemblyman Munford moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

By Assemblymen Hansen, Oscarson, Wheeler, Dickman, Ellison and Titus; Senators Gustavson and Settlemeyer:

Assembly Bill No. 163—AN ACT relating to fire protection; providing for the creation of rangeland fire protection associations; authorizing a board of county commissioners to approve a petition to create an association;

providing for the evaluation of an association by the board and the State Forester Firewarden; requiring the State Forester Firewarden to adopt regulations relating to the formation, operation and training of the members of an association; and providing other matters properly relating thereto.

Assemblyman Paul Anderson moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

By Assemblymen Ohrenschall, Wheeler, Fiore, Araujo, Armstrong, Diaz, Gardner, Jones, Moore, Seaman, Shelton, Stewart and Swank; Senators Woodhouse, Segerblom and Manendo:

Assembly Bill No. 164—AN ACT relating to public health; authorizing a manufacturer to provide or make available an investigational drug, biological product or device to certain patients under certain circumstances; prohibiting an officer, employee or agent of this State from preventing or attempting to prevent a patient from accessing such an investigational drug, biological product or device under certain circumstances; authorizing a physician to prescribe or recommend an investigational drug, biological product or device to certain persons under certain circumstances; providing a penalty; and providing other matters properly relating thereto.

Assemblyman Ohrenschall moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.

By the Committee on Education:

Assembly Bill No. 165—AN ACT relating to education; establishing a credit against the modified business tax for taxpayers who donate money to a scholarship organization; setting forth certain requirements for a scholarship organization and for schools that receive grants from a scholarship organization; requiring a scholarship organization to submit an annual report to the Department of Education; and providing other matters properly relating thereto.

Assemblywoman Woodbury moved that the bill be referred to the Committee on Education.
