Assembly Bill No. 181—AN ACT relating to motor carriers, requiring certain fully regulated carriers to pay an annual fee to the Nevada Transportation Authority; revising filing fees imposed for certain applications required to be filed with the Authority by certain motor carriers; requiring an inspection of certain charter buses and the payment to the Authority of an inspection fee; revising fees for certain limousines; providing a penalty; and providing other matters properly relating thereto.

Assembly Bill No. 182—AN ACT relating to local governments; prohibiting a local government employer from entering into an agreement to pay dues to an employee organization through deductions from compensation; prohibiting such an employer from providing paid leave or paying compensation or benefits for time spent by an employee in providing services to an employee organization; prohibiting the inclusion of certain employees in a bargaining unit; revising provisions relating to a reduction in force; providing that a collective bargaining agreement between a local government employer and a recognized employee organization expires for certain purposes at the end of the term stated in the agreement; requiring public notice of certain offers made in collective bargaining; eliminating final and binding fact-finding except upon the election of the governing body; removing a portion of the budgeted ending fund balance of certain governmental funds from the scope of collective bargaining and from consideration by a fact finder; eliminating statutory impasse arbitration for firefighters, police officers, teachers and educational support personnel; and providing other matters properly relating thereto.

Assemblyman Kirner moved that the bill be referred to the Committee on Commerce and Labor.

Assembly Bill No. 183—AN ACT relating to real property; requiring the grantee to whom real property is conveyed under an agreement for a deed in lieu of a foreclosure sale to record the conveyance within 30 days after the date of the conveyance; providing that a grantee who fails to record such a conveyance is liable for certain damages and attorney's fees and costs; and providing other matters properly relating thereto.

Assemblyman Elliot Anderson moved that the bill be referred to the Committee on Judiciary.

GENERAL FILE AND THIRD READING

Assembly Bill No. 15.

Bill read third time.

Remarks by Assemblymen Spiegel, Joiner, and Ellison.

## ASSEMBLYWOMAN SPIEGEL:

Assembly Bill 15 creates the Account for the Protection and Rehabilitation of the Stewart Indian School in the State General Fund. The Account is to be administered by the Director of the State Department of Conservation and Natural Resources for the purposes of repairing and maintaining the historic state buildings and grounds of the Stewart Indian School. The bill authorizes the Administrator of the Division of State Lands to make a direct sale of two parcels of state land for the purpose of funding the Account. The bill is effective upon passage and approval.

## ASSEMBLYWOMAN JOINER:

I rise in support of Assembly Bill 15, because I believe that the Stewart Indian School is an extremely important cultural and heritage site in Nevada. However, I would like to express my continued concern, which I raised in committee, that the way this project is being funded is incredibly short-sighted. This bill, in section 5, would sell off a piece of state land and provide a pot of money for a very limited amount of time for the maintenance and repair of this school. It is my hope that as a body, we would fund important projects such as this under our normal means such as the budget and our CIP [Capital Improvement Program] process. I would hope that selling off our public land to private developers is not a precedent that we fall into time and again every time we need a pot of money. That being said, I do plan to vote for this bill because of the extreme importance of this particular project.

## ASSEMBLYMAN ELLISON:

I stand in support of Assembly Bill 15. The presentation of the Director regarding the Stewart Indian School expressed their feeling that disposal of the two parcels was the best use for maintaining that facility. That was brought through their committees so I stand in support. Thank you.
