INTRODUCTION, FIRST READING AND REFERENCE

By Assemblymen Wheeler, O'Neill, Dickman and Seaman:

Assembly Bill No. 189—AN ACT relating to special license plates; authorizing the Commission on Special License Plates to investigate and request an audit of certain charitable organizations which receive additional fees collected by the Department of Motor Vehicles for special license plates; revising provisions regarding the application submitted to the Department by certain persons seeking a special license plate intended to generate financial support for an organization; revising provisions requiring certain charitable organizations which receive additional fees paid for special license plates to provide certain documents and records annually to the Commission; and providing other matters properly relating thereto.

Assemblyman Wheeler moved that the bill be referred to the Committee on Transportation.

By Assemblymen Kirner, Wheeler, Hickey, Jones, Dickman, Ellison, Hansen and Oscarson:

Assembly Bill No. 190—AN ACT relating to public employees' retirement; providing for the establishment of a hybrid retirement program for certain public employees; requiring the program to include a defined benefit plan and a defined contribution plan; setting forth the required provisions of each plan; requiring certain public employers under certain circumstances to make additional contributions to the Public Employees' Retirement System to reduce the unfunded liability of the System; and providing other matters properly relating thereto.

Assemblyman Kirner moved that the bill be referred to the Committee on Commerce and Labor.

By Assemblymen Paul Anderson and Kirkpatrick; Senators Hammond and Roberson:

Assembly Bill No. 191—AN ACT relating to taxation; revising provisions relating to the imposition by certain counties of additional taxes on fuels for motor vehicles; providing that the boards of county commissioners of certain larger counties may continue the imposition of certain additional taxes on fuels for motor vehicles if a ballot question authorizing such additional taxes is approved by a majority of the voters in the county; providing for the imposition by the boards of county commissioners of certain counties of additional taxes on fuels for motor vehicles if a ballot question authorizing such additional taxes is approved by a majority of the voters in the county; requiring the approval by voters of additional ballot measures to continue the imposition of the additional taxes; providing that money collected from certain of the additional taxes must be deposited with the State Treasurer to the credit of the State Highway Fund, accounted for separately in the State Highway Fund and used by the Department of Transportation only to finance projects for the construction, maintenance and repair of state highways in the county in which the tax is collected; repealing certain provisions relating to a ballot question providing for the imposition by the State of certain additional taxes on fuels for motor vehicles; and providing other matters properly relating thereto.

Assemblyman Paul Anderson moved that the bill be referred to the Committee on Taxation.

GENERAL FILE AND THIRD READING

Assembly Bill No. 75.

Remarks by Assemblyman Silberkraus.

ASSEMBLYMAN SILBERKRAUS:

Assembly Bill 75 changes from \$2,500 to \$15,000 the threshold increase in annual gross operating revenue resulting from a proposed rate change that would require a utility to file a rate change application with the Public Utilities Commission of Nevada, rather than submitting a letter of advice that the utility plans to change its rates. Additionally, the bill will require the letter of advice to include a certification or affidavit from the utility that the proposed change meets the threshold requirement. The bill will be effective July 1 and passed out of committee unanimously.
