#### INTRODUCTION, FIRST READING AND REFERENCE

By the Committee on Judiciary:

Assembly Bill No. 193—AN ACT relating to criminal procedure; revising provisions governing the waiver of a preliminary examination; revising provisions regarding the introduction of evidence at a preliminary examination or grand jury proceeding; revising the provisions governing the use of a witness's affidavit at a preliminary examination or grand jury proceeding; revising provisions relating to the use of audiovisual technology to present live witness testimony at a preliminary examination or grand jury proceeding; revising provisions relating to a finding of probable cause at a preliminary hearing or grand jury proceeding; eliminating the ability for a defendant to submit certain evidentiary statements to a grand jury; making various changes concerning notice given to a person whose indictment is being considered by a grand jury; revising the provisions pertaining to the filing of trial-related motions in criminal proceedings; and providing other matters properly relating thereto.

Assembly Bill No. 29.

Bill read third time.

Remarks by Assemblyman Sprinkle.

#### ASSEMBLYMAN SPRINKLE:

Assembly Bill 29 provides that a for-profit partnership, firm, corporation, or association must obtain a certificate from the Aging and Disability Services Division, Department of Health and Human Services, in order to provide jobs and day training services to persons with intellectual disabilities and related conditions. The bill requires existing provisions concerning the use of restraints and interventions associated with the care and treatment of persons with intellectual

disabilities and related conditions to be applicable to any facility operated or certified by the Division. Such facilities are prohibited from depriving any person their legal rights to due process of law. Also, A.B. 29 clarifies that the Administrator of the Division is required to adopt regulations related to administrative procedures of the Division.
