Assembly Joint Resolution No. 7—Submitting an application to Congress to call a convention of the states limited to proposing amendments to the Constitution of the United States to impose fiscal restraints on the Federal Government, limit certain federal powers and limit the terms of officers of the Federal Government and members of Congress.

#### INTRODUCTION, FIRST READING AND REFERENCE

By Assemblymen Dickman, Fiore, Jones, Hansen, Moore, Dooling, Ellison, Gardner, Hambrick, Hickey, Nelson, O'Neill, Oscarson, Seaman, Shelton, Titus, Trowbridge and Wheeler:

Assembly Bill No. 266—AN ACT relating to elections; requiring, with limited exceptions, proof of identity for voting in person; requiring the Department of Motor Vehicles, under certain circumstances, to issue voter identification cards at no cost; and providing other matters properly relating thereto.

Assemblywoman Dickman moved that the bill be referred to the Committee on Legislative Operations and Elections.

Motion carried.

By Assemblymen Hambrick, Hickey, Paul Anderson, Ohrenschall, O'Neill, Seaman and Titus; Senators Hammond, Parks, Ford, Manendo and Settlemeyer:

Assembly Bill No. 267—AN ACT relating to criminal procedure; setting forth certain mitigating factors a court must consider when determining an appropriate sentence for a person convicted as an adult for an offense committed when the person was less than 18 years of age; eliminating the imposition of a sentence of life without the possibility of parole upon a person convicted of a crime committed when the person was less than 18 years of age; providing that a prisoner who was sentenced as an adult for an offense that was committed when he or she was less than 18 years of age is eligible for parole after the prisoner has served 15 years of his or her sentence; setting forth certain factors the State Board of Parole Commissioners must consider when determining whether to grant parole to a person convicted as an adult for an offense committed when the person was less than 18 years of age; and providing other matters properly relating thereto.

Assemblyman Paul Anderson moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By the Committee on Health and Human Services:

Assembly Bill No. 268—AN ACT relating to foster care; authorizing a licensing authority to conduct a background check on a person who routinely supervises a child in a foster home; requiring an applicant or person licensed to conduct a foster home to prevent such a person from being present in the foster home if the background check reports certain prior criminal convictions of the person; allowing a person who routinely supervises a child

in a foster home for whom an investigation is conducted an opportunity to correct such information; requiring each applicant for a license to conduct a foster home and each person licensed to conduct a foster home to maintain records of certain information concerning certain persons who routinely supervise a child in a foster home; and providing other matters properly relating thereto.

Assemblyman Oscarson moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.

By Assemblymen Jones, Moore, Seaman, Gardner, Fiore, Dickman, Dooling, Ellison, Shelton, Trowbridge and Wheeler; Senator Gustavson:

Assembly Bill No. 269—AN ACT relating to professional licensing; providing that a natural person has a right to engage in a lawful occupation free from a substantial burden imposed by an occupational regulation; providing that a natural person may assert the right to engage in a lawful occupation as a defense in any judicial or administrative proceeding brought against the person; authorizing a natural person to bring an action against a governmental entity or regulatory body seeking to enforce an occupational regulation; and providing other matters properly relating thereto.

Assemblyman Jones moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By the Committee on Commerce and Labor:

Assembly Bill No. 270—AN ACT relating to manufactured homes; revising the manner in which the fair market value of certain manufactured homes is determined; revising the definition of “dealer” for certain purposes to exclude a manufactured home park or an owner or agent of a manufactured home park; and providing other matters properly relating thereto.

Assemblyman Kirner moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By the Committee on Commerce and Labor:

Assembly Bill No. 271—AN ACT relating to equine dentistry; providing for the licensure of equine dental providers by the Nevada State Board of Veterinary Medical Examiners; creating the Equine Dental Provider Advisory Committee; and providing other matters properly relating thereto.

Assemblyman Kirner moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By Assemblyman Hickey:

Assembly Bill No. 272—AN ACT relating to residential facilities for groups; exempting certain businesses that provide referrals to residential facilities for groups from certain licensing requirements; and providing other matters properly relating thereto.

Assemblyman Hickey moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.

By Assemblyman Hickey:

Assembly Bill No. 273—AN ACT relating to the Legislature; requiring a cooling-off period before a former State Legislator may act as a paid lobbyist before the Legislature; providing an exception; providing a penalty; and providing other matters properly relating thereto.

Assemblyman Hickey moved that the bill be referred to the Committee on Legislative Operations and Elections.

Motion carried.

By Assemblywoman Woodbury and Senator Hardy:

Assembly Bill No. 274—AN ACT relating to cities; requiring a board of county commissioners and a county clerk to provide certain information to a committee of qualified electors that petitions a county to organize an incorporated city; and providing other matters properly relating thereto.

Assemblywoman Woodbury moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

By Assemblyman Nelson:

Assembly Bill No. 275—AN ACT relating to trust companies; authorizing a fiduciary or excluded fiduciary to delegate a duty of the fiduciary or excluded fiduciary to an agent; limiting the liability of an excluded fiduciary; revising the definition of “fiduciary” to exclude certain servicers or administrators of individual retirement accounts; and providing other matters properly relating thereto.

Assemblyman Nelson moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By Assemblymen Hambrick, Paul Anderson, Flores, Carrillo, Silberkraus, Araujo, Seaman, Spiegel, Stewart and Thompson; Senator Harris:

Assembly Bill No. 276—AN ACT relating to human trafficking; requiring certain law enforcement officers to take certain actions upon an initial encounter with a possible victim of human trafficking; requiring the Department of Health and Human Services to develop a statewide plan for delivery of services to victims of human trafficking; requiring the Department of Education and the State Board of Education to develop and

distribute certain informational materials relating to the human trafficking of children; requiring certain businesses or other establishments to post an informational sign relating to the National Human Trafficking Resource Center hotline; and providing other matters properly relating thereto.

Assemblyman Hansen moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Assemblymen Nelson and Ellison; Senator Hardy:

Assembly Bill No. 277—AN ACT relating to religious freedom; enacting the Nevada Protection of Religious Freedom Act; prohibiting state action from substantially burdening a person's exercise of religion under certain circumstances; requiring strict scrutiny to be applied in all cases where state action substantially burdens a person's exercise of religion; providing a claim or defense in judicial and administrative proceedings to protect a person's exercise of religion; providing certain exceptions; and providing other matters properly relating thereto.

Assemblyman Nelson moved that the bill be referred to the Committee on Judiciary.

#### GENERAL FILE AND THIRD READING

Senate Bill No. 115.

Bill read third time.

Remarks by Assemblymen Stewart, Kirkpatrick, and Elliot Anderson:

ASSEMBLYMAN STEWART:

Senate Bill 115 allows the outlying areas in Clark County to elect their own advisory town boards. If no one runs for the office, then the County Commission can still make the appointment. I recommend this bill be passed.

ASSEMBLYWOMAN KIRKPATRICK:

I rise in support of Senate Bill 115. However, I thought a better amendment would have been to make it take the advisory piece out; just make it a regular board so that they actually have to file like everybody else. But I supported this in the past, and I will support it again today.

ASSEMBLYMAN ELLIOT ANDERSON:

I just want to ask my colleague from the double-deuce a quick question to clarify the record on S.B. 115. He said that it applied to Clark County. Did he mean to say this it was just the rural town advisory boards, so we can keep the record clear?

ASSEMBLYMAN STEWART:

In Clark County, those unincorporated towns 25 miles or more from Las Vegas. It applies only to the counties of 700,000 or more, which would be Clark County.
