Assembly Bill No. 278—AN ACT relating to education; requiring the Department of Education to develop certain policies, procedures and guidance related to class-size reduction; and providing other matters properly relating thereto.

Assembly Bill No. 41.

Bill read third time.

Remarks by Assemblyman Moore.

#### ASSEMBLYMAN MOORE:

Assembly Bill 41 provides that any money remaining in the Fund for Hospital Care to Indigent Persons at the end of each fiscal year does not revert to the State General Fund and must be carried over to the next fiscal year. The bill removes certain limitations on agreements entered into by the Board of Trustees of the Fund for Hospital Care to Indigent Persons. The Supplemental Account for Medical Assistance to Indigent Persons is replaced with the Fund for Hospital Care to Indigent Persons, allowing each board of county commissioners to remit the amount previously reverted to the Supplemental Account directly to the Fund. Assembly Bill 41 also repeals provisions authorizing the Board to require certain hospitals to pay an assessment thereby preventing a reduction in federal participation for Nevada Medicaid. Lastly, the bill repeals the inactive Fund for the Institutional Care of the Medically Indigent.

WHEREAS, Women of Diversity Productions, Inc. gives visibility to the women of Nevada and is creating a woman-appreciated future by continually creating and producing projects and events at the NWVC and through two exhibits on display at the Nevada State Library and Archives and the atrium of the Nevada legislative building; now, therefore, be it

PROCLAIMED, That the Women of Diversity Productions, Inc. is hereby recognized and commended for its dedication and efforts to present and preserve the achievements of the many women who have helped shape the history of Nevada, including the women who are continuing to affect that legacy today.
