Remarks by Assemblyman Paul Anderson:

ASSEMBLYMAN PAUL ANDERSON:

Assembly Bill 265 makes a supplemental appropriation to the Supreme Court. When the voters created the Appellate Court in the last election, there was an appointment process. Through that process, they have chosen judges who were already judges, they are having to backfill those positions. It has taken a little bit longer to go through that process. This is a \$5,000 allocation to help them complete that process.

REMARKS FROM THE FLOOR

Assemblyman Kirner requested that the following proclamation be entered in the Journal.

**PROCLAMATION**

WHEREAS, Lake Tahoe sits on the border between Nevada and California and is the largest alpine lake in the Northern Hemisphere and the second deepest lake in the United States; and

WHEREAS, In the late 1960s it was recognized that Lake Tahoe was a national treasure at risk of degradation due to significant development and population growth; and

WHEREAS, The respective governors of Nevada and California recognized the need to join together to protect that internationally recognized natural resource for the benefit of both states and the world; and

WHEREAS, Former Nevada Governor Paul Laxalt and Former California Governor Ronald Reagan met at Lake Tahoe and decided that the deterioration of the quality of Lake Tahoe was not a legacy they wanted to leave behind and they would cooperate to seek a resolution; and

WHEREAS, After much debate and a bi-state study, California generated the Z'berg Bill, in support of a bi-state compact in 1967; and

WHEREAS, Nevada's Former Senator Coe Swobe was charged with negotiating the inclusion of Nevada's proposed amendments and other views into the Z'berg Bill; and

WHEREAS, After months of such negotiation, Nevada Governor Laxalt convened a special session of the Nevada Legislature in February 1968; and

WHEREAS, Passage of Senate Bill 9, the "Swobe Bill," on February 23, 1968, authorized Nevada's participation in a Nevada-California Bi-State Compact; and

WHEREAS, California adopted an identical companion bill in July 1968, and the U.S. Congress ratified resulting federal compact legislation that was signed by Former U.S. President Richard Nixon on December 18, 1969; and

WHEREAS, The first meeting of the Tahoe Regional Planning Agency (TRPA) governing board, formed as a result of the Tahoe Regional Planning Agency Bi-State Compact, was held in Carson City on March 19, 1970; and

WHEREAS, The work of the TRPA has contributed significantly to the protection of the environmental quality and beauty of Lake Tahoe to the betterment of the citizens of Nevada, California, and the world; and

WHEREAS, The legendary clarity of Lake Tahoe has stabilized over the last decade; and

WHEREAS, The two states have reaffirmed their cooperative partnership, and their commitment to Lake Tahoe remains strong; now, therefore, be it

PROCLAIMED, That the month of March 2015 is designated as the month for recognition and celebration of the 45th Anniversary of the Bi-State Compact to preserve Lake Tahoe.
