Assembly Bill No. 424—AN ACT relating to public services for children; creating the Account for the Statewide Alert System for the Safe Return of Abducted Children in the State General Fund; authorizing the Committee for the Statewide Alert System to expend the money in the Account for certain

purposes; authorizing the Committee to apply for gifts, grants and donations for certain purposes; and providing other matters properly relating thereto.

Assemblyman Paul Anderson moved that the bill be referred to the Committee on Health and Human Services.

Assembly Bill No. 425—AN ACT relating to emergency medical services; revising the composition of the Committee on Emergency Medical Services; making provisions governing providers of health care applicable to persons who are licensed as attendants or certified as emergency medical technicians, advanced emergency medical technicians or paramedics; providing a penalty; and providing other matters properly relating thereto.

Remarks by Assemblywoman Seaman:

ASSEMBLYWOMAN SEAMAN:

Assembly Bill 167 authorizes a person who is in lawful possession of a firearm or ammunition to store such items on the premises of a family foster home in a locked secure storage container. This bill also authorizes a provider of family foster care or other person who

resides in a family foster home to carry a firearm on his or her person while off of the premises of a family foster home, but in the presence of a foster child, in a manner that ensures that the firearm is inaccessible to the foster child if the provider or other person is a law enforcement officer or has a permit to carry a concealed firearm.

This bill is effective upon passage and approval.

Assembly Bill 198 requires the Legislative Committee on Public Lands to conduct a study of water conservation and alternative sources of water for Nevada communities. The measure sets out the scope of the study. In addition to its other duties, the Committee must submit its findings and recommendations to the next session of the Legislature.

This bill is effective on October 1, 2015.

Among other things, you might be surprised to learn that Nevada was years ahead of *Brown vs. Board of Education* in ending school segregation. In 1871, attorney T.W.W. Davies II—who was later elected to represent Ormsby County (Carson City) in the Assembly—successfully argued before the Nevada Supreme Court that it was unconstitutional to exclude children from attending public school due to race or color.
