WHEREAS, A single individual's donation of the heart, lungs, liver, kidneys, pancreas and small intestine can save up to eight lives, and the donation of tissue can save or heal the lives of up to 50 others; and

WHEREAS, Donor Network West has served as the federally designated organ procurement organization in northern Nevada since 1988; and

WHEREAS, Donor Network West works in close partnership with families, doctors, nurses, coroners, and northern Nevada hospitals to connect donors with recipients; and

WHEREAS, Donor Network West is dedicated to educating residents in northern Nevada about their ability to save others by registering as organ and tissue donors through the Nevada Donor Registry online or at Nevada's Department of Motor Vehicles; and

WHEREAS, Donor Network West provides support to all donor families during and after the donation process and honors donors annually at a Donor Family Gathering in Reno; and

WHEREAS, Every organ or tissue donation is a generous, powerful gift that can save or improve the life of someone in need; now, therefore, be it

PROCLAIMED, That April 23, 2015, is designated as a day in honor of Donor Network West and organ and tissue donors in Nevada.
