INTRODUCTION, FIRST READING AND REFERENCE

By Senators Settlemeyer, Gustavson and Goicoechea:

Senate Bill No. 176—AN ACT relating to weapons; revising provisions governing certain dangerous or deadly weapons; revising provisions concerning certain concealed weapons; reserving for the Legislature the rights and powers to regulate certain knives; repealing certain provisions governing the manufacture and sale of switchblade knives; and providing other matters properly relating thereto.

Senator Settlemeyer moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By the Committee on Health and Human Services:

Senate Bill No. 177—AN ACT relating to public health; authorizing certain persons to designate a caregiver for a person in certain circumstances; requiring a hospital to provide an opportunity for a patient who is admitted as an inpatient or certain other persons to designate a caregiver for the patient; requiring a hospital to attempt to provide certain notification, information and training to a caregiver before taking certain actions concerning a patient; and providing other matters properly relating thereto.

Senator Hardy moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.

By Senator Hardy:

Senate Bill No. 178—AN ACT relating to education; requiring all public and private schools to provide instruction in physical education for certain grades; requiring certain pupils enrolled in a public or private school to take physical education in certain grade levels; prescribing the minimum number of credits required of pupils enrolled in high school in physical education; requiring the Council to Establish Academic Standards for Public Schools to establish standards of content and performance for physical education; requiring certain school districts to collect data concerning the height and weight of pupils; and providing other matters properly relating thereto.

Senator Hardy moved that the bill be referred to the Committee on Education.
