Senate Bill No. 262—AN ACT relating to guardians; adding provisions governing the appointment of certain preferred persons as guardians for adult wards; providing an exception to the residency requirements for certain guardians under certain circumstances; revising requirements governing eligibility to utilize a public guardian; revising provisions concerning

attorneys retained by a public guardian; revising provisions concerning reimbursement by a public guardian to the county for expenses relating to a ward; and providing other matters properly relating thereto.

Senate Bill No. 272—AN ACT relating to religious freedom; enacting the Nevada Protection of Religious Freedom Act; prohibiting state action from substantially burdening a person's exercise of religion under certain circumstances; requiring strict scrutiny to be applied in all cases where state action substantially burdens a person's exercise of religion; providing a claim or defense in judicial and administrative proceedings to protect a person's exercise of religion; providing certain exceptions; and providing other matters properly relating thereto.

Senator Hardy moved that the bill be referred to the Committee on Judiciary.

Senate Bill No. 273—AN ACT relating to health care records; prohibiting a custodian of the health care records from preventing the physical inspection of any health care records or providing copies thereof under certain circumstances; requiring a custodian of health care records to deliver the health care records or copies thereof under certain circumstances; providing a penalty; and providing other matters properly relating thereto.

Senator Hardy moved that the bill be referred to the Committee on Commerce, Labor and Energy.

By Senator Settelmeyer:

Senate Bill No. 274—AN ACT relating to federal constitutional conventions; enacting provisions governing the State's delegates to any federal constitutional conventions called pursuant to Article V of the United States Constitution; providing for the appointment, qualifications, duties, terms, recall and replacement of the delegates; prescribing oaths, rules, instructions and limitations for the delegates; prohibiting the delegates from acting or voting outside the scope of the rules, instructions and limitations; providing penalties; and providing other matters properly relating thereto.

Senator Settelmeyer moved that the bill be referred to the Committee on Legislative Operations and Elections.

By Senator Segerblom:

Senate Bill No. 275—AN ACT relating to public safety; creating the Account for the Treatment of Substance Abusers; providing that money in the Account must be distributed for programs relating to the treatment of certain offenders who are abusers of alcohol or drugs; requiring the appointment of a Deputy Director for Substance Abuser Programs within the Department of Corrections; increasing the taxes imposed on intoxicating liquor, cigarettes and gaming; requiring the Division of Public and Behavioral Health of the Department of Health and Human Services to establish a pilot program for the treatment of certain heroin-dependent persons; making appropriations; and providing other matters properly relating thereto.

Senator Ford moved that the bill be referred to the Committee on Revenue and Economic Development.

By Senators Segerblom and Farley:

Senate Bill No. 276—AN ACT relating to medical marijuana; revising provisions governing the registration of certain medical marijuana establishments; and providing other matters properly relating thereto.

Senator Ford moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.

By Senator Segerblom:

Senate Bill No. 277—AN ACT relating to environmental protection; enacting the Nevada Environmental Policy Act; creating the Council on Environmental Quality within the Office of the Governor; requiring the Council to adopt certain regulations; requiring state and local agencies to prepare environmental reports that analyze the environmental impact of agency activity and certain private activity; authorizing an agency to charge a fee to prepare an environmental impact statement for certain private projects that require the authorization or financing of the agency; authorizing the Governor to hire staff for the Council; and providing other matters properly relating thereto.

Senator Ford moved that the bill be referred to the Committee on Natural Resources.

By Senator Settelmeyer:

Senate Bill No. 278—AN ACT relating to off-highway vehicles; prohibiting the Department of Motor Vehicles from requiring a notarized signature from an owner of an off-highway vehicle on an application for the registration of that off-highway vehicle; and providing other matters properly relating thereto.

Senator Settelmeyer moved that the bill be referred to the Committee on Transportation.

Motion carried.

By Senators Segerblom, Atkinson, Kihuen, Ford, Parks, Smith, Woodhouse; Assemblymen Carrillo and Swank:

Senate Bill No. 279—AN ACT relating to offenders; requiring the Director of the Department of Corrections to verify the name and age of an offender who is to be released by obtaining certain documents before providing a photo identification card to the offender; requiring a sheriff, chief of police or town marshal, upon request, to provide a photo identification card to a prisoner who is to be released from a jail or detention facility; establishing an Ombudsman for Offenders within the Legislative Counsel Bureau to receive, process and investigate complaints by offenders and certain other persons; prescribing the duties and powers of the Ombudsman; requiring the Department of Corrections and the Division of Parole and Probation of the Department of Public Safety to post certain information pertaining to the Ombudsman in certain locations; revising the documents which may be furnished to the Department of Motor Vehicles as proof of full legal name and age to apply for a driver's license or identification card; providing for the waiver of certain fees relating to driver's licenses and identification cards for certain persons who are released from a jail or detention facility; and providing other matters properly relating thereto.

Senator Ford moved that the bill be referred to the Committee on Judiciary.

By Senator Hammond:

Senate Bill No. 280—AN ACT relating to unmanned aerial vehicles; authorizing the seizure and storage of certain unmanned aerial vehicles; providing for the licensing and regulation of unmanned aerial vehicle storage facilities; providing for the retrieval of evidence from unmanned aerial vehicles that have been used in criminal activities; providing a penalty; and providing other matters properly relating thereto.

Senator Hammond moved that the bill be referred to the Committee on Transportation.

Senate Bill No. 281—AN ACT relating to vehicles; providing that certain vehicles which are used as a source of parts are not to be regulated as solid waste; and providing other matters properly relating thereto.

By Senators Spearman, Ford, Parks, Denis, Kihuen, Manendo, Segerblom and Woodhouse:

Senate Bill No. 282—AN ACT relating to energy; revising provisions relating to the payment of incentives to participants in the Solar Energy Systems Incentive Program, the Wind Energy Systems Demonstration Program and the Waterpower Energy Systems Demonstration Program; providing for the implementation by certain electric utilities of energy efficiency resource plans; authorizing such electric utilities to recover certain costs and performance-based incentives as the result of implementing a plan; and providing other matters properly relating thereto.

Senate Bill No. 285—AN ACT relating to local law enforcement agencies; revising provisions relating to the powers and duties of constables and deputy constables; exempting from certain provisions the sale of liquor by a sheriff or constable at a sale under execution; authorizing a constable to accept payment of certain fees by credit card, debit card or electronic transfer of money; authorizing a constable to require the payment to the constable of a convenience fee for the acceptance of payments by credit card, debit card or

electronic transfer of money; revising the amount of certain fees which a constable is entitled to charge and collect; and providing other matters properly relating thereto.
