GENERAL FILE AND THIRD READING

Senate Bill No. 503.

Bill read third time.

Remarks by Senators Kieckhefer and Gustavson.

SENATOR KIECKHEFER:

Senate Bill No. 503, as amended, expands chapter 387 of *Nevada Revised Statutes* to require public schools with 70 percent or more of the enrolled pupils eligible for free or reduced-price lunches under the National School Lunch Act to provide breakfast to their pupils after an instructional day of school has officially begun. Senate Bill No. 503 requires the Department of Agriculture to distribute funding to eligible schools to assist with the implementation of these breakfast programs, utilizing General Fund appropriations of \$1 million in each year of the 2015-17 biennium that are included in the Executive Budget. Senate Bill No. 503 requires the Department of Agriculture to publish a list of public schools that meet the requirements for participation in the program and adopt regulations prescribing the manner in which these funds would be distributed. Senate Bill No. 503 requires funds to be distributed in sequential order starting with the public school with the highest percentage of enrolled pupils eligible for free or reduced-price lunches under the National School Lunch Act. Senate Bill No. 503 requires the Department of Agriculture to prepare and submit an annual report on the implementation and

effectiveness of the program and submit the report to the Governor and the Director of the Legislative Counsel Bureau.

Senate Bill No. 503 enacts recommendations included in The Executive Budget and becomes effective upon passage and approval for the purpose of adopting any regulations and performing any other preparatory administrative tasks necessary to carry out the provisions of this act, and on July 1, 2015, for all other purposes. Mr. President, Senate Bill No. 503 insures that our children, who need to be fed to learn, have the opportunity to do so.

SENATOR GUSTAVSON:

I have to rise in opposition to Senate Bill No. 503. I agree that studies have shown that students do better if they eat properly, as I do too. However, I do not believe that we should be taking valuable teaching time away from the students so that they can eat. They should do this before the bell, not after the bell.

Assembly Bill No. 37.

Remarks by Senator Manendo.

Assembly Bill No. 37 amends the definitions of "lienholder" and "registered owner," in the context of consignment auctions, to exclude automobile wreckers, body shops, distributors, manufacturers, rebuilders, salvage pools, vehicle dealers or garages. The bill also corrects a date in reference to an existing exemption from smog checks for replica vehicles to prevent a gap in coverage. The bill is effective on July 1, 2015.
