SUMMARY—Authorizes a peace officer or retired peace officer to request the display of an alternate address on his or her driver’s license or identification card. (BDR 43-692)

AN ACT relating to peace officers; authorizing a peace officer or retired peace officer to request the display of an alternate address on his or her driver’s license, identification card, commercial driver’s license or commercial learner’s permit; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Existing law requires the Department of Motor Vehicles to adopt regulations
2 prescribing the information that must be contained on a driver’s license. (NRS
3 483.340) Pursuant to that requirement, existing regulations require that a driver’s
4 license issued by the Department must contain the address of principal residence of
5 the licensee. (NAC 483.040) **Section 2** of this bill authorizes a peace officer or a
6 retired peace officer applying for a driver’s license or renewing a driver’s license to
7 request from the Department a driver’s license that displays an alternate address
8 instead of the address of principal residence. A peace officer must use as an
9 alternate address the address of his or her employer, and a retired peace officer
10 must provide an alternate address at the time he or she submits the request. The
11 peace officer or retired peace officer must provide the Department with his or her
12 address of principal residence or mailing address, if different from the address of
13 principal residence, for the purposes of Department records and mailing.

14 Existing law also requires the Department to adopt regulations prescribing the
15 information that must be contained on an identification card. (NRS 483.840)
16 **Section 3** of this bill authorizes a peace officer or a retired peace officer applying
17 for an identification card or renewing an identification card to request from the

18 Department an identification card that displays an alternate address instead of the
19 address of principal residence, in the same manner as for a driver's license in
20 **section 2.**

21 Existing law further requires the Department to adopt regulations providing for
22 the issuance of commercial driver's licenses. (NRS 483.908) **Section 4** of this bill
23 authorizes a peace officer or a retired peace officer applying for or renewing a
24 commercial driver's license or a commercial learner's permit to request from the
25 Department a commercial driver's license or a commercial learner's permit that
26 displays an alternate address instead of the address of principal residence, in the
27 same manner as for a driver's license or an identification card in **sections 2 and 3.**

28 **Sections 5-7** of this bill make conforming changes.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 483 of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 2, 3 and 4 of this act.

3 **Sec. 2. 1.** *A peace officer may request, at the time of*
4 *application for or renewal of his or her driver's license, the display*
5 *of an alternate address on his or her driver's license. The*
6 *alternative address must be the street address of his or her*
7 *employer.*

8 *2. A retired peace officer may request, at the time of*
9 *application for or renewal of his or her driver's license, the display*
10 *of an alternate address on his or her driver's license. The*
11 *alternative address must be provided by the retired peace officer at*
12 *the time he or she submits the request.*

13 *3. A peace officer or retired peace officer who requests the*
14 *display of an alternate address on his or her driver's license*
15 *pursuant to this section must provide to the Department:*

16 *(a) Proof satisfactory to the Department that he or she*
17 *qualifies for the display of an alternate address on his or her*
18 *driver's license pursuant to this section and any regulations*
19 *adopted pursuant thereto; and*

20 *(b) His or her address of principal residence and mailing*
21 *address, if different from the address of principal residence, for*
22 *use by the Department in recordkeeping and mailing.*

23 *4. A peace officer or retired peace officer who receives from*
24 *the Department a driver's license imprinted with an alternate*
25 *address pursuant to this section who ceases to be qualified for the*
26 *driver's license:*

27 *(a) Shall notify the Department and return the driver's license*
28 *within 30 days after ceasing to be qualified; and*

29 *(b) May apply to the Department for a replacement driver's*
30 *license that displays his or her address of principal residence.*



1 5. *The Department shall adopt regulations setting forth*
2 *criteria pursuant to which the Department will issue or refuse to*
3 *issue a driver's license which displays an alternate address in*
4 *accordance with this section.*

5 6. *As used in this section, "peace officer" means any person*
6 *upon whom some or all of the powers of a peace officer are*
7 *conferred pursuant to NRS 289.150 to 289.360, inclusive.*

8 **Sec. 3.** *1. A peace officer may request, at the time of*
9 *application for or renewal of his or her identification card, the*
10 *display of an alternate address on his or her identification card.*
11 *The alternative address must be the street address of his or her*
12 *employer.*

13 2. *A retired peace officer may request, at the time of*
14 *application for or renewal of his or her identification card, the*
15 *display of an alternate address on his or her identification card.*
16 *The alternative address must be provided by the retired peace*
17 *officer at the time he or she submits the request.*

18 3. *A peace officer or retired peace officer who requests the*
19 *display of an alternate address on his or her identification card*
20 *pursuant to this section must provide to the Department:*

21 (a) *Proof satisfactory to the Department that he or she*
22 *qualifies for the display of an alternate address on his or her*
23 *identification card pursuant to this section and any regulations*
24 *adopted pursuant thereto; and*

25 (b) *His or her address of principal residence and mailing*
26 *address, if different from the address of principal residence, for*
27 *use by the Department in recordkeeping and mailing.*

28 4. *A peace officer or retired peace officer who receives from*
29 *the Department an identification card imprinted with an alternate*
30 *address pursuant to this section who ceases to be qualified for the*
31 *identification card:*

32 (a) *Shall notify the Department and return the identification*
33 *card within 30 days after ceasing to be qualified; and*

34 (b) *May apply to the Department for a replacement*
35 *identification card that displays his or her address of principal*
36 *residence.*

37 5. *The Department shall adopt regulations setting forth*
38 *criteria pursuant to which the Department will issue or refuse to*
39 *issue an identification card which displays an alternate address in*
40 *accordance with this section.*

41 6. *As used in this section, "peace officer" means any person*
42 *upon whom some or all of the powers of a peace officer are*
43 *conferred pursuant to NRS 289.150 to 289.360, inclusive.*

44 **Sec. 4.** *1. A peace officer may request, at the time of*
45 *application for or renewal of his or her commercial driver's*



1 *license or commercial learner's permit, the display of an alternate*
2 *address on his or her commercial driver's license or commercial*
3 *learner's permit. The alternative address must be the street*
4 *address of his or her employer.*

5 *2. A retired peace officer may request, at the time of*
6 *application for or renewal of his or her commercial driver's*
7 *license or commercial learner's permit, the display of an alternate*
8 *address on his or her commercial driver's license or commercial*
9 *learner's permit. The alternative address must be provided by the*
10 *retired peace officer at the time he or she submits the request.*

11 *3. A peace officer or retired peace officer who requests the*
12 *display of an alternate address on his or her commercial driver's*
13 *license or commercial learner's permit pursuant to this section*
14 *must provide to the Department:*

15 *(a) Proof satisfactory to the Department that he or she*
16 *qualifies for the display of an alternate address on his or her*
17 *commercial driver's license or commercial learner's permit*
18 *pursuant to this section and any regulations adopted pursuant*
19 *thereto; and*

20 *(b) His or her address of principal residence and mailing*
21 *address, if different from the address of principal residence, for*
22 *use by the Department in recordkeeping and mailing.*

23 *4. A peace officer or retired peace officer who receives from*
24 *the Department a commercial driver's license or commercial*
25 *learner's permit imprinted with an alternate address pursuant to*
26 *this section who ceases to be qualified for the commercial driver's*
27 *license or commercial learner's permit:*

28 *(a) Shall notify the Department and return the commercial*
29 *driver's license or commercial learner's permit within 30 days*
30 *after ceasing to be qualified; and*

31 *(b) May apply to the Department for a replacement*
32 *commercial driver's license or commercial learner's permit that*
33 *displays his or her address of principal residence.*

34 *5. The Department shall adopt regulations setting forth*
35 *criteria pursuant to which the Department will issue or refuse to*
36 *issue a commercial driver's license or commercial learner's permit*
37 *which displays an alternate address in accordance with this*
38 *section.*

39 *6. As used in this section, "peace officer" means any person*
40 *upon whom some or all of the powers of a peace officer are*
41 *conferred pursuant to NRS 289.150 to 289.360, inclusive.*

42 **Sec. 5.** NRS 483.015 is hereby amended to read as follows:

43 483.015 Except as otherwise provided in NRS 483.330, the
44 provisions of NRS 483.010 to 483.630, inclusive, *and section 2 of*
45 *this act* apply only with respect to noncommercial drivers' licenses.



1 **Sec. 6.** NRS 483.020 is hereby amended to read as follows:
 2 483.020 As used in NRS 483.010 to 483.630, inclusive, *and*
 3 *section 2 of this act*, unless the context otherwise requires, the
 4 words and terms defined in NRS 483.030 to 483.190, inclusive,
 5 have the meanings ascribed to them in those sections.

6 **Sec. 7.** NRS 483.820 is hereby amended to read as follows:
 7 483.820 1. A person who applies for an identification card in
 8 accordance with the provisions of NRS 483.810 to 483.890,
 9 inclusive, *and section 3 of this act* and who is not ineligible to
 10 receive an identification card pursuant to NRS 483.861, is entitled to
 11 receive an identification card if the person is:

12 (a) A resident of this State and is 10 years of age or older and
 13 does not hold a valid driver’s license or identification card from any
 14 state or jurisdiction; or

15 (b) A seasonal resident who does not hold a valid Nevada
 16 driver’s license.

17 2. Except as otherwise provided in NRS 483.825, the
 18 Department shall charge and collect the following fees for the
 19 issuance of an original, duplicate or changed identification card:

 3 years of age, which expires on or before the fourth
 4 anniversary of the person’s birthday \$9

 7 which expires on or before the fourth anniversary of
 8 the person’s birthday 9
 9 A new photograph or change of name, or both 4

 11 3. The Department shall not charge a fee for:

12 (a) An identification card issued to a person who has voluntarily
 13 surrendered his or her driver’s license pursuant to NRS 483.420; or

14 (b) A renewal of an identification card for a person 65 years of
 15 age or older.

16 4. Except as otherwise provided in NRS 483.825, the increase
 17 in fees authorized in NRS 483.347 must be paid in addition to the
 18 fees charged pursuant to this section.

19 5. As used in this section, “photograph” has the meaning
 20 ascribed to it in NRS 483.125.

21 **Sec. 8.** NRS 483.900 is hereby amended to read as follows:

22 483.900 The purposes of NRS 483.900 to 483.940, inclusive,
 23 *and section 4 of this act* are to implement the Commercial Motor
 24 Vehicle Safety Act of 1986, as amended, 49 U.S.C. chapter 313 (§§
 25 31301 et seq.), and reduce or prevent commercial motor vehicle
 26 crashes, fatalities and injuries by:

27 1. Permitting drivers of commercial motor vehicles to hold
 28 only one license;

29 2. Providing for the disqualification of drivers of commercial
 30 motor vehicles who have committed certain serious traffic violations
 31 or other specified offenses;

32 3. Strengthening the licensing and testing standards for drivers
 33 of commercial motor vehicles; and

34 4. Ensuring that drivers of commercial motor vehicles carrying
 35 hazardous materials are qualified to operate a commercial motor
 36 vehicle in accordance with all regulations pertaining to the
 37 transportation of hazardous materials and have the skills and
 38 knowledge necessary to respond appropriately to any emergency
 39 arising out of the transportation of hazardous materials.

40 **Sec. 9.** NRS 483.902 is hereby amended to read as follows:

41 483.902 The provisions of NRS 483.900 to 483.940, inclusive,
 42 *and section 4 of this act* apply only with respect to commercial
 43 drivers’ licenses.



1 **Sec. 10.** NRS 483.904 is hereby amended to read as follows:
2 483.904 As used in NRS 483.900 to 483.940, inclusive, *and*
3 *section 4 of this act*, unless the context otherwise requires:

4 1. “Commercial driver’s license” means a license issued to a
5 person which authorizes the person to drive a class or type of
6 commercial motor vehicle.

7 2. “Commercial Driver’s License Information System” means
8 the information system maintained by the Secretary of
9 Transportation pursuant to 49 U.S.C. § 31309 to serve as a
10 clearinghouse for locating information relating to the licensing,
11 identification and disqualification of operators of commercial motor
12 vehicles.

13 3. “Out-of-service order” means a temporary prohibition
14 against:

15 (a) A person operating a commercial motor vehicle as such a
16 prohibition is described in 49 C.F.R. § 395.13; or

17 (b) The operation of a commercial motor vehicle as such a
18 prohibition is described in 49 C.F.R. § 396.9(c).

19 **Sec. 11.** This act becomes effective upon passage and approval
20 for the purpose of adopting regulations pursuant to the amendatory
21 provisions of this act and on July 1, 2017, for all other purposes.
