SUMMARY—Revises provisions governing land use planning. (BDR 22-954)

AN ACT relating to land use planning; establishing uniform statewide standards that local governments must strictly comply with when exercising powers of land use planning, subdivision regulation and zoning with regard to certain lands within or surrounding national conservation areas; repealing provisions relating to land use planning, subdivision regulation and zoning with regard to certain national conservation areas, national recreation areas and adjacent lands; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

- 1 Under existing law, the Legislature has authorized local governments to
- 2 exercise certain powers relating to land use planning, subdivision regulation and
- 3 zoning. (Chapters 244, 268, 269 and 278 of NRS) This bill establishes uniform
- 4 statewide standards that local governments must strictly comply with when
- 5 exercising those powers with regard to certain lands within or surrounding any
- 6 national conservation areas in Nevada.

7 Currently, the Congress of the United States has designated by federal law the
8 following national conservation areas in Nevada: (1) the Black Rock Desert-High
9 Rock Canyon Emigrant Trails National Conservation Area in Humboldt, Pershing
10 and Washoe Counties (16 U.S.C. §§ 460ppp et seq.); (2) the Sloan Canyon National
11 Conservation Area in Clark County (16 U.S.C. §§ 460qqq et seq.); and (3) the Red
12 Rock Canyon National Conservation Area in Clark County (16 U.S.C. §§ 460ccc et
13 seq.). If Congress designates by federal law any additional national conservation
14 areas in Nevada, this bill would apply to the lands within or surrounding those
15 national conservation areas but only after the enactment of the federal law making
16 the designation.

17 **Section 1.1** of this bill sets forth legislative findings and declarations
18 underlying this bill. In particular, the Legislature finds in **section 1.1** that because
19 of the importance of the natural resources found within national conservation areas
20 in Nevada, there is a legitimate and compelling need to enact uniform statewide
21 standards to regulate development on lands within or surrounding national
22 conservation areas to ensure that development on such lands proceeds at the local
23 level in an orderly and responsible manner without detrimentally and irreversibly
24 impacting the natural resources found within national conservation areas in Nevada.
25 In order to secure, promote and advance these legislative purposes and objectives,
26 the Legislature declares in **section 1.1** that it is necessary and essential to: (1)
27 designate and define natural resources overlay lands; (2) establish uniform
28 statewide standards that local governments must strictly comply with when
29 regulating the use of those lands; and (3) provide for judicial review and other
30 appropriate remedies to ensure that local governments strictly comply with those
31 standards.

32 **Section 1.45** of this bill defines “natural resources overlay lands” to mean all
33 parcels of land located: (1) within the boundary of any national conservation area in
34 this State; or (2) not more than one-half mile outside the boundary of any national
35 conservation area in this State. **Section 1.45** also provides that if any parcel of land
36 is located partially but not entirely within natural resources overlay lands, the
37 portion of the parcel within natural resources overlay lands is subject to this bill but
38 the remaining portion of the parcel is not subject to this bill, unless a proposed
39 project on the remaining portion includes any part of the portion of the parcel
40 within natural resources overlay lands.

41 However, **sections 1.25, 1.35 and 1.45** of this bill create an exemption from
42 this bill for any parcel of land subject to any development agreement that was
43 approved and recorded under NRS 278.0201-278.0207 before the effective date of
44 this bill. Additionally, **section 4.5** of this bill creates an exemption from this bill for
45 any project to develop lands if a local government took final action that approved
46 the project before the effective date of this bill and the local government’s final
47 action of approval remained in effect and was enforceable on the effective date of
48 this bill.

49 With regard to natural resources overlay lands that are subject to this bill,
50 **sections 1.55 and 2-4** of this bill provide that a local government’s powers relating
51 to planning, subdivision regulation and zoning are subordinate to this bill.
52 However, those sections also provide that this bill establishes, as a minimum
53 threshold, uniform statewide standards relating to natural resources overlay lands
54 but this bill does not preempt or otherwise limit a local government from imposing,
55 with regard to those lands, standards relating to planning, subdivision regulation
56 and zoning that are stricter or more protective of natural resources overlay lands
57 than the standards set forth in this bill. In addition, **section 1.6** of this bill authorizes
58 a local government to enact ordinances and adopt policies and procedures that
59 implement and facilitate this bill so long as they are consistent with this bill.

60 **Sections 1.2-1.35, 1.5 and 1.65-1.8** of this bill establish uniform statewide
61 standards for any proposed project to develop, improve or build on natural

62 resources overlay lands that requires final action by a local government, except for
63 any public parks, trailheads, trails or other public recreational facilities that are
64 constructed by a local government or by a developer pursuant to any development
65 agreement.

66 Under **section 1.65**, a local government cannot take final action on a proposed
67 project unless: (1) the developer prepares and submits an environmental impact
68 statement; (2) the local government posts the environmental impact statement on its
69 Internet website at least 15 calendar days before the public hearing at which the
70 local government may take final action; and (3) the local government applies and
71 weighs certain factors relating to the impact of the proposed project on natural
72 resources overlay lands. However, if an environmental review relating to the
73 proposed project has already been conducted by an appropriate federal or state
74 agency under law, **section 1.65** does not require the developer to prepare and
75 submit an additional environmental impact statement. Instead, the local government
76 must accept and utilize the findings and conclusions made in the federal or state
77 agency's environmental review.

78 Under **section 1.7**, when the developer prepares and submits an environmental
79 impact statement, the developer must provide a professional, detailed, thorough and
80 comprehensive analysis and explanation concerning the environmental impacts that
81 the proposed project will have on natural resources overlay lands. In reviewing and
82 analyzing the environmental impact statement, **section 1.7** permits the local
83 government to use the regulations adopted by the Council on Environmental
84 Quality pursuant to the National Environmental Policy Act of 1969 (42 U.S.C. §§
85 4321 et seq.) as a guide in determining whether the environmental impact statement
86 accurately and appropriately addresses the environmental impacts that the proposed
87 project will have on natural resources overlay lands, but those regulations are not
88 binding or determinative.

89 Under **section 1.75**, before the local government takes final action on the
90 proposed project, it must apply and weigh several factors relating to the impact of
91 the proposed project on natural resources overlay lands, including: (1) whether the
92 proposed project will be located near or in close proximity to existing developed or
93 urban lands or existing undeveloped or rural lands; (2) whether the proposed
94 project will be located near or in close proximity to existing infrastructure and
95 utilities or whether the project will require extensive work to build necessary
96 infrastructure and utilities; (3) whether the proposed project will have significant
97 beneficial or adverse environmental impacts; (4) whether the proposed project will
98 restrict or impair open space or public access to open space; and (5) whether the
99 proposed project will protect or preserve or destroy or impair natural terrain, native
100 vegetation, wildlife habitat, watershed areas, scenic views or geological formations.
101 In addition to these factors, **section 1.75** permits the local government to consider
102 other factors relating to planning, subdivision regulation and zoning that are stricter
103 or more protective of natural resources overlay lands.

104 Under **section 1.8**, if the local government does not strictly comply with this
105 bill when it takes any final action on the proposed project: (1) the final action is
106 deemed void and is of no legal force or effect; and (2) any person aggrieved by the
107 final action may appeal the final action to the district court by filing a petition for
108 judicial review against the local government within the 25-day appeal period. If an
109 aggrieved party timely files a petition for judicial review, **section 1.8** provides that
110 the court must determine, based upon the record, whether the local government
111 strictly complied with this bill and whether the local government's determination
112 was based upon substantial evidence in the record. If the aggrieved party prevails
113 on any claim for relief against the local government, **section 1.8** provides that the
114 aggrieved party is entitled to an award of reasonable attorney's fees and court costs.
115 **Section 1.8** also provides that the developer cannot be awarded attorney's fees or
116 court costs, regardless of the outcome of the judicial review, unless the court

117 imposes them as a penalty against another party for ethically or procedurally
118 improper conduct that is independently sanctionable under court rules or other
119 laws.

120 Finally, during the 1993 Legislative Session, the Legislature enacted Senate
121 Bill No. 544 (1993 Red Rock Canyon Act), which is a special act that regulates
122 certain uses of land within the Red Rock Canyon National Conservation Area in
123 Clark County. (Chapter 639, Statutes of Nevada 1993, p. 2673) During the 2003
124 Legislative Session, the Legislature amended the 1993 Red Rock Canyon Act by
125 enacting Senate Bill No. 358 (2003 Red Rock Canyon Act), which is a special act
126 that restricts the authority of local governments to regulate planning, subdividing
127 and zoning of certain lands located in and adjacent to the Red Rock Canyon
128 National Conservation Area in Clark County. (Chapter 639, Statutes of Nevada
129 1993, p. 2673, as amended by chapter 105, Statutes of Nevada 2003, p. 595) In
130 2013, the Nevada Supreme Court ruled that the 2003 Red Rock Canyon Act
131 violates Sections 20, 21 and 25 of Article 4 of the Nevada Constitution on the
132 grounds that it: (1) is a "local or special law" that "regulates county business"; and
133 (2) establishes a "system of county government" that is not "uniform throughout
134 the State." (*Attorney General v. Gypsum Resources*, 129 Nev. Adv. Op. 4, 294 p.3d
135 404 (2013))

136 To conform existing statutory provisions with the constitutional requirements
137 established by the Nevada Supreme Court in *Gypsum Resources* and to resolve any
138 statutory conflicts with this bill, **section 5** of this bill repeals: (1) the pertinent
139 provisions of the 1993 Red Rock Canyon Act and the 2003 Red Rock Canyon Act;
140 and (2) related provisions of the Nevada Revised Statutes. (NRS 244.154, 268.105,
141 269.617, 278.0239) In addition, **section 5** also repeals certain provisions of the
142 Spring Mountains National Recreation Area Act, chapter 198, Statutes of Nevada
143 2009, p. 734, which are similar to the provisions of the 2003 Red Rock Canyon Act
144 that the Court in *Gypsum Resources* held unconstitutional.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 278 of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 1.1 to 1.8, inclusive, of
3 this act.

4 **Sec. 1.1. 1. *The Legislature hereby finds that:***

5 *(a) Some of this State's most valuable and distinctive natural*
6 *resources are found within national conservation areas in Nevada,*
7 *and those natural resources must be protected and preserved*
8 *because they are uniquely beautiful, incomparably scenic and*
9 *geologically, scientifically, historically and culturally significant;*

10 *(b) The natural resources found within national conservation*
11 *areas in Nevada also contribute to the public's health, well-being*
12 *and welfare and stimulate this State's economy because those*
13 *natural resources offer unparalleled recreational opportunities in*
14 *peaceful and idyllic settings which are enjoyed by the residents of*
15 *this State and which draw many tourists, sightseers and*
16 *recreational users from other states and countries to Nevada; and*



1 (c) Because of the importance of the natural resources found
2 within national conservation areas in Nevada, there is a legitimate
3 and compelling need to enact uniform statewide standards to
4 regulate development on lands within or surrounding national
5 conservation areas in Nevada to ensure that development on such
6 lands proceeds at the local level in an orderly and responsible
7 manner without detrimentally and irreversibly impacting the
8 natural resources found within national conservation areas in
9 Nevada.

10 2. The Legislature hereby declares that it is in the best
11 interests of this State, beneficial to the public's health, well-being
12 and welfare and necessary and essential for protecting and
13 preserving this State's natural resources and for securing,
14 promoting and obtaining the benefits of those natural resources
15 for present and future generations to:

16 (a) Designate and define natural resources overlay lands;

17 (b) Establish uniform statewide standards that local
18 governments must strictly comply with when regulating the use of
19 those lands; and

20 (c) Provide for judicial review and other appropriate remedies
21 to ensure that local governments strictly comply with those
22 standards.

23 Sec. 1.15. As used in sections 1.1 to 1.8, inclusive, of this act,
24 unless the context otherwise requires, the words and terms defined
25 in sections 1.2 to 1.5, inclusive, of this act have the meanings
26 ascribed to them in those sections.

27 Sec. 1.2. "Developer" means a person who wants to
28 undertake or complete any proposed project to develop, improve or
29 build on natural resources overlay lands.

30 Sec. 1.25. 1. "Development agreement" means any
31 agreement for the development of lands authorized pursuant to
32 NRS 278.0201 to 278.0207, inclusive.

33 2. The term does not include any development agreement that
34 was approved and recorded pursuant to NRS 278.0201 to
35 278.0207, inclusive, before the effective date of this act.

36 Sec. 1.3. "Environmental impact statement" means a
37 detailed report which a developer prepares and submits pursuant
38 to sections 1.1 to 1.8, inclusive, of this act for the purposes of
39 providing both the local government and the public with detailed
40 information concerning the environmental impacts that a
41 proposed project will have on natural resources overlay lands.

42 Sec. 1.35. 1. "Final action" means any final action,
43 decision or order that is taken by:

44 (a) The governing body of a local government; or



1 (b) Any public officer, as defined in NRS 281.005, or
2 commission, board or other body of the local government that is
3 taking such final action, decision or order in lieu of any final
4 action, decision or order taken by the governing body.

5 2. The term includes, without limitation, any final action,
6 decision or order that is taken with regard to:

7 (a) Establishing new zoning districts;

8 (b) Amending, altering or expanding existing zoning districts;

9 (c) Establishing or increasing the number or density of units
10 within zoning districts;

11 (d) Granting or allowing variances or special uses within
12 zoning districts; or

13 (e) Approving any development agreement.

14 3. The term does not include any final action, decision or
15 order that is taken with regard to any parcel of land subject to any
16 development agreement that was approved and recorded pursuant
17 to NRS 278.0201 to 278.0207, inclusive, before the effective date
18 of this act.

19 **Sec. 1.4.** "National conservation area" means any area
20 designated by federal law as a national conservation area by the
21 Congress of the United States.

22 **Sec. 1.45.** 1. "Natural resources overlay lands" means all
23 parcels of land located:

24 (a) Within the boundary of any national conservation area in
25 this State; or

26 (b) Not more than one-half mile outside the boundary of any
27 national conservation area in this State.

28 2. The term includes, without limitation:

29 (a) Any parcel of land in its natural state;

30 (b) Any parcel of land that is zoned, rezoned or not zoned;

31 (c) Any parcel of land that is subdivided or developed into
32 smaller parcels or lots;

33 (d) Any parcel of land that is developed for any residential or
34 nonresidential use; or

35 (e) Any other parcel of land that is undeveloped or developed,
36 in whole or in part, regardless of its use.

37 3. The term does not include any parcel of land subject to any
38 development agreement that was approved and recorded pursuant
39 to NRS 278.0201 to 278.0207, inclusive, before the effective date
40 of this act.

41 4. For the purposes of this section, if any parcel of land is
42 located partially but not entirely within natural resources overlay
43 lands:

44 (a) The portion of the parcel within natural resources overlay
45 lands is subject to sections 1.1 to 1.8, inclusive, of this act; and



1 (b) *The remaining portion of the parcel is not subject to*
2 *sections 1.1 to 1.8, inclusive, of this act, unless a proposed project*
3 *on the remaining portion includes any part of the portion of the*
4 *parcel within natural resources overlay lands.*

5 **Sec. 1.5.** 1. *“Project” means any project to develop,*
6 *improve or build on natural resources overlay lands that requires*
7 *final action by a local government.*

8 2. *The term does not include any public parks, trailheads,*
9 *trails or other public recreational facilities that are constructed by*
10 *a local government or by a developer pursuant to any development*
11 *agreement.*

12 **Sec. 1.55.** 1. *Notwithstanding any other provision of law to*
13 *the contrary:*

14 (a) *The powers otherwise conferred by this chapter which*
15 *relate to planning, subdivision regulation and zoning are*
16 *subordinate to the provisions of sections 1.1 to 1.8, inclusive, of*
17 *this act; and*

18 (b) *A local government shall strictly comply with the*
19 *provisions of sections 1.1 to 1.8, inclusive, of this act.*

20 2. *If there is a conflict between any other provisions of this*
21 *chapter and the provisions of sections 1.1 to 1.8, inclusive, of this*
22 *act, the provisions of sections 1.1 to 1.8, inclusive, of this act*
23 *control.*

24 3. *The provisions of sections 1.1 to 1.8, inclusive, of this act:*

25 (a) *Establish, as a minimum threshold, uniform statewide*
26 *standards relating to natural resources overlay lands; and*

27 (b) *Must not be interpreted to preempt or otherwise limit a*
28 *local government from imposing, with regard to those lands,*
29 *standards relating to planning, subdivision regulation and zoning*
30 *that are stricter or more protective of natural resources overlay*
31 *lands than the standards set forth in sections 1.1 to 1.8, inclusive,*
32 *of this act.*

33 **Sec. 1.6.** *For the purposes of carrying out the provisions of*
34 *sections 1.1 to 1.8, inclusive, of this act, a local government may*
35 *enact ordinances and adopt policies and procedures that*
36 *implement and facilitate those provisions and are consistent*
37 *therewith, including, without limitation, requiring developers to*
38 *pay for the costs of the local government to review and analyze an*
39 *environmental impact statement.*

40 **Sec. 1.65.** 1. *Except as otherwise provided in this section, if*
41 *a developer wants to undertake or complete any proposed project*
42 *on natural resources overlay lands, a local government shall not*
43 *take any final action regarding the proposed project unless:*

44 (a) *The developer prepares and submits an environmental*
45 *impact statement that complies with section 1.7 of this act;*



1 (b) The local government posts the environmental impact
2 statement on its Internet website at least 15 calendar days before
3 the public hearing at which the local government may take final
4 action; and

5 (c) The local government applies and weighs the factors set
6 forth in section 1.75 of this act.

7 2. If an environmental review relating to the proposed project
8 has already been conducted by an appropriate federal agency or
9 state agency pursuant to federal or state law:

10 (a) The local government shall accept and utilize the findings
11 and conclusions made in that review for the purposes of carrying
12 out the provisions of sections 1.1 to 1.8, inclusive, of this act; and

13 (b) The developer is not required to prepare and submit an
14 additional environmental impact statement that complies with
15 section 1.7 or this act.

16 **Sec. 1.7.** 1. In an environmental impact statement, a
17 developer must provide a professional, detailed, thorough and
18 comprehensive analysis and explanation concerning the
19 environmental impacts that a proposed project will have on
20 natural resources overlay lands.

21 2. The developer must pay all costs associated with
22 preparation of the environmental impact statement.

23 3. The environmental impact statement must analyze and
24 explain:

25 (a) All significant beneficial and adverse environmental
26 impacts of the proposed project;

27 (b) All significant adverse environmental impacts of the
28 proposed project which cannot be avoided if the proposed project
29 is completed or which would have irreversible consequences if the
30 project is completed;

31 (c) All reasonable alternatives to the proposed project;

32 (d) All mitigation measures which must be implemented to
33 address, alleviate or offset the significant adverse environmental
34 impacts of the proposed project; and

35 (e) The growth-inducing impact of the proposed project.

36 4. For the purposes of the environmental impact statement:

37 (a) Significant beneficial environmental impacts may include,
38 without limitation:

39 (1) The development or use of renewable energy or
40 renewable energy generation projects;

41 (2) The establishment or maintenance of public parks,
42 trailheads, trails or other public recreational facilities;

43 (3) The development or use of land for recreational,
44 educational or charitable purposes by a nonprofit organization



1 *that qualifies as a tax-exempt organization pursuant to 26 U.S.C.*
2 *§ 501(c) or state law; or*

3 *(4) The protection or preservation of natural terrain, native*
4 *vegetation, wildlife habitat, watershed areas, scenic views or*
5 *geological formations.*

6 *(b) Significant adverse environmental impacts may include,*
7 *without limitation:*

8 *(1) The development or use of fossil fuels;*

9 *(2) The generation of air pollution, water pollution, light*
10 *pollution, noise pollution or other types of pollution;*

11 *(3) The restriction or elimination of open space or public*
12 *access to open space; or*

13 *(4) The destruction or impairment of natural terrain, native*
14 *vegetation, wildlife habitat, watershed areas, scenic views or*
15 *geological formations.*

16 *5. In reviewing and analyzing an environmental impact*
17 *statement, the local government may use the regulations adopted*
18 *by the Council on Environmental Quality pursuant to the National*
19 *Environmental Policy Act of 1969, 42 U.S.C. §§ 4321 et seq., as a*
20 *guide in determining whether an environmental impact statement*
21 *accurately and appropriately addresses the environmental impacts*
22 *that the proposed project will have on natural resources overlay*
23 *lands, but those regulations are not binding or determinative.*

24 **Sec. 1.75. 1.** *Before a local government takes any final*
25 *action regarding a proposed project on natural resources overlay*
26 *lands, the local government shall apply and weigh the following*
27 *factors:*

28 *(a) Whether the proposed project will be located near or in*
29 *close proximity to existing developed or urban lands or existing*
30 *undeveloped or rural lands.*

31 *(b) Whether the proposed project will be located near or in*
32 *close proximity to existing infrastructure and utilities or whether*
33 *the project will require extensive work to build necessary*
34 *infrastructure and utilities.*

35 *(c) Whether the proposed project will have significant*
36 *beneficial or adverse environmental impacts.*

37 *(d) Whether the proposed project will restrict or impair open*
38 *space or public access to open space.*

39 *(e) Whether the proposed project will protect or preserve or*
40 *destroy or impair natural terrain, native vegetation, wildlife*
41 *habitat, watershed areas, scenic views or geological formations.*

42 **2.** *The provisions of this section:*

43 *(a) Establish, as a minimum threshold, the factors that a local*
44 *government must apply and weigh before the local government*



1 *takes any final action regarding a proposed project on natural*
2 *resources overlay lands; and*

3 *(b) Must not be interpreted to preempt or otherwise limit a*
4 *local government from applying and weighing, with regard to*
5 *those lands, other factors relating to planning, subdivision*
6 *regulation and zoning that are stricter or more protective of*
7 *natural resources overlay lands than the factors set forth in this*
8 *section.*

9 **Sec. 1.8.** *1. A local government shall not take any final*
10 *action regarding a proposed project on natural resources overlay*
11 *lands unless the local government strictly complies with the*
12 *provisions of sections 1.1 to 1.8, inclusive, of this act.*

13 *2. If a local government does not strictly comply with the*
14 *provisions of sections 1.1 to 1.8, inclusive, of this act when it takes*
15 *any final action regarding a proposed project on natural resources*
16 *overlay lands:*

17 *(a) The final action shall be deemed to be void and of no legal*
18 *force or effect; and*

19 *(b) Any person aggrieved by the final action may appeal the*
20 *final action to the district court of the proper county by filing a*
21 *petition for judicial review against the local government within 25*
22 *days after the date of filing of notice of the final action with the*
23 *clerk or secretary of the governing body of the local government*
24 *as set forth in NRS 278.0235.*

25 *3. For the purposes of this section, a person shall be deemed*
26 *to be aggrieved by the final action taken by the local government if*
27 *the person appeared before the local government, either in person,*
28 *through an authorized representative or in writing, regarding the*
29 *final action.*

30 *4. If a person brings a petition for judicial review pursuant to*
31 *this section:*

32 *(a) The purpose of the judicial review is for the court to*
33 *determine, based upon the record, whether the local government*
34 *strictly complied with the provisions of sections 1.1 to 1.8,*
35 *inclusive, of this act and whether the determination of the local*
36 *government was based upon substantial evidence in the record.*

37 *(b) If the person prevails on any claim for relief against the*
38 *local government, the court shall award reasonable attorney's fees*
39 *and court costs to the person regarding the prevailing claim, but*
40 *the developer whose proposed project is the subject of the judicial*
41 *review may not be awarded attorney's fees or court costs,*

Section 1 of chapter 639, Statutes of Nevada 1993:

Section 1. The legislature finds and declares that this special act which regulates activity in the Red Rock Canyon national conservation area is necessary because of:

1. The unusual beauty of the Red Rock Canyon national conservation area; and
2. The rapidly increasing population and growth in the region around the Red Rock Canyon national conservation area.

Section 2 of chapter 639, Statutes of Nevada 1993:

Sec. 2. As used in sections 1 to 4, inclusive, of this act, "Red Rock Canyon national conservation area" means the area in and around Red Rock Canyon which has been designated as a national conservation area by Congress pursuant to Title 16 of the United States Code.

Section 3 of chapter 639, Statutes of Nevada 1993:

Sec. 3. 1. Except as otherwise provided in subsection 2, the governing body of a city or county whose territory



includes all or any part of the Red Rock Canyon national conservation area shall in regulating the use of land prohibit the use of any part of the national conservation area for any purpose other than recreation, and shall prohibit excavation, the extraction of any substance, and the erection of any structure within the national conservation area.

2. Within the boundaries of a patented or unpatented mining claim the governing body may permit excavation, the extraction of any substance, or the making of improvements only to the extent permitted by a federally approved plan of operations or exempted by federal law or regulation from having an approved plan of operations.

Section 4 of chapter 639, Statutes of Nevada 1993:

Sec. 4. In the absence or pending the adoption and effectiveness of an ordinance complying with section 3 of this act, excavation, the extraction of any substance, and the erection of any structure are prohibited within the Red Rock Canyon national conservation area unless a permit is first obtained from the division of environmental protection of the state department of conservation and natural resources. The division shall not issue such a permit if the proposed activity would be detrimental to the environment outside the Red Rock Canyon national conservation area or would preclude the designation of the national conservation area as wilderness.

4. *All of sections 31 and 32, Township 20 South, Range 59 East, MDM, with the exception of any lands that are located within the corporate limits of the City of Las Vegas on the effective date of this act;*

5. *All of sections 3 and 4, Township 21 South, Range 59 East, MDM, with the exception of any lands that are located within the corporate limits of the City of Las Vegas on the effective date of this act;*

6. *All of sections 5, 6, 7, 8, 9, 10 and 11, Township 21 South, Range 59 East, MDM, with the exception of any lands that are located within the Summerlin South unincorporated area on the effective date of this act;*

(b) Retain all other authority regarding planning, zoning and regulation of uses of land.

(c) Expand the size of any nonresidential zoning district in existence on the effective date of this act, other than for public facilities.

2. May regulate matters to include, without limitation, landscaping, buffering, screening, signage and lighting.

3. Retains all other authority regarding planning, zoning and regulation of uses of land.
