SUMMARY—Revises provisions governing the consideration of the criminal history of an applicant for employment by the State or a county, city or unincorporated town. (BDR 23-33)

AN ACT relating to public employment; providing generally that the criminal history of an applicant or other qualified person under consideration for a position in the unclassified or classified service of the State may be considered only under certain circumstances; prohibiting the Administrator, when examining an applicant for a position in the classified service of the State, from considering the criminal history of the applicant; providing that, except in certain circumstances, the criminal history of a person may serve as the basis for the Administrator to refuse to certify an applicant or for rescission of a conditional offer of employment in the unclassified or classified service of the State only after consideration of certain factors relating to the criminal history of the person; providing for written notice to a person if the criminal history of the person is the basis for the Administrator's refusal to certify the person or for the rescission of a conditional offer of employment; establishing similar provisions relating to the consideration by the governing body of a county, incorporated city or unincorporated town of the criminal history of an applicant for employment by a county, incorporated city or unincorporated town; authorizing the filing of a complaint with the Nevada Equal Rights Commission under certain circumstances; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law governs generally the employment of persons in the classified and
2 unclassified service of the State. Existing law further establishes the duties of the
3 Administrator of the Division of Human Resource Management of the Department
4 of Administration with regard to administering competitive examinations of
5 persons seeking employment in the classified service of the State and maintaining a
6 list of eligible persons for employment in the classified service. (Chapter 284 of
7 NRS) Under existing law, the Administrator may refuse to examine an applicant or
8 refuse to certify an eligible person if the person has been found guilty of any crime
9 involving moral turpitude or of infamous or notoriously disgraceful conduct.
10 (NRS 284.240)

11 **Section 2** of this bill provides, with exceptions, that the criminal history of an
12 applicant or other qualified person under consideration for employment in the
13 unclassified service of the State may be considered only after the earliest of: (1) the
14 final interview conducted in person; (2) the appointing authority has made a
15 conditional offer of employment to the applicant; or (3) if applicable, the applicant
16 has been certified by the Administrator. **Section 3** of this bill prohibits the
17 Administrator from considering the criminal history of an applicant in examining
18 the applicant. Additionally, **section 3** provides, with exceptions, that the criminal
19 history of an applicant for a position in the classified service may be considered
20 only after the earliest of: (1) the final interview conducted in person; (2) the
21 applicant has been certified by the Administrator; or (3) the appointing authority
22 has made a conditional offer of employment to the applicant. **Sections 2 and 3** set
23 forth specific factors that must be considered by an appointing authority or the
24 Administrator before the criminal history of an applicant may be used as the basis
25 for rescinding a conditional offer of employment or for rejection of the applicant,
26 including: (1) whether any criminal offense charged against or committed by the
27 person directly relates to the responsibilities of the position for which the person
28 has applied; (2) the nature and severity of each criminal offense charged against or
29 committed by the person; (3) the age of the person at the time of the commission of
30 each criminal offense; (4) the period of time between the commission of each
31 criminal offense and the date of the application for employment; and (5) any
32 information or documentation demonstrating the person's rehabilitation. **Sections**
33 **5, 6 and 6.3** of this bill establish similar provisions relating to the consideration by
34 the governing body of a county, incorporated city or unincorporated town,
35 respectively, of the criminal history of an applicant for employment by the county,
36 incorporated city or unincorporated town. **Sections 2, 3, 5, 6 and 6.3** provide that if
37 the criminal history of an applicant is used as the basis for rejecting the applicant or
38 rescinding a conditional offer of employment extended to the applicant, the
39 appointing authority or the governing body of the county, incorporated city or
40 unincorporated town, as applicable, must provide to the applicant a written
41 statement which must specifically state the evidence presented and the reason for
42 the rejection of the applicant or rescission of the conditional offer of employment.
43 **Sections 2, 3, 5, 6 and 6.3** also prohibit the appointing authority or the governing
44 body of a county, incorporated city or unincorporated town from considering
45 certain criminal records. **Sections 2, 3, 5, 6 and 6.3** also require the appointing
46 authority or the governing body of a county, incorporated city or unincorporated
47 town to include certain information in an application for employment. **Sections 2,**
48 **3, 5, 6 and 6.3** do not apply to any applicant for employment: (1) as a peace officer
49 or firefighter; or (2) in any position that entails physical access to a computer or
50 other equipment used for access to the Nevada Criminal Justice Information System
51 or the National Crime Information Center.

52 Existing law declares certain employment practices to be unlawful and
53 authorizes any person injured by such a practice to file a complaint with the Nevada
54 Equal Rights Commission. Generally, the Commission has jurisdiction only over



55 practices involving discrimination on the basis of race, color, sex and certain other
56 enumerated characteristics. (NRS 613.330, 613.405) **Section 6.5** of this bill
57 provides that an employer that is subject to the requirements of **section 2, 3, 5, 6 or**
58 **6.3** and fails to follow the procedure required by those sections in considering the
59 criminal history of an applicant for employment thereby engages in an unlawful
60 employment practice. **Section 6.7** of this bill provides that the applicant in such a
61 case may file a complaint with the Commission, regardless of whether the
62 complaint is based on race, color, sex or some other characteristic enumerated in
63 existing law.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

15 *applicant or extending to an applicant a conditional offer of*
16 *employment, notify the applicant of any provision of state or*
17 *federal law that disqualifies a person with a particular criminal*
18 *history from employment in a particular position.*

19 3. *Unless, pursuant to a specific provision of state or federal*
20 *law, a person is disqualified from employment in a particular*
21 *position because of the particular criminal history of the person,*
22 *an appointing authority may rescind a conditional offer of*
23 *employment extended to an otherwise qualified person who has*
24 *criminal charges pending against him or her that were filed within*
25 *the previous 6 months or has been convicted of a criminal offense*
26 *only after considering:*

27 (a) *Whether any criminal offense charged against the person*
28 *or committed by the person directly relates to the responsibilities of*
29 *the position for which the person has applied or is being*
30 *considered;*

31 (b) *The nature and severity of each criminal offense charged*
32 *against the person or committed by the person;*

6 *other person acting on behalf of the unincorporated town will*
7 *consider factors such as:*

8 (1) *The length of time that has passed since the offense;*

9 (2) *The age of the applicant at the time of the offense;*

10 (3) *The severity and nature of the offense;*

11 (4) *The relationship of the offense to the position for which*
12 *the applicant has applied; and*

13 (5) *Evidence of the rehabilitation of the applicant.*

14 7. *This section does not apply to any applicant for*
15 *employment:*

16 (a) *As a peace officer or firefighter; or*

17 (b) *In any position that entails physical access to a computer*
18 *or other equipment used for access to the Nevada Criminal Justice*
19 *Information System or the National Crime Information Center.*

37 (a) Fail or refuse to refer for employment, or otherwise to

41 (b) Classify or refer for employment any person on the basis of
42 the race, color, religion, sex, sexual orientation, gender identity or

1 (a) To exclude or to expel from its membership, or otherwise to
2 discriminate against, any person because of his or her race, color,
3 religion, sex, sexual orientation, gender identity or expression, age,
4 disability or national origin;

5 (b) To limit, segregate or classify its membership, or to classify
6 or fail or refuse to refer for employment any person, in any way
7 which would deprive or tend to deprive the person of employment
8 opportunities, or would limit the person's employment opportunities
9 or otherwise adversely affect the person's status as an employee or
10 as an applicant for employment, because of his or her race, color,
11 religion, sex, sexual orientation, gender identity or expression, age,
12 disability or national origin; or

13 (c) To cause or attempt to cause an employer to discriminate
14 against any person in violation of this section.

15 4. It is an unlawful employment practice for any employer,
16 labor organization or joint labor-management committee controlling
17 apprenticeship or other training or retraining, including, without
18 limitation, on-the-job training programs, to discriminate against any
19 person because of his or her race, color, religion, sex, sexual
20 orientation, gender identity or expression, age, disability or national
21 origin in admission to, or employment in, any program established
22 to provide apprenticeship or other training.

23 5. Except as otherwise provided in subsection 6, it is an
24 unlawful employment practice for any employer, employment
25 agency, labor organization or joint labor-management committee to
26 discriminate against a person with a disability by interfering,
27 directly or indirectly, with the use of an aid or appliance, including,
28 without limitation, a service animal, by such a person.

29 6. It is an unlawful employment practice for an employer,
30 directly or indirectly, to refuse to permit an employee with a
31 disability to keep the employee's service animal with him or her at
32 all times in his or her place of employment, except that an employer
33 may refuse to permit an employee to keep a service animal that is a
34 miniature horse with him or her if the employer determines that it is
35 not reasonable to comply, using the assessment factors set forth in
36 28 C.F.R. § 36.302.

37 7. *It is an unlawful employment practice for an appointing*
38 *authority governed by the provisions of chapter 284 of NRS, the*
39 *Administrator of the Division of Human Resource Management of*
40 *the Department of Administration or the governing body of a*
41 *county, incorporated city or unincorporated town to consider the*
42 *criminal history of an applicant for employment without following*
43 *the procedure required in section 2, 3, 5, 6 or 6.3 of this act, as*
44 *applicable.*

2 ascribed to it in NRS 426.097.

5 **1. Except as otherwise provided in subsection 2, any** person
6 injured by an unlawful employment practice within the scope of
7 NRS 613.310 to 613.435, inclusive, may file a complaint to that
8 effect with the Nevada Equal Rights Commission if the complaint is
9 based on discrimination because of race, color, sex, sexual
10 orientation, gender identity or expression, age, disability, religion or
11 national origin.

12 **2. Any person injured by an unlawful employment practice**
13 **within the scope of subsection 7 of NRS 613.330 may file a**
14 **complaint to that effect with the Nevada Equal Rights Commission**
15 **regardless of whether the complaint is based on discrimination**
16 **because of race, color, sex, sexual orientation, gender identity or**
17 **expression, age, disability, religion or national origin.**
