SUMMARY—Provides for collective bargaining by state employees. (BDR 23-1040)

AN ACT relating to state employees; authorizing collective bargaining for certain state employees; renaming and expanding the duties of the Local Government Employee-Management Relations Board; providing for bargaining units of state employees and their representatives; establishing procedures for collective bargaining and for making and amending collective bargaining agreements; prohibiting certain unfair labor practices; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Title 23 of NRS governs public employment. This bill authorizes collective
2 bargaining between the State and certain state employees. **Sections 25, 26 and 45**
3 of this bill expand the duties of the Local Government Employee-Management
4 Relations Board to include hearing and deciding disputes between the State and
5 certain state employees. **Section 44** of this bill changes the name of the Local
6 Government Employee-Management Relations Board to the Government
7 Employee-Management Relations Board to conform to this change in duties.
8 **Section 22** of this bill authorizes certain state employees to organize and join
9 employee organizations, or refrain from engaging in that activity, and, as
10 applicable, to engage in collective bargaining through exclusive representatives.
11 **Section 23** of this bill establishes requirements concerning collective bargaining
12 agreements. **Section 24** of this bill prohibits certain unfair labor practices in the
13 context of collective bargaining. **Section 27** of this bill provides for the creation
14 and organization of bargaining units of state employees. **Sections 28-31** of this bill
15 provide for the election or designation of exclusive representatives of bargaining
16 units. **Section 32** of this bill requires the exclusive representative of a bargaining
17 unit to engage in collective bargaining with the Executive Department of the State
18 Government on behalf of the employees within the unit. **Section 34** of this bill sets
19 forth the term of a collective bargaining agreement.

20 **Section 36** of this bill requires the Executive Department and an exclusive
21 representative of a bargaining unit to begin negotiations regarding a collective
22 bargaining agreement within 60 days after one party notifies the other of a desire to
23 negotiate or before November 1 of each even-numbered year, whichever is earlier.
24 **Sections 37-39** of this bill provide for the mediation and arbitration of disputes
25 between the Executive Department and a bargaining unit. **Section 40** of this bill
26 authorizes supplemental collective bargaining between the Executive Department
27 and the exclusive representative of a bargaining unit over any terms and conditions
28 of employment that do not affect all the employees of the bargaining unit. **Sections**
29 **42 and 46** of this bill provide that certain meetings convened for the purpose of
30 collective bargaining and resolving disputes relating to collective bargaining are
31 exempt from the provisions of existing law requiring open and public meetings of
32 public bodies. **Sections 5-13, 43 and 49** of this bill reorganize certain definitions in
33 chapter 288 of NRS to conform to changes made in this bill.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 281.129 is hereby amended to read as follows:
2 281.129 1. Any officer of the State, except the Legislative
3 Fiscal Officer, who disburses money in payment of salaries and
4 wages of officers and employees of the State:
5 (a) May, upon written requests of the officer or employee
6 specifying amounts, withhold those amounts and pay them to:
7 (1) Charitable organizations;
8 (2) Employee credit unions;
9 (3) Except as otherwise provided in paragraph (c), insurers;
10 (4) The United States for the purchase of savings bonds and
11 similar obligations of the United States; and
12 (5) ~~Employee~~ *Except as otherwise provided in section 33*
13 *of this act, employee* organizations and labor organizations.
14 (b) May, in accordance with an agreement entered into pursuant
15 to NRS 701A.450 between the Director of the Office of Energy and
16 the officer or employee specifying amounts, withhold those amounts
17 and pay them to the Director of the Office of Energy for credit to the
18 Renewable Energy Account created by NRS 701A.450.
19 (c) Shall, upon receipt of information from the Public
20 Employees' Benefits Program specifying amounts of premiums or
21 contributions for coverage by the Program, withhold those amounts
22 from the salaries or wages of officers and employees who
23 participate in the Program and pay those amounts to the Program.
24 2. The State Controller may adopt regulations necessary to
25 withhold money from the salaries or wages of officers and
26 employees of the Executive Department.
27 **Sec. 2.** NRS 284.013 is hereby amended to read as follows:
28 284.013 1. Except as otherwise provided in subsection 4, this
29 chapter does not apply to:



1 (a) Agencies, bureaus, commissions, officers or personnel in the
2 Legislative Department or the Judicial Department of State
3 Government, including the Commission on Judicial Discipline;

4 (b) Any person who is employed by a board, commission,
5 committee or council created in chapters 445C, 590, 623 to 625A,
6 inclusive, 628, 630 to 644, inclusive, 648, 652, 654 and 656 of NRS;
7 or

8 (c) Officers or employees of any agency of the Executive
9 Department of the State Government who are exempted by specific
10 statute.

11 2. Except as otherwise provided in subsection 3, the terms and
12 conditions of employment of all persons referred to in subsection 1,
13 including salaries not prescribed by law and leaves of absence,
14 including, without limitation, annual leave and sick and disability
15 leave, must be fixed by the appointing or employing authority
16 within the limits of legislative appropriations or authorizations.

17 3. Except as otherwise provided in this subsection, leaves of
18 absence prescribed pursuant to subsection 2 must not be of lesser
19 duration than those provided for other state officers and employees
20 pursuant to the provisions of this chapter. The provisions of this
21 subsection do not govern the Legislative Commission with respect
22 to the personnel of the Legislative Counsel Bureau.

23 4. Any board, commission, committee or council created in
24 chapters 445C, 590, 623 to 625A, inclusive, 628, 630 to 644,
25 inclusive, 648, 652, 654 and 656 of NRS which contracts for the
26 services of a person, shall require the contract for those services to
27 be in writing. The contract must be approved by the State Board of
28 Examiners before those services may be provided.

29 *5. To the extent that they are inconsistent or otherwise in*
30 *conflict, the provisions of this chapter do not apply to any terms*
31 *and conditions of employment that are properly within the scope*
32 *of and subject to the provisions of a collective bargaining*
33 *agreement or a supplemental bargaining agreement that is*
34 *enforceable pursuant to the provisions of sections 14 to 42,*
35 *inclusive, of this act.*

36 **Sec. 3.** NRS 287.015 is hereby amended to read as follows:

37 287.015 1. A local government employer and any employee
38 organization that is recognized by the employer pursuant to chapter
39 288 of NRS may, by written agreement between themselves or with
40 other local government employers and employee organizations,
41 establish a trust fund to provide health and welfare benefits to active
42 and retired employees of the participating employers and the
43 dependents of those employees.

44 2. All contributions made to a trust fund established pursuant
45 to this section must be held in trust and used:



1 (a) To provide, from principal or income, or both, for the benefit
2 of the participating employees and their dependents, medical,
3 hospital, dental, vision, death, disability or accident benefits, or any
4 combination thereof, and any other benefit appropriate for an entity
5 that qualifies as a voluntary employees' beneficiary association
6 under Section 501(c)(9) of the Internal Revenue Code of 1986, 26
7 U.S.C. § 501(c)(9), as amended; and

8 (b) To pay any reasonable administrative expenses incident to
9 the provision of these benefits and the administration of the trust.

10 3. The basis on which contributions are to be made to the trust
11 must be specified in a collective bargaining agreement between each
12 participating local government employer and employee organization
13 or in a written participation agreement between the employer and
14 employee organization, jointly, and the trust.

15 4. The trust must be administered by a board of trustees on
16 which participating local government employers and employee
17 organizations are equally represented. The agreement that
18 establishes the trust must:

19 (a) Set forth the powers and duties of the board of trustees,
20 which must not be inconsistent with the provisions of this section;

21 (b) Establish a procedure for resolving expeditiously any
22 deadlock that arises among the members of the board of trustees;
23 and

24 (c) Provide for an audit of the trust, at least annually, the results
25 of which must be reported to each participating employer and
26 employee organization.

27 5. The provisions of paragraphs (b) and (c) of subsection 2 of
28 NRS 287.029 apply to a trust fund established pursuant to this
29 section by the governing body of a school district.

30 6. The provisions of NRS 287.0278 do not apply to a trust fund
31 established pursuant to this section before October 1, 2013.

32 7. As used in this section:

33 (a) "Employee organization" has the meaning ascribed to it in
34 ~~NRS 288.040.~~ *section 9 of this act.*

35 (b) "Local government employer" has the meaning ascribed to it
36 in NRS 288.060.

37 **Sec. 4.** Chapter 288 of NRS is hereby amended by adding
38 thereto the provisions set forth as sections 5 to 42, inclusive, of this
39 act.

40 **Sec. 5.** *As used in this chapter, unless the context otherwise*
41 *requires, the words and terms defined in NRS 288.050 and*
42 *288.060 and sections 6 to 13, inclusive, of this act have the*
43 *meanings ascribed to them in those sections.*

44 **Sec. 6.** *"Board" means the Government Employee-*
45 *Management Relations Board created by NRS 288.080.*



1 **Sec. 7.** *“Collective bargaining” means a method of*
2 *determining conditions of employment by negotiation between*
3 *representatives of the Executive Department or local government*
4 *employer and an employee organization, entailing a mutual*
5 *obligation of the Executive Department or local government*
6 *employer, as applicable, and the representative of the state or local*
7 *government employees to meet at reasonable times and bargain in*
8 *good faith with respect to:*

9 1. *Wages, hours and other terms and conditions of*
10 *employment;*

11 2. *The negotiation of an agreement;*

12 3. *The resolution of any question arising under a negotiated*
13 *agreement; or*

14 4. *The execution of a written contract incorporating any*
15 *agreement reached if requested by either party,*

16 ↳ *but this obligation does not compel either party to agree to a*
17 *proposal or require the making of a concession.*

18 **Sec. 8.** *“Commissioner” means the Commissioner appointed*
19 *by the Board pursuant to NRS 288.090.*

20 **Sec. 9.** *“Employee organization” means an organization of*
21 *any kind having as one of its purposes improvement of the terms*
22 *and conditions of employment of state or local government*
23 *employees.*

24 **Sec. 10.** *“Executive Department” means an agency, board,*
25 *bureau, commission, department, division, elected officer or any*
26 *other unit of the Executive Department of the State Government.*

27 **Sec. 11.** *“Fact-finding” means the formal procedure by*
28 *which an investigation of a labor dispute is conducted by a person*
29 *at which:*

30 1. *Evidence is presented; and*

31 2. *A written report is issued by the fact finder describing the*
32 *issues involved and setting forth recommendations for settlement*
33 *which may or may not be binding as provided in NRS 288.200.*

34 **Sec. 12.** *“Mediation” means assistance by an impartial third*
35 *party to reconcile differences between the Executive Department*
36 *or a local government employer and an exclusive representative*
37 *through interpretation, suggestion and advice.*

38 **Sec. 13.** *“Strike” means any concerted:*

39 1. *Stoppage of work, slowdown or interruption of operations*
40 *by employees of the State of Nevada or local government*
41 *employees;*

42 2. *Absence from work by employees of the State of Nevada or*
43 *local government employees upon any pretext or excuse, such as*
44 *illness, which is not founded in fact; or*



1 3. *Interruption of the operations of the State of Nevada or*
2 *any local government employer by any employee organization.*

3 **Sec. 14.** *As used in sections 14 to 42, inclusive, of this act,*
4 *unless the context otherwise requires, the words and terms defined*
5 *in sections 15 to 20, inclusive, of this act have the meanings*
6 *ascribed to them in those sections.*

7 **Sec. 15.** *“Arbitration” means a process of dispute resolution*
8 *where the parties involved in an impasse or grievance dispute*
9 *submit their dispute to a third party for a final and binding*
10 *decision.*

11 **Sec. 16.** *“Bargaining unit” means a collection of employees*
12 *that the Board has established as a bargaining unit pursuant to*
13 *section 27 of this act.*

14 **Sec. 17.** *“Confidential employee” means an employee who*
15 *provides administrative support to an employee who assists in the*
16 *formulation, determination and effectuation of personnel policies*
17 *or managerial policies concerning collective bargaining or*
18 *supplemental bargaining.*

19 **Sec. 18.** 1. *“Employee” means a person who:*

20 (a) *Is employed in the classified service of the State pursuant*
21 *to chapter 284 of NRS; or*

22 (b) *Is employed by the Public Employees’ Retirement System*
23 *and is required to be paid in accordance with the pay plan for the*
24 *classified service of the State.*

25 2. *The term does not include:*

26 (a) *A managerial employee whose primary function, as*
27 *determined by the Board, is to administer and control the business*
28 *of any agency, board, bureau, commission, department, division,*
29 *elected officer or any other unit of the Executive Department and*
30 *who is vested with discretion and independent judgment with*
31 *regard to the general conduct and control of that agency, board,*
32 *bureau, commission, department, division, elected officer or unit;*

33 (b) *An elected official or any person appointed to fill a vacancy*
34 *in an elected office;*

35 (c) *A confidential employee;*

36 (d) *A temporary employee who is employed for a fixed period*
37 *of 4 months or less;*

38 (e) *A commissioned officer or an enlisted member of the*
39 *Nevada National Guard; or*

40 (f) *Any person employed by the Nevada System of Higher*
41 *Education.*

42 **Sec. 19.** *“Exclusive representative” means an employee*
43 *organization that, as a result of its designation by the Board, has*
44 *the exclusive right to represent all the employees within a*
45 *bargaining unit and to engage in collective bargaining with the*



1 *Executive Department pursuant to sections 14 to 42, inclusive, of*
2 *this act concerning wages, hours and other terms and conditions*
3 *of employment for those employees.*

4 **Sec. 20.** *“Grievance” means an act, omission or occurrence*
5 *that an employee or an exclusive representative believes to be an*
6 *injustice relating to any condition arising out of the relationship*
7 *between an employer and an employee, including, without*
8 *limitation, working hours, working conditions, membership in an*
9 *organization of employees or the interpretation of any law,*
10 *regulation or agreement.*

11 **Sec. 21.** *1. The Legislature hereby finds and declares that*
12 *there is a great need to:*

13 *(a) Promote orderly and constructive relations between the*
14 *State and its employees; and*

15 *(b) Increase the efficiency of the State Government.*

16 *2. It is therefore within the public interest that the Legislature*
17 *enact provisions:*

18 *(a) Granting certain state employees the right to associate with*
19 *others in organizing and choosing representatives for the purpose*
20 *of engaging in collective bargaining;*

21 *(b) Requiring the State to recognize and negotiate wages,*
22 *hours and other terms and conditions of employment with*
23 *employee organizations that represent state employees and to enter*
24 *into written agreements evidencing the result of collective*
25 *bargaining; and*

26 *(c) Establishing standards and procedures that protect the*
27 *rights of state employees, the Executive Department and the*
28 *people of the State.*

29 **Sec. 22.** *1. For the purposes of collective bargaining,*
30 *supplemental bargaining and other mutual aid or protection,*
31 *employees have the right to:*

32 *(a) Organize, form, join and assist employee organizations,*
33 *engage in collective bargaining and supplemental bargaining*
34 *through exclusive representatives and engage in other concerted*
35 *activities; and*

36 *(b) Refrain from engaging in such activity.*

37 *2. Collective bargaining and supplemental bargaining entail*
38 *a mutual obligation of the Executive Department and an exclusive*
39 *representative to meet at reasonable times and to bargain in good*
40 *faith with respect to:*

41 *(a) Wages, hours and other terms and conditions of*
42 *employment;*

43 *(b) The negotiation of an agreement;*

44 *(c) The resolution of any question arising under an*
45 *agreement; and*



1 (d) *The execution of a written contract incorporating the*
2 *provisions of an agreement, if requested by either party.*

3 3. *The Executive Department shall furnish to an exclusive*
4 *representative data that is maintained in the ordinary course of*
5 *business and which is relevant and necessary to the discussion of*
6 *wages, hours and other terms and conditions of employment. This*
7 *subsection shall not be construed to require the Executive*
8 *Department to furnish to the exclusive representative any advice*
9 *or training received by representatives of the Executive*
10 *Department concerning collective bargaining.*

11 **Sec. 23.** 1. *Each collective bargaining agreement must be*
12 *in writing and must include, without limitation:*

13 (a) *A procedure to resolve grievances which applies to all*
14 *employees in the bargaining unit and culminates in final and*
15 *binding arbitration. The procedure must be used to resolve all*
16 *grievances relating to employment, including, without limitation,*
17 *the administration and interpretation of the collective bargaining*
18 *agreement, the applicability of any law, rule or regulation relating*
19 *to the employment and appeal of discipline and other adverse*
20 *personnel actions.*

21 (b) *A provision which provides that an officer of the Executive*
22 *Department may, upon written authorization by an employee*
23 *within the bargaining unit, withhold a sufficient amount of money*
24 *from the salary or wages of the employee pursuant to NRS*
25 *281.129 to pay dues or similar fees to the exclusive representative*
26 *of the bargaining unit. Such authorization may be revoked only in*
27 *the manner prescribed in the authorization.*

28 2. *Except as otherwise provided in subsection 3, the*
29 *procedure to resolve grievances required in a collective bargaining*
30 *agreement pursuant to paragraph (a) of subsection 1 is the*
31 *exclusive means available for resolving grievances described in*
32 *that paragraph.*

33 3. *An employee in a bargaining unit who has been dismissed,*
34 *demoted or suspended may pursue a grievance related to that*
35 *dismissal, demotion or suspension through:*

36 (a) *The procedure provided in the agreement pursuant to*
37 *paragraph (a) of subsection 1; or*

38 (b) *The procedure prescribed by NRS 284.390,*
39 *↳ but, once the employee has properly filed a grievance in writing*
40 *under the procedure described in paragraph (a) or requested a*
41 *hearing under the procedure described in paragraph (b), the*
42 *employee may not proceed in the alternative manner.*

43 4. *If there is a conflict between any provision of an*
44 *agreement between the Executive Department and an exclusive*
45 *representative and:*



1 (a) Any regulation adopted by the Executive Department, the
2 provision of the agreement prevails unless the provision of the
3 agreement is outside of the lawful scope of collective bargaining.

4 (b) An existing statute, other than a statute described in
5 paragraph (c), the provision of the agreement may not be given
6 effect unless the Legislature amends the existing statute in such a
7 way as to eliminate the conflict.

8 (c) A provision of chapter 284 or 287 of NRS or section 37, 38
9 or 39 of this act, the provision of the agreement prevails unless the
10 Legislature is required to appropriate money to implement the
11 provision.

12 **Sec. 24. 1. It is a prohibited practice for the Executive**
13 **Department or its designated representative willfully to:**

14 (a) Refuse to engage in collective bargaining or otherwise fail
15 to bargain in good faith with an exclusive representative,
16 including, without limitation, refusing to engage in mediation or
17 arbitration.

18 (b) Interfere with, restrain or coerce an employee in the
19 exercise of any right guaranteed pursuant to sections 14 to 42,
20 inclusive, of this act.

21 (c) Dominate, interfere with or assist in the formation or
22 administration of an employee organization.

23 (d) Discriminate in regard to hiring, tenure, wages, hours or
24 other terms and conditions of employment to encourage or
25 discourage membership in an employee organization.

26 (e) Discharge or otherwise discriminate against an employee
27 because the employee has:

28 (1) Signed or filed an affidavit, petition or complaint or has
29 provided any information or given any testimony pursuant to
30 sections 14 to 42, inclusive, of this act; or

31 (2) Formed, joined or chosen to be represented by an
32 employee organization.

33 (f) Deny any right accompanying a designation as an exclusive
34 representative.

35 2. It is a prohibited practice for an employee organization or
36 its designated agent willfully to:

37 (a) When acting as an exclusive representative, refuse to
38 engage in collective bargaining or otherwise fail to bargain in
39 good faith with the Executive Department, including, without
40 limitation, refusing to engage in mediation or arbitration.

41 (b) Interfere with, restrain or coerce an employee in the
42 exercise of any right guaranteed pursuant to sections 14 to 42,
43 inclusive, of this act.



1 (c) *Discriminate because of race, color, religion, sex, sexual*
2 *orientation, gender identity or expression, age, disability, national*
3 *origin, or political or personal reasons or affiliations.*

4 **Sec. 25. 1.** *To establish that a party committed a prohibited*
5 *practice in violation of section 24 of this act, the party aggrieved*
6 *by the practice must:*

7 (a) *File a complaint with the Board not later than 6 months*
8 *after the alleged prohibited practice occurred; and*

9 (b) *Send a copy of the complaint to the other party by certified*
10 *mail, return receipt requested, or by any other method authorized*
11 *by the Board.*

12 2. *Not later than 10 days after receiving a copy of a complaint*
13 *pursuant to paragraph (b) of subsection 1, each party named as a*
14 *respondent in the complaint shall file a response to the complaint*
15 *with the Board.*

16 3. *The Board shall conduct a preliminary investigation of the*
17 *complaint. Based on its investigation:*

18 (a) *If the Board determines that the complaint has no basis in*
19 *law or fact, the Board shall dismiss the complaint.*

20 (b) *If the Board determines that the complaint may have a*
21 *basis in law or fact, the Board shall order a hearing to be*
22 *conducted in accordance with:*

23 (1) *The provisions of chapter 233B of NRS that apply to a*
24 *contested case; and*

25 (2) *Any rules adopted by the Board pursuant to*
26 *NRS 288.110.*

27 4. *If the Board finds at the hearing that the party accused in*
28 *the complaint has committed a prohibited practice, the Board:*

29 (a) *Shall order the party to cease and desist from engaging in*
30 *the prohibited practice; and*

31 (b) *May order any other affirmative relief that is necessary to*
32 *remedy the prohibited practice.*

33 5. *The Board or any party aggrieved by the failure of any*
34 *person to obey an order of the Board issued pursuant to*
35 *subsection 4 may apply to a court of competent jurisdiction for a*
36 *prohibitory or mandatory injunction to enforce the order.*

37 6. *Any order or decision issued by the Board pursuant to this*
38 *section concerning the merits of a complaint is a final decision in*
39 *a contested case and may be appealed pursuant to the provisions*
40 *of chapter 233B of NRS that apply to a contested case, except that*
41 *a party aggrieved by the order or decision of the Board must file a*
42 *petition for judicial review not later than 10 days after being*
43 *served with the order or decision of the Board.*



1 **Sec. 26. 1. The Board may appoint a hearing officer to**
2 **conduct a hearing that the Board is otherwise required to conduct**
3 **pursuant to section 25 of this act.**

4 **2. A decision of the hearing officer may be appealed to the**
5 **Board.**

6 **3. On appeal to the Board, the Board may consider the record**
7 **of the hearing or may conduct a hearing de novo. A hearing de**
8 **novo conducted by the Board must be conducted in accordance**
9 **with:**

10 **(a) The provisions of chapter 233B of NRS that apply to a**
11 **contested case; and**

12 **(b) Any rules adopted by the Board pursuant to NRS 288.110.**

13 **4. If the Board finds at the hearing that the party accused in**
14 **the complaint has committed a prohibited practice, the Board:**

15 **(a) Shall order the party to cease and desist from engaging in**
16 **the prohibited practice; and**

17 **(b) May order any other affirmative relief that is necessary to**
18 **remedy the prohibited practice.**

19 **5. The Board or any party aggrieved by the failure of any**
20 **person to obey an order of the Board issued pursuant to**
21 **subsection 4 may apply to a court of competent jurisdiction for a**
22 **prohibitory or mandatory injunction to enforce the order.**

23 **6. Any order or decision issued by the Board pursuant to this**
24 **section concerning the merits of a complaint is a final decision in**
25 **a contested case and may be appealed pursuant to the provisions**
26 **of chapter 233B of NRS that apply to a contested case, except that**
27 **a party aggrieved by the order or decision of the Board must file a**
28 **petition for judicial review not later than 10 days after being**
29 **served with the order or decision of the Board.**

30 **Sec. 27. 1. The Board shall establish one bargaining unit**
31 **for each of the following occupational groups:**

32 **(a) Labor, maintenance, custodial and institutional employees,**
33 **including, without limitation, employees of penal and correctional**
34 **institutions who are not responsible for security at those**
35 **institutions.**

36 **(b) Administrative and clerical employees, including, without**
37 **limitation, legal support staff and employees whose work involves**
38 **general office work, or keeping or examining records and**
39 **accounts.**

40 **(c) Technical aides to professional employees, including,**
41 **without limitation, computer programmers, tax examiners,**
42 **conservation employees and crew supervisors.**

13 *based upon the similarity of the new classification to other*
14 *classifications within the bargaining unit. If the parties to a*
15 *collective bargaining agreement do not agree to the assignment of*
16 *a new classification to a bargaining unit or an affected employee*
17 *or employee organization objects to such an assignment, the*

28 (d) *“Professional employee” means an employee engaged in*

30 (1) *Is predominately intellectual and varied in character as*

32 (2) *Involves the consistent exercise of discretion and*
33 *judgment in its performance;*

34 (3) *Is of such a character that the result accomplished or*
35 *produced cannot be standardized in relation to a given period; and*
