AN ACT relating to public records; adding prosecutors to a list of persons who may request that certain personal information contained in the records of the county assessor be kept confidential; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Under existing law, justices, judges and peace officers, and the spouses and  
2 minor children of such persons, may request that personal information contained in  
3 the records of the county assessor be kept confidential. (NRS 250.140) This bill  
4 adds prosecutors and the spouses and minor children of prosecutors to the list of  
5 persons who may request that their personal information contained in the records of  
6 a county assessor be kept confidential.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 250.140 is hereby amended to read as follows:  
2 250.140 1. The following persons may request that personal  
3 information contained in the records of a county assessor be kept  
4 confidential:  
5 (a) Any justice or judge in this State.  
6 (b) Any peace officer or retired peace officer.  
7 (c) *Any prosecutor.*



1 (d) The spouse or minor child of a person described in  
2 paragraph (a) ~~for (b).~~  
3 ~~(d)~~, (b) or (c).

4 (e) The surviving spouse or minor child of a person described in  
5 paragraph (a), ~~for~~ (b) or (c) who was killed in the performance of  
6 his or her duties.

7 2. As used in this section ~~;~~ ~~“peace”~~:

8 (a) “Peace officer” means:

9 ~~(a)~~ (1) Any person upon whom some or all of the powers of a  
10 peace officer are conferred pursuant to NRS 289.150 to 289.360,  
11 inclusive; and

12 ~~(b)~~ (2) Any person:

13 ~~(1)~~ (I) Who resides in this State;

14 ~~(2)~~ (II) Whose primary duties are to enforce the law; and

15 ~~(3)~~ (III) Who is employed by a law enforcement agency of  
16 the Federal Government, including, without limitation, a ranger for  
17 the National Park Service and an agent employed by the Federal  
18 Bureau of Investigation, Secret Service, United States Department  
19 of Homeland Security or United States Department of the Treasury.

20 (b) “Prosecutor” has the meaning ascribed to it in  
21 NRS 241A.030.

22 Sec. 2. This act becomes effective on July 1, 2017.
