INTRODUCTION, FIRST READING AND REFERENCE

By Assemblywoman Titus:

Assembly Bill No. 114—AN ACT relating to irrigation districts; increasing the maximum amount of indebtedness that the board of directors of an irrigation district may incur and the amount of certain annual assessments that may be levied on lands in the district; requiring an annual adjustment of those amounts; and providing other matters properly relating thereto.

Assemblywoman Titus moved that the bill be referred to the Committee on Natural Resources, Agriculture, and Mining.

Motion carried.

By Assemblywoman Titus:

Assembly Bill No. 115—AN ACT relating to providers of health care; authorizing a physician assistant or advanced practice registered nurse to perform certain services; and providing other matters properly relating thereto.

Assemblywoman Titus moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.

By Assemblywoman Titus:

Assembly Bill No. 116—AN ACT relating to nursing; authorizing a qualified advanced practice registered nurse to sign, certify, stamp, verify or endorse certain documents requiring the signature, certification, stamp, verification or endorsement of a physician; authorizing an advanced practice registered nurse to make certain certifications, diagnoses and determinations required to be made by a physician or other provider of health care; providing penalties; and providing other matters properly relating thereto.

Assemblywoman Titus moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By Assemblyman Flores:

Assembly Bill No. 117—AN ACT relating to education; requiring certain educational personnel to offer to meet with each pupil enrolled in grade 11 to review the academic plan of the pupil and review the pupil's academic strengths and weaknesses; requiring the academic plan of a pupil to be revised under certain circumstances; and providing other matters properly relating thereto.

Assemblyman Flores moved that the bill be referred to the Committee on Education.

Motion carried.

By Assemblyman Daly:

Assembly Bill No. 118—AN ACT relating to concealed firearms; authorizing certain persons who are at least 18 years of age but less than 21 years of age to be eligible for a permit to carry a concealed firearm; and providing other matters properly relating thereto.

Assemblyman Daly moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Assemblyman Marchant:

Assembly Bill No. 119—AN ACT relating to garnishment; prioritizing claims for spousal and child support in satisfying multiple writs of garnishment; and providing other matters properly relating thereto.

Assemblyman Marchant moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Assemblyman Daly:

Assembly Bill No. 120—AN ACT relating to school construction; revising provisions governing the imposition of a residential construction tax; revising provisions relating to the purchase of certain property for school construction; and providing other matters properly relating thereto.

Assemblyman Daly moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

By Assemblyman Yeager:

Assembly Bill No. 121—AN ACT relating to collective bargaining; prohibiting a local government employer from unilaterally implementing certain changes in terms and conditions of employment for a specified period after the end of the term or expiration of a collective bargaining agreement; requiring the employer, during that period, to continue to pay compensation and monetary benefits as provided in the agreement; generally providing that any increase in compensation and monetary benefits provided for in a successor agreement is effective retroactively to the end of the most recent term or expiration date of the last agreement; making mandatory the provision of certain leave to employees; and providing other matters properly relating thereto.

Assemblyman Yeager moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

By Assemblywoman Benitez-Thompson:

Assembly Bill No. 122—AN ACT relating to victims of crime; removing the prohibition on awarding compensation to certain victims of crime who do not meet certain citizenship or residency requirements; and providing other matters properly relating thereto.

Assemblywoman Benitez-Thompson moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Assemblyman Ellison:

Assembly Bill No. 123—AN ACT relating to business organizations; revising provisions governing the powers of a limited-liability company that has created a series of members' interests with separate rights, powers or duties; and providing other matters properly relating thereto.

Assemblyman Ellison moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Assemblywoman Diaz:

Assembly Bill No. 124—AN ACT relating to education; requiring the Department of Education to establish a code of conduct governing interpersonal interactions and certain communications by teachers, administrators and other employees with pupils; and providing other matters properly relating thereto.

Assemblywoman Diaz moved that the bill be referred to the Committee on Education.

Motion carried.

By Assemblywoman Diaz:

Assembly Bill No. 125—AN ACT relating to interpreters; replacing the term "person with a language barrier" with "person with limited English proficiency"; removing provisions relating to alternate court interpreters; making various other changes to provisions relating to court interpreters; and providing other matters properly relating thereto.

Assemblywoman Diaz moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By the Committee on Health and Human Services:

Assembly Bill No. 126—AN ACT relating to governmental administration; abolishing the Commission to Review the Compensation of Constitutional Officers, Legislators, Supreme Court Justices, Judges of the Court of Appeals, District Judges and Elected County Officers; abolishing the Advisory Committee on Housing; abolishing the Subcommittee on Personal Assistance for Persons with Severe Functional Disabilities of the

Nevada Commission on Services for Persons with Disabilities; and providing other matters properly relating thereto.

Assemblyman Sprinkle moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

By Assemblywoman Benitez-Thompson:

Assembly Bill No. 127—AN ACT relating to education; requiring school districts in certain counties to appoint an emergency manager; requiring boards of trustees of school districts and governing bodies of charter schools to consult with certain persons and entities before constructing, expanding or remodeling buildings for schools or related facilities or acquiring sites for those purposes; requiring the Department of Education to conduct an annual conference regarding safety in public schools; requiring the Department, to the extent that money is available, to make block grants to provide certain mental health workers in public schools; revising provisions governing the development and contents of a plan to respond to a crisis or an emergency in a school; revising provisions governing emergency drills in schools; and providing other matters properly relating thereto.

Assemblywoman Benitez-Thompson moved that the bill be referred to the Committee on Education.

Motion carried.

By Assemblywoman Spiegel:

Assembly Bill No. 128—AN ACT relating to service of process; exempting certain unpaid individuals from the requirement to obtain licensure as a process server; and providing other matters properly relating thereto.

Assemblywoman Spiegel moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By Assemblywoman Tolles:

Assembly Bill No. 129—AN ACT relating to health care; revising provisions concerning the prescribing and fitting of ophthalmic lenses or contact lenses; providing that the use of certain automated testing devices constitutes the practice of optometry; and providing other matters properly relating thereto.

Assemblywoman Tolles moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.
