## INTRODUCTION, FIRST READING AND REFERENCE

Assembly Bill No. 274—AN ACT relating to elections; enacting the Agreement Among the States to Elect the President by National Popular Vote; and providing other matters properly relating thereto.

Assemblyman Araujo moved that the bill be referred to the Committee on Legislative Operations and Elections.

Assembly Bill No. 275—AN ACT relating to education; requiring the Department of Education to establish a protocol for providing integrated student supports for pupils enrolled in public schools and the families of such pupils; requiring the board of trustees of each school district and the governing body of each charter school to take certain action to provide academic and nonacademic supports for pupils enrolled in the school district

or charter school and the families of such pupils; and providing other matters properly relating thereto.
