INTRODUCTION, FIRST READING AND REFERENCE

By Senator Segerblom:

Senate Bill No. 107—AN ACT relating to education; requiring the Council to Establish Academic Standards for Public Schools to establish standards of content and performance for ethnic and diversity studies in high school; requiring a pupil to pass a course in ethnic and diversity studies to receive a high school diploma; revising provisions governing the standards of content and performance for social studies; and providing other matters properly relating thereto.

Senator Segerblom moved that the bill be referred to the Committee on Education.

Motion carried.

By the Committee on Education:

Senate Bill No. 108—AN ACT relating to education; requiring the instruction given in American government to pupils in public high schools to include certain instruction in criminal law; and providing other matters properly relating thereto.

Senator Denis moved that the bill be referred to the Committee on Education.

Motion carried.

By Senator Harris:

Senate Bill No. 109—AN ACT relating to crimes; prohibiting any person from requiring another person to undergo implantation of a microchip or other permanent identification marker; providing a penalty; and providing other matters properly relating thereto.

Senator Harris moved that the bill be referred to the Committee on Judiciary.

Motion carried.

By Senators Parks, Woodhouse, Ford, Atkinson, Ratti, Denis, Manendo, Segerblom, Spearman; Assemblymen Carlton, Araujo, Frierson, Carrillo, Spiegel, Sprinkle and Swank:

Senate Bill No. 110—AN ACT relating to civil actions; exempting from the publication requirement a court-ordered change of name if the reason for the change is to conform the person's name to his or her gender identity; and providing other matters properly relating thereto.

Senator Parks moved that the bill be referred to the Committee on Judiciary.

Motion carried.
