I am herewith forwarding to you, for filing within the constitutional time limit and without my approval, Senate Bill No. 99 (of the 78th Session), which is entitled:

AN ACT relating to crimes; revising provisions governing the lifetime supervision of certain sex offenders; revising provisions governing registration and community notification of sex offenders and offenders convicted of crimes against a child; revising provisions governing registration and community notification of juveniles adjudicated delinquent for committing certain sexual offenses; revising provisions governing certain restrictions on certain sex offenders placed on probation, parole or lifetime supervision; and providing other matters properly relating thereto.

Tier III sex offenders are the most dangerous sexual predators. They are offenders who have been convicted of first-degree murder, sexual assault, kidnapping, battery, lewdness and other

serious crimes against children and adults. Senate Bill No. 99 (of the 78th Session) removes the prohibition in current Nevada law that Tier III sex offenders cannot be within 500 feet of a school, playground, park, daycare, movie theater, athletic field or other places primarily designated for use by children. Senate Bill No. 99 (of the 78th Session) allows sex offenders who have committed the most heinous sexually-motivated crimes to have greater access to places where children frequent in Nevada. It places our children at greater risk of harm.

While Senate Bill No. 99 (of the 78th Session) proposes amendments to the Adam Walsh Act which have merit, the removal of this important prohibition undermines confidence that this legislation will ensure greater protection of Nevada's children. Therefore, I veto this bill and return it without my signature or approval.

AN ACT relating to motor carriers; revising the declaration of legislative purpose and policy governing the regulation of certain motor carriers; revising the criteria for granting or modifying certificates of public convenience and necessity for certain motor carriers; revising provisions governing participation as an intervener in a hearing on an application for such a certificate; revising provisions governing the filing of an application for a certificate of public convenience and necessity by a person whose previous application has been denied; and providing other matters properly relating thereto.

Senate Bill No. 183 (of the 78th Session) seeks to eliminate procedures and policies in Nevada law that govern the Nevada Transportation Authority's ability to oversee and ensure that a motor carrier operator always transports members of the public safely. The Nevada Transportation Authority's ability to consider the economic viability of a motor carrier operator is an important factor in evaluating whether that operator has the necessary resources to transport members of the public safely and can maintain industry safety standards. Therefore, I veto this bill and return it without my signature or approval.

Senate Bill No. 238 (of the 78th Session) forces the residents of the City of Ely to consider an advisory question regarding whether or not to combine the governments of the City of Ely and

White Pine County. Nevada law already sets forth a process for the residents of the City of Ely to place an advisory question about their future on the ballot during a general city election, if they choose to do so. Senate Bill No. 238 (of the 78th Session) circumvents this process. Therefore, I veto this bill and return it without my signature or approval.

RESOLVED BY THE SENATE AND ASSEMBLY OF THE STATE OF NEVADA, JOINTLY, That a new section, designated Section 1A, be added to Article 2 of the Nevada Constitution to read as follows:

Sec. 1A. Each voter has the right:

- 1. To receive and cast a ballot that:
 - (a) Is written in a format that allows the clear identification of candidates; and*
 - (b) Accurately records the voter's preference in the selection of candidates.**
- 2. To have questions concerning voting procedures answered and to have an explanation of the procedures for voting posted in a conspicuous place at the polling place.*
- 3. To vote without being intimidated, threatened or coerced.*
- 4. To vote on election day if the voter is waiting in line at his or her polling place to vote at the time that the polls close and the voter has not already cast a vote in that election.*
- 5. To return a spoiled ballot and receive another ballot in its place.*
- 6. To request assistance in voting, if necessary.*
- 7. To a sample ballot which is accurate, informative and delivered in a timely manner.*
- 8. To receive instruction in the use of the equipment for voting during any period for early voting or on election day.*
- 9. To equal access to the elections system without discrimination, including, without limitation, discrimination on the basis of race, age, disability, employment or overseas residence.*
- 10. To a uniform, statewide standard for counting and recounting all votes accurately.*
- 11. To have complaints about elections and election contests resolved fairly, accurately and efficiently.*

Amendment No. 1.

SUMMARY—Revises provision governing the authorization of certain days of observance. (BDR 19-115)

AN ACT relating to days of observance; authorizing and requesting the Governor to proclaim "Indigenous Peoples Day" as a day of observance; repealing the authorization for "Columbus Day"; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Existing law sets forth certain days of observance in this State to commemorate persons and occasions or to publicize information regarding important topics. (NRS 236.018-236.085) Section 1 of this bill authorizes and requests the Governor annually to issue a proclamation designating the second Monday in October as "Indigenous Peoples Day" in the State of Nevada. Section 2 of this bill repeals the authorization for the Governor to issue a proclamation designating the second Monday in October as "Columbus Day."

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Section 1. Chapter 236 of NRS is hereby amended by adding thereto a new section to read as follows:

The Governor ~~may~~ is authorized and requested to annually proclaim the second Monday in October as "Indigenous Peoples Day" to celebrate the thriving culture and significant value that Indigenous people add to the State of Nevada and the United States of America.

Sec. 2. NRS 236.025 is hereby repealed.

Sec. 3. This act becomes effective upon passage and approval.

TEXT OF REPEALED SECTION

236.025 Columbus Day. The Governor of this State is authorized and requested to issue annually a proclamation designating the second Monday in October as "Columbus Day" in commemoration of the arrival of Cristoforo Columbo in the New World.
