INTRODUCTION, FIRST READING AND REFERENCE

By Senator Hammond:

Senate Bill No. 234—AN ACT relating to unmanned aerial vehicles; authorizing the seizure and storage of certain unmanned aerial vehicles; authorizing the examination of recordings or data contained in an unmanned aerial vehicle under certain conditions; providing for the licensing and regulation of unmanned aerial vehicle storage facilities; providing a penalty; and providing other matters properly relating thereto.

Senate Bill No. 235—AN ACT relating to trade practices; making certain sales of tickets a deceptive trade practice; regulating the manner in which tickets to an athletic contest or live entertainment event may be sold in certain circumstances; requiring certain disclosures to be made by resellers and ticket brokers; prohibiting the use of an Internet robot for certain purposes relating to ticket sales; providing a penalty; and providing other matters properly relating thereto.

REMARKS FROM THE FLOOR

Senator Ratti requested that her remarks be entered in the Journal.

I would like to make sure everyone is aware we have a Nevada Radon Education Program. It is a grant program funded by the U.S. Environmental Protection Agency State Indoor Radon Grant through the Nevada Division of Public and Behavioral Health. The mission of this

program is to educate Nevadans about the health risk of radon, how to test for the gas and reduce radon exposure in homes. The outreach includes an annual radon poster contest, presentations throughout the State, a radon hotline, social media and offering free or low-cost radon test kits.

Radon is a colorless, odorless, tasteless radioactive gas that naturally comes from the decay of uranium and easily enters homes. Living in a home with an elevated level of radon can increase a person's risk of developing lung cancer. I was privileged to sit on the Washoe County Board of Health where we learned some alarming statistics. One in four homes tested in Nevada has elevated radon levels, and one in five homes tested in Washoe County showed elevated levels. It is important that you test your home. I have done it, and it is very easy. You pick up the kit, leave it in place long enough and it tells you if you have a risk and how to mitigate it. I recommend everyone do this.
