INTRODUCTION, FIRST READING AND REFERENCE

By the Committee on Health and Human Services:

Senate Bill No. 266—AN ACT relating to health care; providing for the certification and regulation of providers of community-based living arrangement services; making similar changes relating to providers of supported living arrangement services; revising certain definitions; and providing other matters properly relating thereto.

Senator Spearman moved that the bill be referred to the Committee on Health and Human Services.

Senate Bill No. 267—AN ACT relating to real property; providing for the continuation of certain provisions relating to an expedited process for the foreclosure of abandoned residential property; and providing other matters properly relating thereto.

By the Committee on Judiciary:

Senate Bill No. 268—AN ACT relating to corrections; requiring the Director of the Department of Corrections to verify the full legal name and age of an offender who is to be released by obtaining certain documents before providing a photo identification card to the offender; requiring a sheriff, chief of police, town marshal or director of a facility for the detention of children, upon request, to provide a photo identification card to a person who is to be released from a jail or detention facility; revising provisions governing the allowance of credits to a prisoner of a local detention facility who successfully completes a program of education or a program of treatment for alcohol or drug abuse; revising the documents which may be furnished to the Department of Motor Vehicles as proof of the full legal name and age of the offender to apply for a driver's license or identification card; providing for the waiver of certain fees relating to driver's licenses and identification cards for certain persons who are released from a jail or detention facility; and providing other matters properly relating thereto.

Senator Segerblom moved that the bill be referred to the Committee on Judiciary.

Senate Bill No. 269—AN ACT relating to water; authorizing the State Engineer to approve the inclusion of certain limitations, restrictions, requirements and other provisions in a groundwater management plan; and providing other matters properly relating thereto.

Senate Bill No. 270—AN ACT relating to water; requiring a claimant of pre-statutory water rights to submit proof of the claim to the State Engineer on or before a certain date; requiring the State Engineer to provide certain notice of this requirement; eliminating the procedure for taking proofs of claims on and after a certain date; and providing other matters properly relating thereto.

GENERAL FILE AND THIRD READING

Senate Bill No. 148.

Bill read third time.

Remarks by Senator Spearman.

This bill is necessary, because during the time of Don't Ask Don't Tell, and even before, there were many veterans who were separated from the service. Those veterans do not have access to veteran's benefits. I think it is important for us to recognize their service and the fact this country now says it is okay to be who you are and to serve your country.

Senate Bill No. 148 requires the Director of the Department of Veterans Services to provide assistance and information relating to aid, benefits and services to veterans and members of the military who are lesbian, gay, bisexual or transgender (LGBT) and their spouses and dependents. The Director is further required to assist a veteran who is LGBT in applying for an upgrade to the character of the veteran's discharge from service or a change in the narrative reason for the discharge. Finally, the measure prohibits the denial of a veteran's eligibility for any program, service, benefit, activity or facility in Nevada for which the veteran would otherwise be eligible solely based on a veteran's status as a discharged veteran who is LGBT. There are some veterans who are buried in Arlington National Cemetery, and we salute them as well.

Senate Bill No. 197

Bill read third time.

Remarks by Senator Kieckhefer.

Senate Bill No. 197 extends by 10 years, from June 30, 2020, to June 30, 2030, the deadline for the issuance of the remainder of the general obligation bonds that were required in 2009 to be issued to carry out certain projects to improve the environment in the Lake Tahoe Basin.

The Legislative Committee for the Review and Oversight of the Tahoe Regional Planning Agency and the Marlette Lake Water System voted unanimously to request the legislation to extend by 10 years to June 30, 2030, the authority for the issuance of the general obligation bonds authorized, but not yet issued, to fund Nevada's apportioned share of the costs for the Lake Tahoe Environmental Improvement Program (EIP). The Lake Tahoe EIP is a partnership between Nevada and California, the federal government, local governments and the private sector. Some bonds for the Lake Tahoe EIP have not been issued despite legislative authorization to do so because of the limited general obligation debt capacity. Testimony indicated that the total bonding authority remaining for the second phase of the Lake Tahoe EIP is in excess of \$92 million.

Senate Bill No. 198.

Bill read third time.

Remarks by Senator Kieckhefer.

Senate Bill No. 198 extends by 5 years, from June 30, 2019, to June 30, 2024, the deadline for the issuance of the remainder of the general obligation bonds that were authorized, but not yet issued, for the Conservation and Resource Protection Grant Program. In 2001, the Nevada Legislature approved Assembly Bill 9 (Chapter 6, Statutes of Nevada, 17th Special Session), which required that a proposal be submitted to the voters of Nevada to issue general obligation bonds to protect, preserve and obtain the benefits of the property and natural resources of Nevada. The total bonding was not to exceed \$200 million. The voters approved Question 1 on November 5, 2002.

Most recently, S.B. 489 (Chapter 251, Statutes of Nevada 2013) extended the date, by 5 years, for the issuance of general obligation bonds for the Question 1 Program from June 30, 2014, to June 30, 2019. Testimony indicated that, not including bond sales contemplated in the Executive Budget for the upcoming biennium, there is still a remaining funding authority of \$18.6 million. The Legislative Committee for the Review and Oversight of the Tahoe Regional Planning Agency and the Marlette Lake Water System voted unanimously to request legislation to extend by 5 years the authority for the issuance of these general obligation bonds.
