INTRODUCTION, FIRST READING AND REFERENCE

By the Committee on Transportation:

Senate Bill No. 426—AN ACT relating to protective equipment; requiring the driver and any passenger of a moped or trimobile to wear protective headgear while the moped or trimobile is being driven on a highway; requiring the driver and any passenger of a moped to wear certain additional protective equipment; providing a penalty; and providing other matters properly relating thereto.

Senator Manendo moved that the bill be referred to the Committee on Transportation.

Senate Bill No. 427—AN ACT relating to railroads; requiring certain trains and locomotives which are transporting freight in this State to contain a crew of not less than two persons; providing civil penalties; providing a penalty; and providing other matters properly relating thereto.

By the Committee on Transportation:

Senate Bill No. 428—AN ACT relating to license plates; providing for the issuance of special license plates indicating support for the Tule Springs Fossil Beds National Monument; imposing a fee for the issuance and renewal of the license plates; and providing other matters properly relating thereto.

Senator Manendo moved that the bill be referred to the Committee on Transportation.
