

ASSEMBLY BILL NO. 393—ASSEMBLYMAN FRIERSON

MARCH 21, 2019

Referred to Committee on Judiciary

SUMMARY—Provides protections to certain governmental and tribal employees and certain other persons during a government shutdown. (BDR 3-1015)

AN ACT relating to governmental administration; prohibiting the foreclosure of real property or a lien against a unit in a common-interest community owned by a federal worker, tribal worker, state worker or household member of such a worker during a government shutdown in certain circumstances; providing certain protections to a tenant who is a federal worker, tribal worker, state worker or household member of such a worker during a government shutdown; prohibiting a person from repossessing the vehicle of a federal worker, tribal worker, state worker or household member of such a worker during a government shutdown; authorizing the provision of assistance in paying for natural gas and electricity to a federal worker, tribal worker, state worker or household member of such a worker during a government shutdown; providing penalties; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 The Federal Employees Civil Relief Act, which is pending before Congress,
2 proposes to provide relief to federal employees and employees of contractors during
3 a lapse in appropriations for any federal agency or department by suspending the
4 enforcement of certain civil liabilities of such employees during the lapse. (S. 72,
5 116th Cong. (2019)) This bill generally enacts similar provisions in state law
6 intended to provide certain protections to federal workers, tribal workers, state
7 workers and household members of such workers during a lapse in appropriations at
8 the state or federal level or for the tribal government. This bill defines the following



9 terms: (1) “federal worker” to mean an employee of a federal agency or an employee
10 of a contractor who has entered into a contract with a federal agency; (2) “tribal
11 worker” to mean an employee of a federally recognized Nevada Indian tribe that
12 receives at least a majority of its funding from the Federal Government or an
13 employee of a contractor who has entered into a contract with such a tribe; (3) “state
14 worker” to mean an employee of a state agency or an employee of a contractor who
15 has entered into a contract with a state agency; (4) “shutdown” to mean any period
16 in which there is a lapse in appropriations for a federal or state agency or tribal
17 government that continues through any unpaid payday for a federal worker, tribal
18 worker or state worker employed by that agency or government; and (5) “household
19 member” to mean any person who is related by blood, marriage, adoption or other
20 legal process and is currently residing with a federal worker, tribal worker or state
21 worker affected by a shutdown.

22 **Section 6** of this bill provides that if a mortgagor or grantor of a deed of trust
23 under a residential mortgage loan is a federal worker, tribal worker, state worker or,
24 in certain circumstances, a household member or landlord of such a worker, a person
25 is prohibited from conducting a foreclosure sale during the period commencing on
26 the date that a shutdown begins and ending on the date that is 90 days after the date
27 on which the shutdown ends. **Section 6** also provides that in any civil action for a
28 foreclosure sale that is filed during that period against a federal worker, tribal worker
29 or state worker or, if applicable, a household member or landlord of such a worker,
30 the court is authorized or required, depending on the circumstances, to stay the
31 proceedings in the action for a certain period or issue an order that conserves the
32 interests of the parties unless the court determines that the ability of the federal
33 worker, tribal worker, state worker or household member or landlord of such a
34 worker to comply with the terms of the obligation secured by the residential mortgage
35 loan is not materially affected by the shutdown. **Section 6** further provides that any
36 such protection against foreclosure only applies to a residential mortgage loan that
37 was secured before the shutdown. **Section 6** provides that any person who knowingly
38 conducts a foreclosure sale in violation of the provisions of **section 6** is guilty of a
39 misdemeanor and is liable for actual damages, reasonable attorney’s fees and costs
40 incurred by the injured party. This protection against foreclosure provided by **section**
41 **6** is similar to that provided in existing law to a servicemember on active duty or
42 deployment. (NRS 40.439) Existing law requires that a servicemember receive notice
43 of such protections before a notice of default and election to sell is recorded for a
44 trustee’s sale or before the commencement of a civil action for a foreclosure sale.
45 (NRS 107.500) **Section 12** of this bill extends this requirement to provide notice of
46 the similar protections to a federal worker, tribal worker or state worker or household
47 member or landlord of such a worker in relation to a shutdown.

48 **Section 13** of this bill applies the applicable provisions set forth in **section 6** to
49 the foreclosure of a lien of a unit-owners’ association against a unit in a common-
50 interest community and provides that if a unit’s owner or his or her successor in
51 interest is a federal worker, tribal worker or state worker or, in certain circumstances,
52 a household member or landlord of such a worker, an association is generally
53 prohibited from initiating the foreclosure of a lien by sale during any period between
54 the commencement of a shutdown and 90 days after the end of a shutdown. **Section**
55 **13** also requires a unit-owners’ association to: (1) inform each unit’s owner or his or
56 her successor in interest that if the person is a federal worker, tribal worker, state
57 worker or household member or landlord of such a worker, he or she may be entitled
58 to certain protections pursuant to **section 13**; and (2) give the person the opportunity
59 to provide any information required to enable the association to verify whether the
60 person is entitled to the protections set forth in **section 13**. **Section 13** also requires
61 that before an association takes certain action relating to the foreclosure of a lien by
62 sale, the association must, if such information is provided, verify whether a unit’s
63 owner or his or her successor in interest is entitled to the protections set forth in



64 **section 13** or, if such information is not provided, make a good faith effort to verify
65 whether a unit's owner or his or her successor in interest is entitled to such
66 protections. This protection against foreclosure provided by **section 13** is similar to
67 that provided to a servicemember on active duty or deployment. (NRS 116.311625)

68 Existing law prescribes criteria for unlawful detainer by a tenant of real property,
69 a recreational vehicle or a mobile home. (NRS 40.251, 40.2512) **Section 7** of this
70 bill: (1) authorizes a tenant who is a federal worker, tribal worker, state worker or
71 household member of such a worker to request to be allowed to continue in
72 possession of real property or a dwelling unit during a shutdown and for a period of
73 not more than 30 days after the shutdown; and (2) requires a landlord who receives
74 such a request to allow the tenant to remain in possession of the property or unit
75 during that period. **Section 8** of this bill provides that a tenant who provides to a
76 landlord proof that he or she is a federal worker, tribal worker, state worker or
77 household member of such a worker during a shutdown is not guilty of unlawful
78 detainer.

79 Existing law provides for a summary eviction procedure when the tenant of any
80 dwelling, apartment, mobile home, recreational vehicle or commercial premises
81 defaults in the payment of rent. (NRS 40.253) **Section 9** of this bill provides that the
82 summary eviction procedure does not apply to a tenant who provides proof to the
83 landlord that he or she is a federal worker, tribal worker, state worker or household
84 member of such a worker during a shutdown.

85 Existing law prescribes basic obligations of a tenant, which include requiring a
86 tenant to comply with the terms of a rental agreement. (NRS 118A.310) **Section 20**
87 of this bill makes any term of a rental agreement requiring the payment of rent at a
88 specified time unenforceable against a tenant who is a federal worker, tribal worker,
89 state worker or household member of such a worker during a shutdown. **Section 20**
90 also requires a landlord to accept payment of rent for the period in which a federal or
91 state agency or tribal government was experiencing a shutdown for a period not to
92 exceed 30 days after the end of the shutdown. **Section 21** of this bill prohibits a
93 landlord from taking certain retaliatory action against a tenant who pays rent in the
94 period prescribed in **section 20**.

95 **Section 18.7** of this bill authorizes a landlord to petition the court for relief from
96 the protections for federal workers, tribal workers, state workers and certain
97 household members of such workers prescribed in **sections 6 and 20** if: (1) a
98 shutdown continues for a period of 30 days or more; and (2) the requirements
99 prescribed by **sections 6 and 20** impose an undue hardship on the landlord. **Section**
100 **18.7** provides that if the court grants relief from these provisions: (1) the parties may
101 modify the terms of the rental agreement; or (2) the landlord may terminate the rental
102 agreement and commence eviction proceedings. **Sections 7-9, 20 and 21** make
103 conforming changes.

104 **Sections 26 and 27** of this bill prohibit a landlord of a manufactured home park
105 from charging any late fee for a late rental payment by a federal worker, tribal worker,
106 state worker or household member of such a worker during a shutdown. **Section 28**
107 of this bill prohibits a landlord of a manufactured home park from terminating a rental
108 agreement for failure of the tenant to pay rent if the tenant provides proof to the
109 landlord that he or she is a federal worker, tribal worker, state worker or household
110 member of such a worker during a shutdown. **Section 29** of this bill prohibits a
111 landlord from taking certain retaliatory action against a tenant who provides such
112 proof.

113 **Section 30** of this bill prohibits a person from repossessing the vehicle of a
114 federal worker, tribal worker, state worker or household member of such a worker
115 who provides proof that he or she is such a person during a shutdown or for a period
116 of 30 days immediately after the end of a shutdown. **Section 30** provides that any
117 person who knowingly repossesses a vehicle in violation of the provisions of **section**
118 **30** is guilty of a misdemeanor and is liable for actual damages, reasonable attorney's



119 fees and costs incurred by the injured party. Existing law requires that certain notice
120 be provided before a vehicle repossessed pursuant to a security agreement may be
121 sold. (NRS 482.516) **Section 30.5** of this bill requires that information about the
122 protections provided by **section 30** be included in that notice.

123 Existing law authorizes the Division of Welfare and Supportive Services of the
124 Department of Health and Human Services to use money in the Fund for Energy
125 Assistance and Conservation to assist eligible households in paying for natural gas
126 and electricity. (NRS 702.260) **Section 31** of this bill makes households that include
127 at least one federal worker, tribal worker or state worker eligible for such assistance
128 during a shutdown.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 40 of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 2 to 6, inclusive, of this act.

3 **Sec. 2.** *As used in this chapter, unless the context otherwise*
4 *requires, the words and terms defined in sections 3 to 5.5, inclusive,*
5 *of this act have the meanings ascribed to them in those sections.*

6 **Sec. 3.** *“Federal worker” means an employee of a federal*
7 *agency or an employee of a contractor who has entered into a*
8 *contract with a federal agency.*

9 **Sec. 3.25.** *“Household member” means any person who is*
10 *related by blood, marriage, adoption or other legal process and is*
11 *currently residing with a federal worker, tribal worker or state*
12 *worker affected by a shutdown.*

13 **Sec. 3.5.** *“Qualified Indian tribe” means a federally*
14 *recognized Nevada Indian tribe that receives at least a majority of*
15 *its funding from the Federal Government.*

16 **Sec. 4.** *“Shutdown” means any period in which there is a*
17 *lapse in appropriations for a federal or state agency or tribal*
18 *government that continues through any unpaid payday for a federal*
19 *worker, state worker or tribal worker employed by that agency or*
20 *tribal government.*

21 **Sec. 5.** *“State worker” means an employee of a state agency*
22 *or an employee of a contractor who has entered into a contract with*
23 *a state agency.*

24 **Sec. 5.5.** *“Tribal worker” means an employee of a qualified*
25 *Indian tribe or an employee of a contractor who has entered into a*
26 *contract with a qualified Indian tribe.*

27 **Sec. 6. 1.** *Notwithstanding any other provision of law and*
28 *except as otherwise ordered by a court of competent jurisdiction, if*
29 *a borrower provides proof that he or she is a federal worker, tribal*
30 *worker or state worker or, in accordance with subsection 5, a*
31 *household member or landlord of such a worker, a person shall not*
32 *initiate or direct or authorize another person to initiate a*



1 *foreclosure sale during the period commencing on the date on*
2 *which a shutdown begins and ending on the date that is 90 days*
3 *after the date on which the shutdown ends.*

4 2. *Except as otherwise provided in subsection 3, in any civil*
5 *action for a foreclosure sale pursuant to NRS 40.430 involving a*
6 *failure to make a payment required by a residential mortgage loan*
7 *that is filed against a federal worker, tribal worker or state worker*
8 *or, in accordance with subsection 5, a household member or*
9 *landlord of such a worker, during a shutdown or during the 90-day*
10 *period immediately after the end of a shutdown, the court may, on*
11 *its own motion after a hearing, or shall, on a motion or on behalf*
12 *of the federal worker, tribal worker, state worker or household*
13 *member or landlord of such a worker, as applicable, do one or both*
14 *of the following:*

15 (a) *Stay the proceedings in the action until at least 90 days after*
16 *the end of the shutdown; or*

17 (b) *Adjust the obligation to preserve the interests of the parties.*

18 3. *The provisions of subsection 2 do not apply if the court*
19 *determines that the ability of the federal worker, tribal worker, state*
20 *worker or household member or landlord of such a worker to*
21 *comply with the terms of the obligation secured by the residential*
22 *mortgage loan is not materially affected by the shutdown.*

23 4. *The provisions of this section apply only to a residential*
24 *mortgage loan that was secured by a federal worker, tribal worker*
25 *or state worker or, in accordance with subsection 5, a household*
26 *member or landlord of such a worker, before the shutdown.*

27 5. *Upon application to the court, a household member or*
28 *landlord of such a worker is entitled to the protections provided to*
29 *a federal worker, tribal worker or state worker pursuant to this*
30 *section if the ability of the household member or landlord of such a*
31 *worker to make payments required by a residential mortgage loan*
32 *is materially affected by the shutdown.*

33 6. *Except as otherwise provided in subsection 7, any person*
34 *who knowingly initiates or directs or authorizes another person to*
35 *initiate a foreclosure sale in violation of this section:*

36 (a) *Is guilty of a misdemeanor; and*

37 (b) *May be liable for actual damages, reasonable attorney's fees*
38 *and costs incurred by the injured party.*

39 7. *The provisions of subsection 6 do not apply to a trustee who*
40 *initiates a foreclosure sale pursuant to the direction or*
41 *authorization of another person.*

42 8. *In imposing liability pursuant to paragraph (b) of*
43 *subsection 6, a court shall, when determining whether to reduce*
44 *such liability, take into consideration any due diligence used by the*



1 *person before he or she initiated or directed or authorized another*
2 *person to initiate the foreclosure sale.*

3 **9. As used in this section:**

4 (a) *“Borrower” has the meaning ascribed to it in NRS 107.410.*

5 (b) *“Initiate a foreclosure sale” means to commence a civil*
6 *action for a foreclosure sale pursuant to NRS 40.430 or, in the case*
7 *of the exercise of a trustee’s power of sale pursuant to NRS 107.080*
8 *and 107.0805, to execute and cause to be recorded in the office of*
9 *the county recorder a notice of the breach and of the election to sell*
10 *or cause to be sold the property pursuant to paragraph (b) of*
11 *subsection 2 of NRS 107.080 and paragraph (b) of subsection 1 of*
12 *NRS 107.0805.*

13 (c) *“Residential mortgage loan” has the meaning ascribed to it*
14 *in NRS 107.450.*

15 (d) *“Trustee” means a person described in NRS 107.028.*

16 **Sec. 7.** NRS 40.251 is hereby amended to read as follows:

17 40.251 1. A tenant of real property, a recreational vehicle or a
18 mobile home for a term less than life is guilty of an unlawful detainer
19 when having leased:

20 (a) Real property, except as otherwise provided in this section, or
21 a mobile home for an indefinite time, with monthly or other periodic
22 rent reserved, the tenant continues in possession thereof, in person or
23 by subtenant, without the landlord’s consent after the expiration of a
24 notice of:

25 (1) For tenancies from week to week, at least 7 days;

26 (2) Except as otherwise provided in subsection 2, for all other
27 periodic tenancies, at least 30 days; or

28 (3) For tenancies at will, at least 5 days.

29 (b) A dwelling unit subject to the provisions of chapter 118A of
30 NRS, the tenant continues in possession, in person or by subtenant,
31 without the landlord’s consent after expiration of:

32 (1) The term of the rental agreement or its termination and,
33 except as otherwise provided in subparagraph (2), the expiration of a
34 notice of:

35 (I) At least 7 days for tenancies from week to week; and

36 (II) Except as otherwise provided in subsection 2, at least
37 30 days for all other periodic tenancies; or

38 (2) A notice of at least 5 days where the tenant has failed to
39 perform the tenant’s basic or contractual obligations under chapter
40 118A of NRS.

41 (c) A mobile home lot subject to the provisions of chapter 118B
42 of NRS, or a lot for a recreational vehicle in an area of a mobile home
43 park other than an area designated as a recreational vehicle lot
44 pursuant to the provisions of subsection 8 of NRS 40.215, the tenant



1 continues in possession, in person or by subtenant, without the
2 landlord's consent:

3 (1) After notice has been given pursuant to NRS 118B.115,
4 118B.170 or 118B.190 and the period of the notice has expired; or

5 (2) If the person is not a natural person and has received three
6 notices for nonpayment of rent within a 12-month period,
7 immediately upon failure to pay timely rent.

8 (d) A recreational vehicle lot, the tenant continues in possession,
9 in person or by subtenant, without the landlord's consent, after the
10 expiration of a notice of at least 5 days.

11 2. Except as otherwise provided in this section, if a tenant with
12 a periodic tenancy pursuant to paragraph (a) or (b) of subsection 1,
13 other than a tenancy from week to week, is 60 years of age or older
14 or has a physical or mental disability, the tenant may request to be
15 allowed to continue in possession for an additional 30 days beyond
16 the time specified in subsection 1 by submitting a written request for
17 an extended period and providing proof of the tenant's age or
18 disability. A landlord may not be required to allow a tenant to
19 continue in possession if a shorter notice is provided pursuant to
20 subparagraph (2) of paragraph (b) of subsection 1.

21 3. *Except as otherwise provided in this section, if a tenant with*
22 *a periodic tenancy pursuant to paragraph (a) or (b) of subsection 1*
23 *is a federal worker, tribal worker, state worker or household*
24 *member of such a worker, the tenant may request to be allowed to*
25 *continue in possession during the period commencing on the date*
26 *on which a shutdown begins and ending on the date that is 30 days*
27 *after the date on which the shutdown ends by submitting a written*
28 *request for the extended period and providing proof that he or she*
29 *is a federal worker, tribal worker, state worker or household*
30 *member of such a worker during the shutdown.*

31 4. *Except as otherwise provided in section 18.7 of this act, a*
32 *landlord who receives a request from a tenant pursuant to*
33 *subsection 3 shall allow a tenant to continue in possession for the*
34 *period requested.*

35 5. Any notice provided pursuant to paragraph (a) or (b) of
36 subsection 1 must include a statement advising the tenant of the
37 provisions of ~~subsection~~ *subsections 2 [4-], 3 and 4.*

38 ~~[4-]~~ 6. If a landlord rejects a request to allow a tenant to continue
39 in possession for an additional 30 days pursuant to subsection 2, the
40 tenant may petition the court for an order to continue in possession
41 for the additional 30 days. If the tenant submits proof to the court that
42 the tenant is entitled to request such an extension, the court may grant
43 the petition and enter an order allowing the tenant to continue in
44 possession for the additional 30 days. If the court denies the petition,



1 the tenant must be allowed to continue in possession for 5 calendar
2 days following the date of entry of the order denying the petition.

3 **Sec. 8.** NRS 40.2512 is hereby amended to read as follows:

4 40.2512 ~~[A]~~

5 **1. Except as otherwise provided in subsection 2, a** tenant of real
6 property or a mobile home for a term less than life is guilty of an
7 unlawful detainer when the tenant continues in possession, in person
8 or by subtenant, after default in the payment of any rent and after a
9 notice in writing, requiring in the alternative the payment of the rent
10 or the surrender of the detained premises, remains uncomplished with
11 for a period of 5 days, or in the case of a mobile home lot, 10 days
12 after service thereof. The notice may be served at any time after the
13 rent becomes due.

14 **2. Except as otherwise provided in section 18.7 of this act, the**
15 **provisions of subsection 1 do not apply to a person who provides to**
16 **the landlord proof that he or she is a federal worker, tribal worker,**
17 **state worker or household member of such a worker during a**
18 **shutdown.**

19 **Sec. 9.** NRS 40.253 is hereby amended to read as follows:

20 40.253 1. Except as otherwise provided in subsection 10, in
21 addition to the remedy provided in NRS 40.2512 and 40.290 to
22 40.420, inclusive, when the tenant of any dwelling, apartment, mobile
23 home, recreational vehicle or commercial premises with periodic rent
24 reserved by the month or any shorter period is in default in payment
25 of the rent, the landlord or the landlord's agent, unless otherwise
26 agreed in writing, may serve or have served a notice in writing,
27 requiring in the alternative the payment of the rent or the surrender of
28 the premises:

29 (a) At or before noon of the fifth full day following the day of
30 service; or

31 (b) If the landlord chooses not to proceed in the manner set forth
32 in paragraph (a) and the rent is reserved by a period of 1 week or less
33 and the tenancy has not continued for more than 45 days, at or before
34 noon of the fourth full day following the day of service.

35 ➤ As used in this subsection, "day of service" means the day the
36 landlord or the landlord's agent personally delivers the notice to the
37 tenant. If personal service was not so delivered, the "day of service"
38 means the day the notice is delivered, after posting and mailing
39 pursuant to subsection 2, to the sheriff or constable for service if the
40 request for service is made before noon. If the request for service by
41 the sheriff or constable is made after noon, the "day of service" shall
42 be deemed to be the day next following the day that the request is
43 made for service by the sheriff or constable.

44 2. A landlord or the landlord's agent who serves a notice to a
45 tenant pursuant to paragraph (b) of subsection 1 shall attempt to



1 deliver the notice in person in the manner set forth in paragraph (a)
2 of subsection 1 of NRS 40.280. If the notice cannot be delivered in
3 person, the landlord or the landlord's agent:

4 (a) Shall post a copy of the notice in a conspicuous place on the
5 premises and mail the notice by overnight mail; and

6 (b) After the notice has been posted and mailed, may deliver the
7 notice to the sheriff or constable for service in the manner set forth in
8 subsection 1 of NRS 40.280. The sheriff or constable shall not accept
9 the notice for service unless it is accompanied by written evidence,
10 signed by the tenant when the tenant took possession of the premises,
11 that the landlord or the landlord's agent informed the tenant of the
12 provisions of this section which set forth the lawful procedures for
13 eviction from a short-term tenancy. Upon acceptance, the sheriff or
14 constable shall serve the notice within 48 hours after the request for
15 service was made by the landlord or the landlord's agent.

16 3. A notice served pursuant to subsection 1 or 2 must:

17 (a) Identify the court that has jurisdiction over the matter; and

18 (b) Advise the tenant:

19 (1) Of the tenant's right to contest the matter by filing, within
20 the time specified in subsection 1 for the payment of the rent or
21 surrender of the premises, an affidavit with the court that has
22 jurisdiction over the matter stating that the tenant has tendered
23 payment or is not in default in the payment of the rent;

24 (2) That if the court determines that the tenant is guilty of an
25 unlawful detainer, the court may issue a summary order for removal
26 of the tenant or an order providing for the nonadmittance of the
27 tenant, directing the sheriff or constable of the county to remove the
28 tenant within 24 hours after receipt of the order; and

29 (3) That, pursuant to NRS 118A.390, a tenant may seek relief
30 if a landlord unlawfully removes the tenant from the premises or
31 excludes the tenant by blocking or attempting to block the tenant's
32 entry upon the premises or willfully interrupts or causes or permits
33 the interruption of an essential service required by the rental
34 agreement or chapter 118A of NRS.

35 4. If the tenant files such an affidavit at or before the time stated
36 in the notice, the landlord or the landlord's agent, after receipt of a
37 file-stamped copy of the affidavit which was filed, shall not provide
38 for the nonadmittance of the tenant to the premises by locking or
39 otherwise.

40 5. Upon noncompliance with the notice:

41 (a) The landlord or the landlord's agent may apply by affidavit of
42 complaint for eviction to the justice court of the township in which
43 the dwelling, apartment, mobile home, recreational vehicle or
44 commercial premises are located or to the district court of the county
45 in which the dwelling, apartment, mobile home, recreational vehicle



1 or commercial premises are located, whichever has jurisdiction over
2 the matter. The court may thereupon issue an order directing the
3 sheriff or constable of the county to remove the tenant within 24 hours
4 after receipt of the order. The affidavit must state or contain:

5 (1) The date the tenancy commenced.

6 (2) The amount of periodic rent reserved.

7 (3) The amounts of any cleaning, security or rent deposits paid
8 in advance, in excess of the first month's rent, by the tenant.

9 (4) The date the rental payments became delinquent.

10 (5) The length of time the tenant has remained in possession
11 without paying rent.

12 (6) The amount of rent claimed due and delinquent.

15 (8) A copy of the written notice served on the tenant.

16 (9) A copy of the signed written rental agreement, if any.

17 (b) Except when the tenant has timely filed the affidavit described
18 in subsection 3 and a file-stamped copy of it has been received by the
19 landlord or the landlord's agent, and except when the landlord is
20 prohibited pursuant to NRS 118A.480, the landlord or the landlord's
21 agent may, in a peaceable manner, provide for the nonadmittance of
22 the tenant to the premises by locking or otherwise.

23 6. Upon the filing by the tenant of the affidavit permitted in
24 subsection 3, regardless of the information contained in the affidavit,
25 and the filing by the landlord of the affidavit permitted by subsection
26 5, the justice court or the district court shall hold a hearing, after
