SUMMARY—Revises provisions relating to Internet privacy.

AN ACT relating to Internet privacy; prohibiting an operator of an Internet website or online service which collects certain information from consumers in this State from making any sale of certain information about a consumer if so directed by the consumer; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Existing law requires an operator of an Internet website or online service which
2 collects certain items of personally identifiable information about consumers in this
3 State to make available a notice containing certain information relating to the
4 privacy of covered information collected by the operator. (NRS 603A.340) **Section**
5 **6** of this bill revises the definition of the term “operator” to exclude certain
6 financial institutions and entities that are subject to certain federal laws concerning
7 privacy and certain persons who manufacture, service or repair motor vehicles.
8 **Section 2** of this bill requires an operator to establish a designated request
9 address through which a consumer may submit a verified request directing the
10 operator not to make any sale of covered information collected about the consumer.
11 **Section 1.6** of this bill defines the term “sale” to mean the exchange of covered
12 information for monetary consideration by the operator to a person for the person to
13 license or sell the covered information to additional persons. **Section 2** prohibits an
14 operator who has received such a request from making any sale of any covered
15 information collected about the consumer. **Section 7** of this bill authorizes the
16 Attorney General to seek an injunction or a civil penalty against an operator who
17 violates **section 2**.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 603A of NRS is hereby amended by
2 adding thereto the provisions set forth as sections 1.3 to 2, inclusive,
3 of this act.

4 **Sec. 1.3.** *“Designated request address” means an electronic*
5 *mail address, toll-free telephone number or Internet website*
6 *established by an operator through which a consumer may submit*
7 *to an operator a verified request.*

8 **Sec. 1.6. 1.** *“Sale” means the exchange of covered*
9 *information for monetary consideration by the operator to a*
10 *person for the person to license or sell the covered information to*
11 *additional persons.*

12 **2.** *The term does not include:*

13 **(a)** *The disclosure of covered information by an operator to a*
14 *person who processes the covered information on behalf of the*
15 *operator;*

16 **(b)** *The disclosure of covered information by an operator to a*
17 *person with whom the consumer has a direct relationship for the*
18 *purposes of providing a product or service requested by the*
19 *consumer;*

20 **(c)** *The disclosure of covered information by an operator to a*
21 *person for purposes which are consistent with the reasonable*
22 *expectations of a consumer considering the context in which the*
23 *consumer provided the covered information to the operator;*

24 **(d)** *The disclosure of covered information to a person who is*
25 *an affiliate, as defined in NRS 686A.620, of the operator; or*

26 **(e)** *The disclosure or transfer of covered information to a*
27 *person as an asset that is part of a merger, acquisition, bankruptcy*
28 *or other transaction in which the person assumes control of all or*
29 *part of the assets of the operator.*

30 **Sec. 1.8.** *“Verified request” means a request:*

31 **1.** *Submitted by a consumer to an operator for the purposes*
32 *set forth in section 2 of this act; and*

33 **2.** *For which an operator can reasonably verify the*
34 *authenticity of the request and the identity of the consumer using*
35 *commercially reasonable means.*

36 **Sec. 2. 1.** *Each operator shall establish a designated*
37 *request address through which a consumer may submit a verified*
38 *request pursuant to this section.*

39 **2.** *A consumer may, at any time, submit a verified request*
40 *through a designated request address to an operator directing the*
41 *operator not to make any sale of any covered information the*
42 *operator has collected or will collect about the consumer.*



1 **3. An operator that has received a verified request submitted**
2 **by a consumer pursuant to subsection 2 shall not make any sale of**
3 **any covered information the operator has collected or will collect**
4 **about that consumer.**

5 **4. An operator shall respond to a verified request submitted**
6 **by a consumer pursuant to subsection 2 within 60 days after**
7 **receipt thereof. An operator may extend by not more than 30 days**
8 **the period prescribed by this subsection if the operator determines**
9 **that such an extension is reasonably necessary. An operator who**
10 **extends the period prescribed by this subsection shall notify the**
11 **consumer of such an extension.**

12 **Sec. 3.** (Deleted by amendment.)

13 **Sec. 4.** NRS 603A.100 is hereby amended to read as follows:

14 603A.100 1. The provisions of NRS 603A.010 to 603A.290,
15 inclusive, do not apply to the maintenance or transmittal of
16 information in accordance with NRS 439.581 to 439.595, inclusive,
17 and the regulations adopted pursuant thereto.

18 2. A data collector who is also an operator, as defined in NRS
19 603A.330, shall comply with the provisions of NRS 603A.300 to
20 603A.360, inclusive ~~§~~, **and sections 1.3 to 2, inclusive, of this act.**

21 3. Any waiver of the provisions of NRS 603A.010 to
22 603A.290, inclusive, is contrary to public policy, void and
23 unenforceable.

24 **Sec. 5.** NRS 603A.300 is hereby amended to read as follows:

25 603A.300 As used in NRS 603A.300 to 603A.360, inclusive,
26 **and sections 1.3 to 2, inclusive, of this act**, unless the context
27 otherwise requires, the words and terms defined in NRS 603A.310,
28 603A.320 and 603A.330 **and sections 1.3, 1.6 and 1.8 of this act**
29 have the meanings ascribed to them in those sections.

30 **Sec. 6.** NRS 603A.330 is hereby amended to read as follows:

31 603A.330 1. "Operator" means a person who:

32 (a) Owns or operates an Internet website or online service for
33 commercial purposes;

34 (b) Collects and maintains covered information from consumers
35 who reside in this State and use or visit the Internet website or
36 online service; and

37 (c) Purposefully directs its activities toward this State,
38 consummates some transaction with this State or a resident thereof,
39 ~~for~~ purposefully avails itself of the privilege of conducting
40 activities in this State ~~§~~ **or otherwise engages in any activity that**
41 **constitutes sufficient nexus with this State to satisfy the**
42 **requirements of the United States Constitution.**

43 2. The term does not include ~~§~~:

44 **(a)** A third party that operates, hosts or manages an Internet
45 website or online service on behalf of its owner or processes



1 information on behalf of the owner of an Internet website or online
2 service **[]**;

3 *(b) A financial institution or an affiliate of a financial*
4 *institution that is subject to the provisions of the Gramm-Leach-*
5 *Bliley Act, 15 U.S.C. §§ 6801 et seq., and the regulations adopted*
6 *pursuant thereto;*

7 *(c) An entity that is subject to the provisions of the Health*
8 *Insurance Portability and Accountability Act of 1996, Public Law*
9 *104-191, as amended, and the regulations adopted pursuant*
10 *thereto; or*

11 *(d) A manufacturer of a motor vehicle or a person who repairs*
12 *or services a motor vehicle who collects, generates, records or*
13 *stores covered information that is:*

14 *(1) Retrieved from a motor vehicle in connection with a*
15 *technology or service related to the motor vehicle; or*

16 *(2) Provided by a consumer in connection with a*
17 *subscription or registration for a technology or service related to*
18 *the motor vehicle.*

19 **Sec. 7.** NRS 603A.360 is hereby amended to read as follows:

20 603A.360 1. The Attorney General shall enforce the
21 provisions of NRS 603A.300 to 603A.360, inclusive **[]** , *and*
22 *sections 1.3 to 2, inclusive, of this act.*

23 2. If the Attorney General has reason to believe that an
24 operator, either directly or indirectly, has violated or is violating
25 NRS 603A.340 **[]** *or section 2 of this act*, the Attorney General
26 may institute an appropriate legal proceeding against the operator.
27 The district court, upon a showing that the operator, either directly
28 or indirectly, has violated or is violating NRS 603A.340 **[]** *or*
29 *section 2 of this act*, may:

30 (a) Issue a temporary or permanent injunction; or

31 (b) Impose a civil penalty not to exceed \$5,000 for each
32 violation.

33 3. The provisions of NRS 603A.300 to 603A.360, inclusive,
34 *and sections 1.3 to 2, inclusive, of this act* do not establish a private
35 right of action against an operator.

36 4. The provisions of NRS 603A.300 to 603A.360, inclusive,
37 *and sections 1.3 to 2, inclusive, of this act* are not exclusive and are
38 in addition to any other remedies provided by law.
