Department to annually file certain consolidated reports; and providing other matters properly relating thereto.

Assembly Bill No. 264—AN ACT relating to governmental administration; requiring a state agency to implement a policy that promotes collaboration between the state agency and Indian nations or tribes; requiring the Governor to meet with the leaders of Indian nations or tribes; requiring certain employees of state agencies to receive certain training; and providing other matters properly relating thereto.

Assemblywoman Peters moved that the bill be referred to the Committee on Government Affairs.

Assembly Bill No. 265—AN ACT relating to water; requiring the Desert Research Institute to conduct a study concerning water treatment and recycling; and providing other matters properly relating thereto.

Assembly Bill No. 26.

Remarks by Assemblyman Daly.

ASSEMBLYMAN DALY:

Assembly Bill 26 increases the maximum permissible amounts that may be paid out of the State Contractors' Board Recovery Fund on certain claims against residential contractors. The maximum amount of money that an injured person may recover for actual damages is increased from \$35,000 to \$40,000. The maximum amount that may be recovered based upon claims made against any single contractor is increased from \$400,000 to \$750,000 or 20 percent of the balance of the Recovery Fund, whichever is less. This bill is effective on October 1, 2019.

Assembly Bill No. 147.

Remarks by Assemblywoman Titus.

ASSEMBLYWOMAN TITUS:

Assembly Bill 147 authorizes an advanced practice registered nurse or physician assistant to complete certain certificates, documents, and statements and to order home health care for a patient, which under current law only a physician, or in certain cases, other specified providers of health care are allowed to do. This bill also provides that a medical device prescribed by a physician assistant is exempt from sales tax under the same conditions as a medical device prescribed by another eligible provider of health care. A state or local government entity must update any forms issued by the entity to conform to the provisions of this bill. This bill is effective on July 1, 2019.
