MOTIONS, RESOLUTIONS AND NOTICES

By Senators Spearman, Brook, Denis, Parks, Harris, Ohrenschall, Ratti and Woodhouse:

Senate Concurrent Resolution No. 1—Directing the Legislative Committee on Energy to conduct an interim study concerning the development of renewable energy and clean energy resources in this State.

Senator Spearman moved that the resolution be referred to the Committee on Legislative Operations and Elections.

By Senators Pickard, Hammond, Kieckhefer, Seevers Gansert, Settlemeyer; Assemblymen Hansen, Roberts, Tolles and Yeager:

Senate Joint Resolution No. 2—Proposing to amend the Nevada Constitution to revise the provisions governing appointments of judicial officers to fill vacancies.

RESOLVED BY THE SENATE AND ASSEMBLY OF THE STATE OF NEVADA, JOINTLY, That Section 20 of Article 6 of the Nevada Constitution be amended to read as follows:

Sec. 20. 1. When a vacancy occurs before the expiration of any term of office in the Supreme Court or the court of appeals or among the district judges, the Governor shall appoint a justice or judge from among three nominees selected for such individual vacancy by the Commission on Judicial Selection.

2. The term of office of any justice or judge so appointed expires on the first Monday of January following the next general election.

3. Each nomination for the Supreme Court or the court of appeals must be made by the permanent Commission, composed of:

- (a) The Chief Justice or an associate justice designated by him;
- (b) Three members of the State Bar of Nevada, a public corporation created by statute, appointed by its Board of Governors; and
- (c) ~~Three persons;~~ *One person,* not ~~members~~ *a member* of the legal profession, appointed by the Governor.

4. ~~Each~~ *Except as otherwise provided in subsection 5,* each nomination for the district court must be made by a temporary commission composed of:

- (a) The permanent Commission;
- (b) A member of the State Bar of Nevada resident in the judicial district in which the vacancy occurs, appointed by the Board of Governors of the State Bar of Nevada; and
- (c) A resident of such judicial district, not a member of the legal profession, appointed by the Governor.

5. *A temporary commission must be composed of at least three but not more than five members of the State Bar of Nevada who reside in the judicial district in which the vacancy occurs and who practice law in that judicial district in the area of law of the division of the district court in which the vacancy occurs. If additional members must be appointed to a temporary commission to comply with this subsection, the Board of Governors of the State Bar of Nevada must appoint to the temporary commission the members that are necessary to comply with this subsection.*

~~5.~~ 6. If at any time the State Bar of Nevada ceases to exist as a public corporation or ceases to include all attorneys admitted to practice before the courts of this State, the Legislature shall provide by law, or if it fails to do so the Supreme Court shall provide by rule, for the appointment of attorneys at law to the positions designated in this Section to be occupied by members of the State Bar of Nevada.

~~6.~~ 7. The term of office of each appointive member of the permanent Commission, except the first members, is 4 years. Each appointing authority shall appoint one of the members first appointed for a term of 2 years. If a vacancy occurs, the appointing authority shall fill the vacancy for the unexpired term. The additional members of a temporary commission must be appointed when a vacancy occurs, and their terms expire when the nominations for such vacancy have been transmitted to the Governor.

~~7.~~ 8. An appointing authority shall not appoint to the permanent Commission more than:

- (a) One resident of any county.
- (b) Two members of the same political party.

↪ No member of the permanent Commission may be a member of the Commission on Judicial Discipline.

~~8.~~ 9. After the expiration of 30 days from the date on which the Commission on Judicial Selection has delivered to him its list of nominees for any vacancy, if the Governor

has not made the appointment required by this Section, he shall make no other appointment to any public office until he has appointed a justice or judge from the list submitted.

10. An application for appointment to fill a vacancy in the Supreme Court or court of appeals or among the district judges submitted to the permanent Commission or a temporary commission, and all information contained therein, is confidential and does not constitute a public record.

REMARKS FROM THE FLOOR

Senator Hammond requested that his remarks be entered in the Journal.

I rise today on President's Day to pay honor to a brave man whose calm confidence, warm character and love of the bonds of home and family helped lead this Country into a new period of peace and prosperity around the world. He battled back the "wimp" factor during his 1988 run for President, never boastful about his accomplishments, others were. We know now that President George Herbert Walker Bush was not only not a wimp, but he was also a true American hero.

The youngest fighter pilot ever to serve in the United States Navy at the time; George Bush enlisted just months after Pearl Harbor at the age of 18, the same day he graduated high school. Shot down in the skies over the Pacific on a bombing run, he was the sole survivor and came within just a few short miles of being captured by the Japanese. In the years after surviving being shot down, he often asked himself, "...why me? Why was I spared?" The answer to that is, historically speaking, obvious to us all, with a resume full of missions defined and missions completed: Congressman, Ambassador to the United Nations, Chairman of the Republican National Committee, Special Envoy to China, Director of the CIA, Vice President, and, of course, President. His life was spared so he could achieve an unbelievable amount of good for his fellow countrymen. He worked to ease tensions and reopen relations with China, to reform the CIA and ensure that our men and women who serve could be proud of what they were doing and that all of America could be proud of their service. He oversaw the fall of the Soviet Union without the sound of a single gunshot. His quiet diplomacy ensured that that epic moment of world history came without a single mishap; he knew that just one and the whole thing could come tumbling down. And, of course, by his side through it all was the incomparable Barbara Bush. Together, they raised six children and endured perhaps the greatest loss of all, the death of their daughter Robin at age 3. Together, they shaped their loss into a lifetime of giving back and doing good works.

Madame President, we lost President Bush just a few months ago. I was a young man just coming out of college during his Presidency, and I remember vividly how safe our Country felt with him as a leader. He was the last President of the greatest generation. He often described himself as a lucky man, but really we are the lucky ones, for his service, for his accomplishments, but mostly, because he loved Americans and never lost his passion for seeing this Country's success.
