INTRODUCTION, FIRST READING AND REFERENCE

By the Committee on Commerce and Labor:

Senate Bill No. 234—AN ACT relating to health care; requiring the Commissioner of Insurance to collect certain information from providers of health care, establish a database comprised of such information and compile an annual report concerning such information; requiring the Commissioner to develop a form letter to provide certain notice to providers of health care relating to participation in the network of a health carrier; and providing other matters properly relating thereto.
