Senate Bill No. 278—AN ACT relating to marijuana; authorizing a medical marijuana establishment or an association of medical marijuana establishments to participate in a program of workforce development to recruit, assess and train medical marijuana establishment agents; requiring the Office of Economic Development to ensure that minority-owned business enterprises, woman-owned business enterprises and disadvantaged business enterprises are involved in programs of workforce development in which medical marijuana establishments participate; and providing other matters properly relating thereto.
