INTRODUCTION, FIRST READING AND REFERENCE

By Senator Cannizzaro:

Senate Bill No. 425—AN ACT relating to public welfare; requiring the Director of the Department of Health and Human Services to amend the State Plan for Medicaid to provide certain additional home and community-based services; requiring the Division of Health Care Financing and Policy of the Department to provide tenancy support services to the extent authorized by federal law; and providing other matters properly relating thereto.

Senator Ratti moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.

By the Committee on Growth and Infrastructure:

Senate Bill No. 426—AN ACT relating to transportation; extending the deadline for a regional transportation commission to submit certain recommendations relating to the imposition of certain taxes to the board of county commissioners; extending the deadline for a board of county commissioners to submit a ballot question to the voters regarding the imposition of certain taxes; and providing other matters properly relating thereto.

Senator Ratti moved that the bill be referred to the Committee on Government Affairs.

Motion carried.

By the Committee on Judiciary:

Senate Bill No. 427—AN ACT relating to business entities; revising provisions governing the resignation of registered agents; revising provisions governing the records kept by a corporation and made available for inspection to certain persons; revising provisions concerning certain distributions to stockholders; revising provisions governing meetings of stockholders of corporations; authorizing the removal of a director of a corporation under certain circumstances; revising provisions relating to the appointment of a receiver for a private corporation; establishing the appointment of a receiver for a limited-liability company; revising the definition of “sales representative” for purposes relating to securities; revising provisions relating to limitations on the right of a stockholder to dissent; and providing other matters properly relating thereto.

Senator Ratti moved that the bill be referred to the Committee on Judiciary.

Motion carried.

REMARKS FROM THE FLOOR

Senator Cannizzaro requested that her remarks be entered in the Journal.

As most of you know, the Nevada Senate Hall of Fame was created in 1989 to recognize individuals who were former members of the Senate and who made significant contributions to the State, not only as members of this Body, but also in their other endeavors. The portraits of previous inductees hang on the walls outside this Chamber. Today, I am pleased to announce the two inductees for the Senate Hall of Fame for 2019 are former Senators Valerie Wiener and Barbara K. Cegavske, both of Clark County.

Senator Wiener served a total of 16 years in the Nevada Legislature, all of those years in the Senate. She served as Senate Minority Whip during the 2001 Session, the 2003 Session, both the 2003 and 2004 Special Sessions (two each year), the 2005 Session, the 2005 Special Session, the 2007 Session, the 2007 Special Session and one of the 2008 Special Sessions. She served as Senate Majority Whip during the second 2008 Special Session, the 2009 Session and the 2010 Special Session. In addition, Senator Wiener served as Senate Assistant Majority Floor Leader during the 2011 Session. She was Chair of the Senate Committee on Health and Education during the 2009 Session and served on the Senate Committee on Judiciary for eight Sessions, chairing the Committee during the 2011 Session. She also served on the Senate Committees on Education; Ethics; Health and Human Services; Human Resources and Education; Human Resources and Facilities; Legislative Affairs and Operations; Legislative Operations and Elections; Select Committee on Economic Growth and Employment, and Transportation.

Our second inductee, Senator Barbara K. Cegavske, served 18 years in the Nevada Legislature, 6 years in the Assembly and 12 years in the Senate. She currently serves Nevada as the Secretary of State. Senator Cegavske served as Assembly Co-Assistant Minority Floor Leader during the 1999 Session and as Assembly Assistant Minority Floor Leader during the 2001 Session. She served as Senate Minority Whip during one of the 2008 Special Sessions, the 2009 Session and the 2010 Special Session. She served as Senate Assistant Minority Floor Leader during the 2011 Session. Senator Cegavske served on the Assembly Committees on Education, Transportation, and Ways and Means. She served as Chair of the Senate Committee on Legislative Operations and Elections during the 2005 and 2007 Sessions. She also served on the Senate Committees on Education; Energy, Infrastructure and Transportation; Finance; Health and Education; Human Resources and Education; Human Resources and Facilities; Legislative Affairs and Operations, and Legislative Operations and Elections.

Both Senator Wiener and Senator Cegavske served on numerous interim commissions, committees and councils for the betterment of Nevada. Please mark April 25 on your calendars as the date on which we will induct Senator Valerie Wiener, and Senator and current Secretary of State, Barbara K. Cegavske into the Senate Hall of Fame.
