REMARKS FROM THE FLOOR

Senator Goicoechea requested that his remarks be entered in the Journal.

I have approximately 60 individuals from across the State representing the 4-H Cooperative Youth Development Program visiting in the Gallery today. I met with them this morning and was pleased to meet with constituents from Elko to Sandy Valley in the southern part of the State. They are a great group of kids. The University of Nevada Cooperative Extension 4-H Youth Development Program is an age-appropriate, positive youth-development program that helps shape future leaders and innovators through research-based, hands-on learning activities with a focus on academic and career readiness. Founded in the land-grant university system, the 4-H Program has grown to meet the needs and aspirations of today's youth. Youth in 4-H can participate in community or special interest clubs, after school programs, volunteering, civic engagement, service activities, camping and in-school enrichment programs. Whether they are building and exhibiting robots, raising and showing animals or writing and presenting speeches, youth in 4-H learn leadership, problem-solving, decision-making, healthy-living, citizenship and the communication skills they need to succeed.

The 4-H Youth Development Program is the largest out-of-school youth organization in the United States, with over 7 million members. There are over 61,000 young people, ages 5 to 19, engaged in 4-H programming across the State of Nevada, taking part in programs planned and initiated by Cooperative Extension personnel, in cooperation with a cadre of nearly 3,000 volunteers. Today, there are over 60 youth and adults representing the Nevada 4-H Youth Development program here today. I am wearing my 4-H tie to make them welcome.
