Remarks by Senator Hardy.

Assembly Bill No. 130 transfers all duties and authority relating to the Nevada ABLE Savings Program from the Aging and Disability Services Division of the Department of Health and Human Services to the State treasurer. The measure is effective on July 1, 2019.

The federal Achieving a Better Life Experience Act (ABLE) of 2014 permitted the creation of ABLE Accounts. These accounts are tax-advantaged savings accounts for persons who have certain qualifying disabilities and their families, and they must be established and maintained by the qualified person's state of residence.

Remarks by Senator Ratti.

Assembly Bill No. 169 is a bill I was proud to cosponsor, and it establishes the Maternal Mortality Review Committee within the Department of Health and Human Services. The

Committee is required to review incidents of maternal mortality and, to the extent that resources are available, severe maternal morbidity in this State; disseminate findings and recommendations concerning maternal mortality and severe maternal morbidity to providers of health care, medical facilities, other interested persons and the public; publish an annual report consisting of data relating to maternal mortality and severe maternal morbidity; and submit to the Legislature a biennial report containing a description of incidents reviewed by the Committee and recommendations to reduce maternal mortality and severe maternal morbidity in Nevada.

The bill authorizes the Committee to take measures necessary to perform its duties, including consulting with interested persons and entering into contracts. The Committee is entitled to certain records it deems necessary to perform its duties. Meetings of the Committee are closed to the public; its records are confidential and are not public records.

We have too many women we are losing to childbirth. This is true in the State of Nevada, and it is true across the nation. This is an effort to put together a qualified group of individuals and make sure we understand what is going on. The good news is there is funding available at the federal level. If we can get this passed and moving along before May 8th, we have the opportunity to apply for a federal grant to support these efforts. I urge your support.
