ASSEMBLY CONCURRENT RESOLUTION—Memorializing former Assemblyman and Senator Alan H. Glover.

1 WHEREAS, Alan Harney Glover was born in 1949 in Carson
2 City, Nevada, to parents Nelson and Peggy Glover, who were both
3 state officials in Nevada’s Executive Branch of State Government;
4 and
5 WHEREAS, After receiving his bachelor of science degree in
6 public administration, with minors in history and literature, from the
7 University of Nevada, Reno, Alan returned to Carson City where he
8 was a private insurance agent early in his career; and



1 WHEREAS, At 23 years of age, Alan Glover was elected to the
2 Nevada Assembly in 1972 where he represented Carson City and
3 served with distinction for the next 10 years until his election to the
4 Nevada Senate in November 1982; and

5 WHEREAS, In the midst of his legislative service, Alan married
6 his wife of 38 years, Harle, eventually raising their three children,
7 Kim, Jamie and Amanda in Carson City; and

8 WHEREAS, Assemblyman Glover served in the Assembly during
9 an important period in history, marked by America's Bicentennial in
10 1976, the end to the war in Vietnam, greatly improved relations
11 between the United States and China and Nevada's emergence as
12 the fastest growing state in the nation; and

13 WHEREAS, As a member of the Assembly, Alan Glover's
14 service included chairmanship of three standing committees: the
15 Assembly Committee on Transportation in 1973 and 1975,
16 the Assembly Committee on Legislative Functions in 1977 and the
17 Assembly Committee on Elections in 1981, and service on interim
18 study committees that were indicative of his knowledge and
19 expertise in many diverse topics; and

20 WHEREAS, Following his service in the Assembly, Alan served
21 3 years in the Senate until his appointment as Carson City Recorder
22 in 1985, which later became the elected office of Carson City Clerk-
23 Recorder, where he would continue to serve until his retirement in
24 December 2014, becoming the longest-serving Clerk in the city's
25 history, and providing the people of Nevada and his community a
26 total of 42 years of quality elective service; and

27 WHEREAS, Alan Glover was devoted to the Carson City
28 community, becoming an active member of the Knights of
29 Columbus and the Rotary Club and serving as Rotary President in
30 1997 and 1998; and

31 WHEREAS, Alan Glover was honored in November 2011 when
32 the First Judicial District Court appointed him to serve as one of
33 three Special Masters who prepared a nonpartisan plan of
34 redistricting for the State, which he considered one of the
35 accomplishments he was most proud of, a plan that remains in effect
36 today; and

37 WHEREAS, In 2015, Alan Glover was added to the Assembly
38 Wall of Distinction for his dedicated service to the Assembly and as
39 a highly respected, elected public officer of this State; now,
40 therefore, be it

41 RESOLVED BY THE ASSEMBLY OF THE STATE OF NEVADA, THE
42 SENATE CONCURRING, That the members of the 81st Session of the
43 Nevada Legislature hereby extend their deepest condolences to
44 Alan's beloved wife Harle, his daughters, Kim, Jamie and Amanda,
45 and the many members of his extended family; and be it further
