S.B. No. 340—Revises provision relating to the wages and working conditions of certain employees. (BDR 53-573)

SUMMARY—Revises provision relating to the wages and working conditions of certain employees. (BDR 53-573)

AN ACT relating to employment; requiring the Director of the Department of Health and Human Services to establish a home care employment standards board under certain circumstances; prescribing the membership of a home care employment standards board; requiring such a board to conduct an investigation into certain matters relating to the employment of home care employees; requiring such a board to develop recommendations concerning the minimum wage for home care employees or the working conditions of such employees; authorizing the Director to adopt regulations implementing such recommendations; revising provisions governing the administration and enforcement of provisions governing the minimum wage paid to employees in this State; providing penalties; making appropriations; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

Existing law requires an employer to pay an employee a wage of not less than a certain minimum wage. (Nev. Const. Art. 15, § 16; NRS 608.250) Existing law requires the Labor Commissioner to administer and enforce the provisions of existing law governing the minimum wage. (NRS 608.270)

Existing law provides for the establishment of certain programs to provide services to certain elderly persons or persons with disabilities to allow such persons to remain in their homes or in the community. (NRS 422.396, 427A.250-427A.280, 427A.793) **Section 8** of this bill designates such a program, and any similar program established by a state agency or a local government, as a “home care program.”

Existing law authorizes an agency licensed as an agency to provide personal care services in the home to provide certain authorized medical services to persons with disabilities and certain nonmedical services related to personal care to elderly persons or persons with disabilities. (NRS 449.1935) Under existing law, certain providers of temporary respite services are not required to be licensed as an agency to provide personal care services in the home. (NRS 449.0021) Existing law authorizes a certified intermediary service organization to provide certain services related to the employment of a personal assistant who is selected by a person with a disability or other responsible person to provide certain nonmedical and authorized medical services to the person with a disability. (NRS 449.4308)

19 **Section 6** of this bill designates an agency to provide personal care services in the home,
20 an intermediary service organization and certain providers of temporary respite services that
21 have entered into a contract with a state agency or a local government to provide certain
22 services under a home care program as “home care employers.” **Section 5** of this bill
23 designates a person who is an employee of a home care employer and who provides personal
24 care services, personal assistance or temporary respite services through a home care program
25 as a “home care employee.”

26 **Section 13** of this bill requires the Director of the Department of Health and Human
27 Services to establish a home care employment standards board if the Director determines that
28 it is necessary or upon the petition of 50 or more home care employees. **Section 13** sets forth
29 the membership of such a board, which consists of certain representatives of home care
30 employers and home care employees and certain other persons. **Section 14** of this bill
31 provides that if the Director establishes a home care employment standards board upon the
32 petition of 50 or more home care employees, the Director or his or her designee is required to
33 meet with representatives of the petitioners and discuss certain matters relating to the
34 employment of home care employees. **Section 15** of this bill requires the Director and the
35 Labor Commissioner to conduct an investigation into certain matters relating to the
36 employment of home care employees and present the findings of the investigation to a home
37 care employment standards board at the first meeting of the board.

38 **Section 16** of this bill requires a home care employment standards board to conduct an
39 investigation into certain matters of its choosing related to the wages and working conditions
40 of home care employees and the compliance of home care employers with applicable laws.
41 **Section 16** also requires a home care employment standards board to, based on such an
42 investigation, develop recommendations regarding: (1) the minimum wage that may be paid to
43 a home care employee; or (2) safe and healthful working conditions for home care employees.
44 **Section 16** requires a home care employment standards board to submit to the Director a
45 report with its findings and recommendations not later than 1 year after the date of its first
46 meeting. **Section 16.5** of this bill requires the Director to make any report submitted by the
47 home care employment standards board available on an Internet website maintained by the
48 Director.

49 **Section 17** of this bill authorizes the Director to take certain actions with respect to the
50 report of a home care employment standards board. Under **section 18** of this bill, if the
51 Director approves of a recommendation of such a board, the Director is required to adopt
52 regulations as necessary to: (1) establish the minimum wage recommended by the home care
53 employment standards board as the minimum wage which may be paid by a home care
54 employer to a home care employee in this State; or (2) provide for safe and healthful working
55 conditions for home care employees in accordance with the recommendation of the home care
56 employment standards board. **Section 18** also provides that if the Director establishes a
57 minimum wage for a home care employee, the Director is also authorized to adopt regulations
58 concerning the payment of overtime for such employees. **Section 21** of this bill provides that
59 such regulations prevail over the provisions of existing law governing the payment of
60 overtime generally. (NRS 608.018)

61 **Section 20** of this bill makes it a misdemeanor for a home care employer to take certain
62 actions against a home care employee because the home care employee engages in or is
63 believed to have engaged in certain activities relating to a home care employment standards
64 board.

65 **Section 22** of this bill revises provisions of existing law which authorize an employee to
66 bring a civil action against an employer who pays the employee less than the minimum wage
67 for the purpose of allowing a home care employee to bring such an action against a home care
68 employer who pays the homecare employee less than the minimum wage for a home care
69 employee established by regulation pursuant to **section 18**. (NRS 608.260)

70 **Section 23** of this bill provides for the enforcement of the provisions governing the
71 minimum wage for a home care employee established pursuant to **section 18** in the same
72 manner in which the minimum wage established under existing law is enforced. (NRS
73 608.270)

74 Existing law provides that a person who violates the provisions of existing law governing
75 the minimum wage is guilty of a misdemeanor and is subject to an administrative fine of not
76 more than \$5,000. (NRS 608.290) **Section 24** of this bill applies these same penalties to a

77 person who violates the provisions governing the minimum wage for a home care employee
78 established by the Director pursuant to **section 18**.

79 **Section 25** of this bill authorizes a home care employment standards board or the Labor
80 Commissioner to develop certain recommendations related to the outbreak of the disease
81 identified by the Centers for Disease Control and Prevention of the United States Department
82 of Health and Human Services as COVID-19 and submit such recommendations to the
83 Governor and the Legislature.

84 **Sections 3-12** of this bill define words and terms for the purposes of **sections 2-20** of this
85 bill. **Sections 26 and 27 of this bill make appropriations to the Office of the Labor**
86 **Commissioner in the Department of Business and Industry and the Division of Public**
87 **and Behavioral Health of the Department of Health and Human Services, respectively,**
88 **for personnel, operating and equipment costs to carry out the provisions of this bill.**

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 608 of NRS is hereby amended by adding thereto the
2 provisions set forth as sections 2 to 20, inclusive, of this act.

3 **Sec. 2.** *As used in sections 2 to 20, inclusive, of this act, unless the context*
4 *otherwise requires, the words and terms defined in sections 3 to 12, inclusive, of*
5 *this act have the meanings ascribed to them in those sections.*

6 **Sec. 3.** *“Agency to provide personal care services in the home” has the*
7 *meaning ascribed to it in NRS 449.0021.*

8 **Sec. 4.** *“Director” means the Director of the Department of Health and*
9 *Human Services.*

10 **Sec. 5. 1.** *“Home care employee” means a person who provides:*
11 *(a) Personal care services through a home care program as an employee of a*
12 *home care employer that is an agency to provide personal care services in the*
13 *home;*

14 *(b) Personal assistance through a home care program as a personal assistant*
15 *for whom a home care employer that is an intermediary service organization is*
16 *the employer of record; or*

17 *(c) Temporary respite services through a home care program as an employee*
18 *of a home care employer that has entered into a contract with the Aging and*
19 *Disability Services Division of the Department of Health and Human Services to*
20 *provide such services.*

21 **2.** *As used in this section, “personal assistant” has the meaning ascribed to*
22 *it in NRS 449.4308.*

23 **Sec. 6.** *“Home care employer” means:*

24 **1.** *An agency to provide personal care services in the home that has entered*
25 *into a contract with a state agency or local government to provide personal care*
26 *services under a home care program;*

27 **2.** *An intermediary service organization that has entered into a contract*
28 *with a state agency or local government to provide services relating to personal*
29 *assistance under a home care program; or*

30 **3.** *A person or agency who has entered into a contract with the Aging and*
31 *Disability Services Division of the Department of Health and Human Services to*
32 *provide temporary respite services under a home care program.*

33 **Sec. 7.** *“Home care employment standards board” means a board*
34 *established by the Director pursuant to section 13 or 17 of this act.*

35 **Sec. 8. 1.** *“Home care program” means a program established by a state*
36 *agency or a local government which provides in the home personal care services,*

1 *personal assistance or temporary respite services to elderly persons or persons*
2 *with disabilities.*

3 2. *The term includes, without limitation:*

4 (a) *Any program established under the State Plan for Medicaid which*
5 *provides, in the home, the services described in subsection 1.*

6 (b) *Any program established pursuant to NRS 427A.250 to 427A.280,*
7 *inclusive.*

8 (c) *The program established pursuant to NRS 422.396.*

9 (d) *The program established pursuant to NRS 427A.793.*

10 **Sec. 9.** *“Intermediary service organization” has the meaning ascribed to it*
11 *in NRS 449.4304.*

12 **Sec. 10.** *“Personal assistance” has the meaning ascribed to it in NRS*
13 *449.4308.*

14 **Sec. 11.** *“Personal care services” means the services described in NRS*
15 *449.1935.*

16 **Sec. 12.** *“Temporary respite services” has the meaning ascribed to it in*
17 *NRS 449.0021.*

18 **Sec. 13.** 1. *If the Director determines that it is necessary or upon the*
19 *petition of 50 or more home care employees, the Director shall establish a home*
20 *care employment standards board to conduct an investigation and develop*
21 *recommendations as provided in section 16 of this act.*

22 2. *A home care employment standards board must consist of:*

23 (a) *The Director or his or her designee, who serves as Chair and a nonvoting*
24 *member; and*

25 (b) *The following voting members:*

26 (1) *The Labor Commissioner;*

27 (2) *Three representatives of home care employers, appointed by the*
28 *Director;*

29 (3) *Three representatives of home care employees, appointed by the*
30 *Director; and*

31 (4) *Three persons who receive or are representatives of persons who*
32 *receive services from a home care employee, appointed by the Director.*

33 3. *The Director shall appoint the members of a home care employment*
34 *standards board pursuant to subparagraphs (2), (3) and (4) of paragraph (b) of*
35 *subsection 2 after providing public notice and soliciting applications for the*
36 *appointment of such members.*

37 4. *The members of a home care employment standards board serve without*
38 *compensation.*

39 5. *A majority of the voting members of a home care employment standards*
40 *board constitutes a quorum to transact business, and a majority of a quorum*
41 *present at any meeting is sufficient to approve any recommendation of such a*
42 *board.*

43 6. *A home care employment standards board shall meet at the times and*
44 *places specified by a call of the Chair. A home care employment standards board*
45 *shall meet as often as necessary to accomplish the duties set forth in section 16 of*
46 *this act, but not less than once each calendar quarter.*

47 **Sec. 14.** *If the Director establishes a home care employment standards*
48 *board upon the petition of 50 or more home care employees pursuant to section*
49 *13 of this act, the Director or his or her designee shall, not later than 30 days*
50 *after the receipt of the petition, meet with representatives of the persons who*
51 *submitted the petition and discuss matters relating to the wages and working*
52 *conditions of home care employees in this State and the compliance of home care*
53 *employers with applicable federal, state and local laws.*

1 **Sec. 15. 1.** *As soon as practicable after the appointment of the members*
2 *of a home care employment standards board pursuant to section 13 of this act,*
3 *the Director shall fix a date for the first meeting of the board. If a home care*
4 *employment standards board is established upon the petition of 50 or more home*
5 *care employees pursuant to section 13 of this act, the first meeting of the board*
6 *must be held not later than 60 days after the date of the meeting described in*
7 *section 14 of this act.*

8 2. *Before the first meeting of a home care employment standards board, the*
9 *Director and the Labor Commissioner shall conduct a preliminary investigation*
10 *into the wages and working conditions of home care employees in this State and*
11 *the compliance of home care employers with applicable federal, state and local*
12 *laws. The Director and the Labor Commissioner shall coordinate with the Aging*
13 *and Disability Services Division of the Department, the Division of Health Care*
14 *Financing and Policy of the Department and the Division of Public and*
15 *Behavioral Health of the Department as necessary to complete the investigation.*

16 3. *The Director and the Labor Commissioner shall present the results of the*
17 *preliminary investigation conducted pursuant to subsection 2 to the home care*
18 *employment standards board at the first meeting of the board.*

19 4. *As used in this section, "Department" means the Department of Health*
20 *and Human Services.*

21 **Sec. 16. 1.** *A home care employment standards board shall:*

22 (a) *Conduct an investigation into matters relating to the wages and working*
23 *conditions of home care employees in this State and the compliance of home care*
24 *employers with applicable federal, state and local laws; and*

25 (b) *Based on the investigation conducted pursuant to paragraph (a), develop*
26 *recommendations regarding:*

27 (1) *The minimum wage that may be paid to a home care employee in this*
28 *State; or*

29 (2) *Safe and healthful working conditions for home care employees.*

30 2. *A home care employment standards board shall determine the scope of its*
31 *investigation conducted pursuant to paragraph (a) of subsection 1 and the*
32 *specific matters into which it will inquire, which may include, without limitation:*

33 (a) *The adequacy of wage rates and other compensation policies of home*
34 *care employers to ensure the provision of quality services and sufficient levels of*
35 *recruitment and retention of home care employees;*

36 (b) *The sufficiency of levels of recruitment and retention of home care*
37 *employees;*

38 (c) *The adequacy of the role of home care employees in making decisions*
39 *affecting their wages and working conditions;*

40 (d) *The adequacy and enforcement of training requirements for home care*
41 *employees;*

42 (e) *The impact of home care programs, the larger system for long-term care*
43 *in this State and any efforts to reach the goal of rebalancing long-term care*
44 *services toward home and community-based services on the wages and working*
45 *conditions of home care employees;*

46 (f) *The impact of systemic racism and economic injustice on home care*
47 *employees and the adequacy of efforts to alleviate such impact through the*
48 *development of career paths through partnerships between labor and*
49 *management and other methods; and*

50 (g) *The adequacy of payment practices and policies of the State as such*
51 *practices and policies relate to the reimbursement of home care employers for the*
52 *provision of services under a home care program.*

1 3. *In conducting the investigation pursuant to paragraph (a) of subsection*
2 *1, a home care employment standards board shall have the power to administer*
3 *oaths, take testimony thereunder and issue subpoenas for the attendance of*
4 *witnesses and the production of books, papers and any other materials relevant to*
5 *the investigation.*

6 4. *A home care employment standards board may request information*
7 *relevant to the investigation conducted pursuant to paragraph (a) of subsection 1*
8 *directly from any state agency. A state agency that receives a reasonable request*
9 *for information from a home care employment standards board shall comply with*
10 *the request as soon as is reasonably practicable after receiving the request.*

11 5. *A home care employment standards board may request direct testimony*
12 *from any state agency at a meeting of the board. The head, or a designee thereof,*
13 *of a state agency who receives a reasonable request for direct testimony at a*
14 *meeting of a home care employment standards board shall appear at the meeting*
15 *and shall comply with the request.*

16 6. *Not later than 1 year after the date of the first meeting of a home care*
17 *employment standards board, the board shall submit to the Director a report of its*
18 *findings and recommendations.*

19 **Sec. 16.5.** *The Director shall make any report submitted by a home care*
20 *employment standards board pursuant to section 16 of this act available on an*
21 *Internet website maintained by the Director.*

22 **Sec. 17.** *Upon receipt of a report submitted by a home care employment*
23 *standards board pursuant to subsection 6 of section 16 of this act, the Director*
24 *shall review the findings and each recommendation contained in the report. The*
25 *Director may:*

26 1. *Approve or disapprove any recommendation;*

27 2. *Require the home care employment standards board that submitted the*
28 *report to conduct a new investigation and develop new recommendations in*
29 *accordance with section 16 of this act; or*

30 3. *Establish a new home care employment standards board in the manner*
31 *provided in section 13 of this act to conduct a new investigation and develop new*
32 *recommendations in accordance with section 16 of this act.*

33 **Sec. 18.** 1. *If the Director approves a recommendation contained in a*
34 *report submitted by a home care employment standards board pursuant to*
35 *subsection 6 of section 16 of this act, the Director shall adopt regulations*
36 *necessary to:*

37 (a) *Establish the minimum wage recommended by the home care*
38 *employment standards board as the minimum wage which may be paid to a home*
39 *care employee in this State; or*

40 (b) *Provide for safe and healthful working conditions for home care*
41 *employees in accordance with the recommendation of the home care employment*
42 *standards board.*

43 2. *If the Director adopts regulations establishing the minimum wage which*
44 *may be paid to a home care employee pursuant to paragraph (a) of subsection 1,*
45 *the Director may also adopt any regulations concerning the payment of overtime*
46 *to a home care employee which the Director deems appropriate and which are*
47 *consistent with federal law.*

48 **Sec. 19.** *If the Director adopts regulations establishing the minimum wage*
49 *which may be paid to a home care employee pursuant to section 18 of this act:*

50 1. *Each home care employer shall pay to each home care employee of the*
51 *employer a wage of not less than the minimum wage established by regulation of*
52 *the Director pursuant to section 18 of this act.*

1 **2. It is unlawful for a home care employer to employ, cause to be employed**
2 **or permit to be employed, or to contract with, cause to be contracted with or**
3 **permit to be contracted with, any home care employee for a wage less than that**
4 **established by regulation of the Director pursuant to section 18 of this act.**

5 **Sec. 20. 1. It is unlawful for a home care employer in this State to**
6 **discharge, discipline, discriminate against in any manner or deny employment or**
7 **promotion to, or threaten to take any such action against, a home care employee**
8 **because:**

9 **(a) The home care employee serves as a member of a home care employment**
10 **standards board;**

11 **(b) The home care employee has actively participated in the formation of a**
12 **home care employment standards board;**

13 **(c) The home care employee has testified or is about to testify in an**
14 **investigation conducted by a home care employment standards board;**

15 **(d) The home care employee has engaged in any other activity related to the**
16 **formation or activities of a home care employment standards board; or**

17 **(e) The home care employer believes that the home care employee may**
18 **engage in any of the activities described in paragraphs (a) to (d), inclusive.**

19 **2. A home care employer who violates the provisions of subsection 1 is**
20 **guilty of a misdemeanor and shall be punished by a fine of not more than \$1,000.**

21 **Sec. 21.** NRS 608.018 is hereby amended to read as follows:

22 608.018 1. An employer shall pay 1 1/2 times an employee's regular wage
23 rate whenever an employee who receives compensation for employment at a rate
24 less than 1 1/2 times the minimum rate set forth in NRS 608.250 works:

25 (a) More than 40 hours in any scheduled week of work; or

26 (b) More than 8 hours in any workday unless by mutual agreement the
27 employee works a scheduled 10 hours per day for 4 calendar days within any
28 scheduled week of work.

29 2. An employer shall pay 1 1/2 times an employee's regular wage rate
30 whenever an employee who receives compensation for employment at a rate not
31 less than 1 1/2 times the minimum rate set forth in NRS 608.250 works more than
32 40 hours in any scheduled week of work.

33 3. The provisions of subsections 1 and 2 do not apply to:

34 (a) Employees who are not covered by the minimum wage provisions of
35 Section 16 of Article 15 of the Nevada Constitution;

36 (b) Outside buyers;

37 (c) Employees in a retail or service business if their regular rate is more than 1
38 1/2 times the minimum wage, and more than half their compensation for a
39 representative period comes from commissions on goods or services, with the
40 representative period being, to the extent allowed pursuant to federal law, not less
41 than 1 month;

42 (d) Employees who are employed in bona fide executive, administrative or
43 professional capacities;

44 (e) Employees covered by collective bargaining agreements which provide
45 otherwise for overtime;

46 (f) Drivers, drivers' helpers, loaders and mechanics for motor carriers subject
47 to the Motor Carrier Act of 1935, as amended;

48 (g) Employees of a railroad;

49 (h) Employees of a carrier by air;

50 (i) Drivers or drivers' helpers making local deliveries and paid on a trip-rate
51 basis or other delivery payment plan;

52 (j) Drivers of taxicabs or limousines;

53 (k) Agricultural employees;

1 (l) Employees of business enterprises having a gross sales volume of less than
2 \$250,000 per year;

3 (m) Any salesperson or mechanic primarily engaged in selling or servicing
4 automobiles, trucks or farm equipment;

5 (n) A mechanic or worker for any hours to which the provisions of subsection
6 3 or 4 of NRS 338.020 apply;

7 (o) A domestic worker who resides in the household where he or she works if
8 the domestic worker and his or her employer agree in writing to exempt the
9 domestic worker from the requirements of subsections 1 and 2; and

10 (p) A domestic service employee who resides in the household where he or she
11 works if the domestic service employee and his or her employer agree in writing to
12 exempt the domestic service employee from the requirements of subsections 1 and
13 2.

14 4. *Any regulation of the Director of the Department of Health and Human*
15 *Services concerning the payment of overtime to a home care employee adopted*
16 *pursuant to section 18 of this act prevails over the general provisions of this*
17 *section.*

18 5. As used in this section ~~["domestic"]~~ :

19 (a) "Domestic worker" has the meaning ascribed to it in NRS 613.620.

20 (b) "Home care employee" has the meaning ascribed to it in section 5 of this
21 act.

22 **Sec. 22.** NRS 608.260 is hereby amended to read as follows:

23 608.260 1. If any employer pays any employee a lesser amount than the
24 minimum wage set forth in NRS 608.250 ~~[""]~~ *or, if applicable, the minimum wage*
25 *established by regulation of the Director of the Department of Health and*
26 *Human Services pursuant to section 18 of this act*, the employee may, at any time
27 within 2 years, bring a civil action against the employer. A contract between the
28 employer and the employee or any acceptance of a lesser wage by the employee is
29 not a bar to the action.

30 2. If the employee prevails in a civil action brought pursuant to subsection 1:

31 (a) The employee is entitled to all remedies available under the law or in equity
32 appropriate to remedy the violation by the employer which may include, without
33 limitation, back pay, damages, reinstatement or injunctive relief; and

34 (b) The court must award the employee reasonable attorney's fees and costs.

35 **Sec. 23.** NRS 608.270 is hereby amended to read as follows:

36 608.270 1. The Labor Commissioner shall:

37 (a) Administer and enforce the provisions of NRS 608.250 ~~[""]~~ *and section 18*
38 *of this act;*

39 (b) Adopt any regulations necessary to carry out the duties set forth in
40 paragraph (a); and

41 (c) Furnish the district attorney of any county or the Attorney General all data
42 and information concerning violations of the provisions of NRS 608.250 ~~[""]~~ *or*
43 *section 18 of this act*, occurring in the county coming to the attention of the Labor
44 Commissioner.

45 2. Each district attorney shall, if a complaint is made to him or her by the
46 Labor Commissioner or by any aggrieved person, prosecute each violation of the
47 provisions of NRS 608.250 *or section 18 of this act* that occurs in the district
48 attorney's county. If any such district attorney fails, neglects or refuses for 20 days
49 to commence a prosecution for a violation of the provisions of NRS 608.250 ~~[""]~~ *or*
50 *section 18 of this act*, after being furnished data and information concerning the
51 violation, and diligently to prosecute the same to conclusion, the district attorney is
52 guilty of a misdemeanor, and in addition thereto must be removed from office.

1 **Sec. 24.** NRS 608.290 is hereby amended to read as follows:
2 608.290 1. Any person who violates any provision of NRS 608.250 ,
