SUMMARY—Revises provisions governing public utilities. (BDR 58-46)

AN ACT relating to utilities; revising provisions governing partial tax abatements for certain renewable energy facilities; revising provisions governing the use of money in the Renewable Energy Account; repealing provisions governing the Electric Vehicle Infrastructure Demonstration Program; requiring an electric utility to submit a plan to accelerate transportation electrification in this State; requiring an electric utility to file a plan for certain high-voltage transmission infrastructure projects; requiring the Public Utilities Commission of Nevada to require a transmission provider to join a regional transmission organization; creating and setting forth the powers, duties and membership of the Regional Transmission Coordination Task Force; providing that there is no presumption that the expenditures of a utility were prudently incurred for certain purposes; revising the definition of public utility; revising provisions governing the disposal of generation assets; revising provisions governing the Economic Development Electric Rate Rider Program; revising requirements for the energy efficiency plan of an electric utility; abolishing the New Energy Industry Task Force; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

- 1 Existing law authorizes a person who intends to locate a facility for the generation of
- 2 process heat from solar renewable energy or a wholesale facility for the generation of
- 3 renewable energy in this State to apply to the Director of the Office of Energy within the
- 4 Office of the Governor for a partial abatement of certain sales and use taxes or property taxes.
- 5 (NRS 701A.360) **Section 7** of this bill authorizes a person who intends to locate a facility for

6 the storage of energy from renewable generation or a hybrid renewable generation and energy
7 storage facility in this State to apply for this partial tax abatement as well. **Sections 3-5** of this
8 bill define additional terms related to this partial tax abatement. **Section 8** of this bill makes a
9 conforming change to reflect that a partial tax abatement may be granted for a facility for the
10 storage of energy from renewable generation or a hybrid renewable generation and energy
11 storage facility **H** and revises the meaning of the term “wages” for the purposes of
12 determining the eligibility of certain renewable energy facilities for certain partial tax
13 abatements.

14 Existing law creates the Renewable Energy Account and requires that not less than
15 75 percent of the money in the Account be used to offset the cost of electricity to or the
16 use of electricity by certain retail electric customers. (NRS 701A.450) Section 8.5 of this
17 bill removes this requirement and instead provides that the money in the Account must
18 be used for such purposes as the Director may establish by regulation.

19 Existing law creates an Electric Vehicle Infrastructure Demonstration Program, in
20 connection with which a utility is required to submit to the Public Utilities Commission of
21 Nevada an annual plan for carrying out the Program in the service area of the utility. (NRS
22 701B.670) **Section 10** of this bill removes the requirement for a utility to submit an annual
23 plan for carrying out the Program. **Section 56** of this bill repeals the remaining provisions of
24 law relating to the Program. **Sections 9 and 48** of this bill remove provisions of law which
25 reference the Program.

26 Existing law requires each electric utility to submit to the Public Utilities Commission of
27 Nevada every 3 years an integrated resource plan to increase the utility’s supply of electricity
28 or decrease the demands made on its system by its customers. Existing law provides that the
29 integrated resource plan must include certain components, including, without limitation, a
30 plan for the construction or expansion of transmission facilities to serve renewable energy
31 zones and to facilitate the utility in meeting the portfolio standard. (NRS 704.741) **Sections 39**
32 **and 41** of this bill remove the requirement for an electric utility to include a plan for the
33 construction or expansion of transmission facilities to serve renewable energy zones and to
34 facilitate the utility in meeting the portfolio standard in its resource plan. Instead, **sections 15-**
35 **24** of this bill require an electric utility, on or before September 1, 2021, to amend its most
36 recently filed resource plan to include a plan for certain high-voltage transmission
37 infrastructure construction projects that will be placed into service not later than December 31,
38 2028. **Section 39** requires the integrated resource plan, with respect to the possible sources of
39 supply of the electric utility, to include at least one scenario of low carbon dioxide emissions
40 that uses sources of supply that will achieve certain reductions in carbon dioxide emissions.
41 **Sections 39 and 41** also revise provisions governing the proposal for certain expenditures
42 related to energy efficiency and conservation programs which must be included in the
43 integrated resource plan.

44 **Section 30** of this bill requires the Public Utilities Commission of Nevada to require
45 every transmission provider in this State to join a regional transmission organization on or
46 before January 1, 2030, unless the transmission provider obtains a waiver or delay of the
47 requirement from the Commission. **Sections 26-29** of this bill define terms related to
48 transmission providers and regional transmission organizations.

49 **Sections 31-34** of this bill create and set forth the membership and duties of the Regional
50 Transmission Coordination Task Force. **Section 33** of this bill requires the Task Force to
51 advise the Governor and the Legislature on topics and policies related to energy transmission
52 in this State, including the costs and benefits of the transmission providers in this State joining
53 a regional transmission organization. **Sections 26-29** of this bill define terms related to
54 regional transmission organizations and the Task Force.

55 **Sections 14 and 39** of this bill require an electric utility to include a plan to accelerate
56 transportation electrification in the distributed resources plan submitted by the utility as part
57 of its integrated resource plan. **Section 40** of this bill establishes factors which must be
58 considered by the Commission in deciding whether to accept or modify a transportation
59 electrification plan which has been submitted by a utility. **Section 1** of this bill sets forth
60 certain findings of the Legislature which are relevant to the transportation electrification plan.
61 **Section 51** of this bill provides that an electric utility is not required to include a
62 transportation electrification plan in its resource plan filed on or before June 1, 2021, but an
63 electric utility is required to file an amendment to its resource plan to add a transportation

64 electrification plan on or before September 1, 2022. **Section 38** of this bill makes a
65 conforming change.

66 **Section 49** of this bill requires an electric utility, on or before September 1, 2021, to file a
67 plan to invest in certain transportation electrification programs during the period beginning
68 January 1, 2022, and ending on December 31, 2024, and establishes requirements for the
69 contents of the transportation electrification investment plan for that period. **Section 49** also
70 establishes requirements for the review and the acceptance or modification of the
71 transportation electrification investment plan by the Commission.

72 **Section 35** of this bill provides that there is no presumption that the expenses,
73 investments or other costs incurred by a utility were prudently incurred and places the burden
74 on the utility to demonstrate that expenses, investments or other costs were prudently and
75 reasonably incurred. **Section 37** of this bill makes a conforming change to indicate the proper
76 placement of **section 35** in the Nevada Revised Statutes.

77 **Section 36** of this bill provides that a person is not a public utility if he or she owns or
78 operates a net metering system that provides electricity to multiple units or spaces on the same
79 premises as the net metering system if the electricity is delivered only to units or spaces on the
80 same premises as the net metering system, there are no individual meters measuring electricity
81 use by the units or spaces and the persons occupying the units or spaces are not charged for
82 electricity based upon volumetric electricity use.

83 Existing law authorizes an electric utility to dispose of its generation assets pursuant to an
84 authorized merger, acquisition or transaction or pursuant to an authorized transfer of its
85 certificate of public convenience and necessity if the merger, acquisition, transaction or
86 transfer satisfies certain requirements, including that the other person in the merger,
87 acquisition, transaction or transfer is not a subsidiary, affiliate or a person that holds a
88 controlling interest in the electric company. (NRS 704.7591) **Section 42** of this bill removes
89 the requirement that the other person involved in the merger, acquisition, transaction or
90 transfer is not a subsidiary, affiliate or a person that holds a controlling interest in the electric
91 utility and instead requires that the disposal of the generation assets be approved in an order
92 issued by the Commission.

93 Existing law establishes the Economic Development Electric Rate Rider Program to
94 encourage the location or relocation of new businesses in this State by providing discounted
95 rates for electricity to eligible participants. (NRS 704.7871-704.7882) The Commission is
96 required to establish the discounted electric rates that may be charged pursuant to the Program
97 as a percentage of the base tariff energy rate. (NRS 704.7881) Existing law prohibits the
98 Office of Economic Development within the Office of the Governor from accepting an
99 application or approving an applicant for participation in the Program after the earlier of
100 December 31, 2017, or the date on which the capacity set aside for allocation pursuant to the
101 Program is fully allocated. (NRS 704.788) **Section 45** of this bill prohibits the Office of
102 Economic Development from accepting an application or approving an applicant for
103 participation in the Program after the earlier of December 31, 2024, or the date on which the
104 capacity set aside for allocation pursuant to the Program is fully allocated. **Section 46** of this
105 bill modifies provisions governing the maximum amount of the discount which the
106 Commission is authorized to establish for the rate charged under the Program. **Section 47** of
107 this bill requires the Commission to submit a report concerning the Program on or before
108 December 31, 2022, for transmittal to the 82nd Session of the Legislature.

109 Existing law requires the Commission to establish goals for energy savings for each
110 electric utility for each calendar year and also requires each electric utility to implement an
111 energy efficiency plan which is cost effective and designed to meet the goals for energy
112 savings established by the Commission. Existing law further requires that at least 5 percent of
113 the expenditures related to energy efficiency programs must be directed toward low-income
114 customers of the electric utility. (NRS 704.741, 704.7836) **Sections 39, 41 and 44** of this bill
115 require that at least 10 percent of the expenditures related to energy efficiency programs must
116 be spent on energy efficiency measures for customers in low-income households and
117 residential customers and public schools in historically underserved communities.
118 Additionally, **section 44** provides that programs that can offer variable incentive levels must
119 offer higher incentive levels for low-income households. **Section 54** of this bill requires an
120 electric utility to amend its energy efficiency plan to conform with the amendatory provisions
121 of this bill. **Sections 12 and 13** of this bill define terms relating to the energy efficiency plan.

122 **Section 43** makes a conforming change to indicate the proper placement of **sections 12 and**
123 **13** in the Nevada Revised Statutes.

124 Existing law creates the New Energy Industry Task Force which is charged with advising
125 the Director of the Office of Energy on measures to promote the development of renewable
126 energy and energy efficiency projects. (NRS 701.500, 701.510) **Section 55** of this bill
127 abolishes the Task Force.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** The Legislature hereby finds and declares that:

2 1. Human activities, including, without limitation, the burning of fossil fuels
3 for electricity, transportation and heat in buildings, cause the release of greenhouse
4 gases that trap heat in the Earth's atmosphere, and these human activities have been
5 and continue to be the primary driver of global climate change.

6 2. The transportation sector now accounts for the greatest percentage of
7 greenhouse gas emission in Nevada, and, based on current policies, is projected to
8 remain the largest contributor of greenhouse gas emissions through 2030.

9 3. Pursuant to NRS 445B.380, the Legislature has established goals to
10 achieve reductions in Nevada's net greenhouse gas emissions, relative to 2005
11 emissions, of 28 percent by the year 2025, 45 percent by the year 2030 and zero or
12 near-zero emissions by the year 2050.

13 4. Meeting these greenhouse gas emission goals will require substantial
14 further reductions in Nevada's transportation sector emissions below the current
15 projected emission levels for that sector for 2025 and 2030.

16 5. Accelerating the use of electric vehicles will help preserve Nevada's
17 climate and help protect Nevadans from unhealthy air pollution.

18 6. Accelerating the use of electric vehicles will reduce pollution in low-
19 income neighborhoods and communities of color that traditionally have been most
20 affected by transportation pollution.

21 7. The acceleration of the use of electric vehicles will be assisted by
22 investments in the infrastructure necessary to maximize the benefits of the
23 expanding electric vehicle market.

24 8. Widespread adoption of electric vehicles requires that electric utilities
25 increase access to electricity as a transportation fuel, including access for low-
26 income Nevadans and historically underserved communities.

27 9. Widespread adoption of electric vehicles should provide consumers with
28 fuel cost savings and electric utility customers with potential cost-saving benefits.

29 10. Widespread adoption of electric vehicles should stimulate innovation,
30 competition and increased choices in charging equipment and networks and should
31 also attract private capital investments and create high-quality jobs in Nevada.

32 11. Widespread adoption of electric vehicles should improve an electric
33 utility's electrical system efficiency and operational flexibility, including, without
34 limitation, the ability of the electric utility to integrate variable renewable energy
35 generation resources and to make use of off-peak generation resources.

36 **Sec. 2.** Chapter 701A of NRS is hereby amended by adding thereto the
37 provisions set forth as sections 3, 4 and 5 of this act.

38 **Sec. 3.** *"Energy storage technology" means technology that stores energy*
39 *as potential, kinetic, chemical or thermal energy that can be released ~~as electric~~*
40 *power] at a later time, including, without limitation, batteries, flywheels,*
41 *electrochemical capacitors, compressed-air storage and thermal storage devices.*

1 **Sec. 4. 1. “Facility for the storage of energy from renewable generation”**
2 *means a facility that is constructed or installed for the sole purpose of storing*
3 *electric energy received from a facility for the generation of electricity from*
4 *renewable energy for release ~~for electric power~~ at a later time, including, without*
5 *limitation, a facility that is designed to use energy storage technology.*

6 **2. The term does not include a facility that is located on a residential**
7 *property.*

8 **Sec. 5. “Hybrid renewable generation and energy storage facility” means a**
9 *facility that includes both a wholesale facility for the generation of electricity*
10 *from renewable energy and a facility for the storage of energy from renewable*
11 *generation.*

12 **Sec. 6.** NRS 701A.300 is hereby amended to read as follows:

13 701A.300 As used in NRS 701A.300 to 701A.390, inclusive, *and sections 3,*
14 *4 and 5 of this act*, unless the context otherwise requires, the words and terms
15 defined in NRS 701A.305 to 701A.345, inclusive, *and sections 3, 4 and 5 of this*
16 *act* have the meanings ascribed to them in those sections.

17 **Sec. 7.** NRS 701A.360 is hereby amended to read as follows:

18 701A.360 1. A person who intends to locate a facility for the generation of
19 process heat from solar renewable energy , ~~for~~ a wholesale facility for the
20 generation of electricity from renewable energy , *a facility for the storage of*
21 *energy from renewable generation or a hybrid renewable generation and energy*
22 *storage facility* in this State may apply to the Director for a partial abatement of the
23 local sales and use taxes, the taxes imposed pursuant to chapter 361 of NRS, or
24 both local sales and use taxes and taxes imposed pursuant to chapter 361 of NRS.
25 An applicant may submit a copy of the application to the board of county
26 commissioners at any time after the applicant has submitted the application to the
27 Director.

28 2. A facility that is owned, operated, leased or otherwise controlled by a
29 governmental entity is not eligible for an abatement pursuant to NRS 701A.300 to
30 701A.390, inclusive ~~H~~, *and sections 3, 4 and 5 of this act.*

31 3. As soon as practicable after the Director receives an application for a
32 partial abatement, the Director shall forward a copy of the application to:

- 33 (a) The Chief of the Budget Division of the Office of Finance;
34 (b) The Department of Taxation;
35 (c) The board of county commissioners;
36 (d) The county assessor;
37 (e) The county treasurer; and
38 (f) The Office of Economic Development.

39 4. With the copy of the application forwarded to the county treasurer, the
40 Director shall include a notice that the local jurisdiction may request a presentation
41 regarding the facility. A request for a presentation must be made within 30 days
42 after receipt of the application.

43 5. The Director shall hold a public hearing on the application. The hearing
44 must not be held earlier than 30 days after all persons listed in subsection 3 have
45 received a copy of the application.

46 **Sec. 8.** NRS 701A.365 is hereby amended to read as follows:

47 701A.365 1. The Director, in consultation with the Office of Economic
48 Development, shall approve an application for a partial abatement pursuant to NRS
49 701A.300 to 701A.390, inclusive, *and sections 3, 4 and 5 of this act* if the
50 Director, in consultation with the Office of Economic Development, makes the
51 following determinations:

- 52 (a) The applicant has executed an agreement with the Director which must:

1 (1) State that the facility will, after the date on which the abatement
2 becomes effective, continue in operation in this State for a period specified by the
3 Director, which must be at least 10 years, and will continue to meet the eligibility
4 requirements for the abatement; and

5 (2) Bind the successors in interest in the facility for the specified period.

6 (b) The facility is registered pursuant to the laws of this State or the applicant
7 commits to obtain a valid business license and all other permits required by the
8 county, city or town in which the facility operates.

9 (c) No funding is or will be provided by any governmental entity in this State
10 for the acquisition, design or construction of the facility or for the acquisition of
11 any land therefor, except any private activity bonds as defined in 26 U.S.C. § 141.

12 (d) Except as otherwise provided in paragraph (e), if the facility will be located
13 in a county whose population is 100,000 or more or a city whose population is
14 60,000 or more, the facility meets the following requirements:

15 (1) There will be 75 or more full-time employees working on the
16 construction of the facility during the second quarter of construction, including,
17 unless waived by the Director for good cause, at least 50 percent who are residents
18 of Nevada;

19 (2) Establishing the facility will require the facility to make a capital
20 investment of at least \$10,000,000 in this State in capital assets that will be retained
21 at the location of the population until at least the date which is 5 years after the date on
22 which the abatement becomes effective;

23 (3) The average hourly wage that will be paid by the facility to its
24 employees in this State is at least 110 percent of the average statewide hourly wage,
25 excluding management and administrative employees, as established by the
26 Employment Security Division of the Department of Employment, Training and
27 Rehabilitation on July 1 of each fiscal year; and

28 (4) Except as otherwise provided in subsection 6, the average hourly wage
29 of the employees working on the construction of the facility will be at least 175
30 percent of the average statewide hourly wage, excluding management and
31 administrative employees, as established by the Employment Security Division of
32 the Department of Employment, Training and Rehabilitation on July 1 of each
33 fiscal year and:

34 (I) The employees working on the construction of the facility must be
35 provided a health insurance plan that is provided by a third-party administrator and
36 includes health insurance coverage for dependents of the employees; and

37 (II) The cost of the benefits provided to the employees working on the
38 construction of the facility will meet the minimum requirements for benefits
39 established by the Director by regulation pursuant to NRS 701A.390.

40 (e) If the facility will be located in a county whose population is less than
41 100,000, in an area of a county whose population is 100,000 or more that is located
42 within the geographic boundaries of an area that is designated as rural by the United
43 States Department of Agriculture and at least 20 miles outside of the geographic
44 boundaries of an area designated as urban by the United States Department of
45 Agriculture, or in a city whose population is less than 60,000, the facility meets the
46 following requirements:

47 (1) There will be 50 or more full-time employees working on the
48 construction of the facility during the second quarter of construction, including,
49 unless waived by the Director for good cause, at least 50 percent who are residents
50 of Nevada;

51 (2) Establishing the facility will require the facility to make a capital
52 investment of at least \$3,000,000 in this State in capital assets that will be retained

1 at the location of the facility until at least the date which is 5 years after the date on
2 which the abatement becomes effective;

3 (3) The average hourly wage that will be paid by the facility to its
4 employees in this State is at least 110 percent of the average statewide hourly wage,
5 excluding management and administrative employees, as established by the
6 Employment Security Division of the Department of Employment, Training and
7 Rehabilitation on July 1 of each fiscal year; and

8 (4) Except as otherwise provided in subsection 6, the average hourly wage
9 of the employees working on the construction of the facility will be at least 175
10 percent of the average statewide hourly wage, excluding management and
11 administrative employees, as established by the Employment Security Division of
12 the Department of Employment, Training and Rehabilitation on July 1 of each
13 fiscal year and:

14 (I) The employees working on the construction of the facility must be
15 provided a health insurance plan that is provided by a third-party administrator and
16 includes health insurance coverage for dependents of the employees; and

17 (II) The cost of the benefits provided to the employees working on the
18 construction of the facility will meet the minimum requirements for benefits
19 established by the Director by regulation pursuant to NRS 701A.390.

20 (f) The financial benefits that will result to this State from the employment by
21 the facility of the residents of this State and from capital investments by the facility
22 in this State will exceed the loss of tax revenue that will result from the abatement.

23 (g) The facility is consistent with the State Plan for Economic Development
24 developed by the Executive Director of the Office of Economic Development
25 pursuant to subsection 2 of NRS 231.053.

26 2. The Director shall not approve an application for a partial abatement of the
27 taxes imposed pursuant to chapter 361 of NRS submitted pursuant to NRS
28 701A.360 by a facility for the generation of process heat from solar renewable
29 energy , ~~for~~ a wholesale facility for the generation of electricity from renewable
30 energy , *a facility for the storage of energy from renewable generation or a hybrid
31 renewable generation and energy storage facility* unless the application is
32 approved or deemed approved pursuant to this subsection. The board of county
33 commissioners of a county must provide notice to the Director that the board
34 intends to consider an application and, if such notice is given, must approve or deny
35 the application not later than 30 days after the board receives a copy of the
36 application. The board of county commissioners:

37 (a) Shall, in considering an application pursuant to this subsection, make a
38 recommendation to the Director regarding the application;

39 (b) May, in considering an application pursuant to this subsection, deny an
40 application only if the board of county commissioners determines, based on
41 relevant information, that:

42 (1) The projected cost of the services that the local government is required
43 to provide to the facility will exceed the amount of tax revenue that the local
44 government is projected to receive as a result of the abatement; or

45 (2) The projected financial benefits that will result to the county from the
46 employment by the facility of the residents of this State and from capital
47 investments by the facility in the county will not exceed the projected loss of tax
48 revenue that will result from the abatement;

49 (c) Must not condition the approval of the application on a requirement that the
50 facility agree to purchase, lease or otherwise acquire in its own name or on behalf
51 of the county any infrastructure, equipment, facilities or other property in the
52 county that is not directly related to or otherwise necessary for the construction and
53 operation of the facility; and

1 (d) May, without regard to whether the board has provided notice to the
2 Director of its intent to consider the application, make a recommendation to the
3 Director regarding the application.

4 ➤ If the board of county commissioners does not approve or deny the application
5 within 30 days after the board receives from the Director a copy of the application,
6 the application shall be deemed approved.

7 3. Notwithstanding the provisions of subsection 1, the Director, in
8 consultation with the Office of Economic Development, may, if the Director, in
9 consultation with the Office, determines that such action is necessary:

10 (a) Approve an application for a partial abatement for a facility that does not
11 meet any requirement set forth in subparagraph (1) or (2) of paragraph (d) of
12 subsection 1 or subparagraph (1) or (2) of paragraph (e) of subsection 1; or

13 (b) Add additional requirements that a facility must meet to qualify for a partial
14 abatement.

15 4. The Director shall cooperate with the Office of Economic Development in
16 carrying out the provisions of this section.

17 5. The Director shall submit to the Office of Economic Development an
18 annual report, at such a time and containing such information as the Office may
19 require, regarding the partial abatements granted pursuant to this section.

21 electric utility or a third-party provider.

22 (2) May include the establishment of electric utility-owned energy storage
23 systems or renewable energy systems which minimize the impact to the grid by
24 reducing the peak demand for electricity.

25 (c) A Public Agency Electric Vehicle Charging Program to serve the public,
26 workplace and fleet electric charging needs of federal, state and local governmental
27 agencies by reducing the financial barrier for the deployment of electric vehicle
28 charging infrastructure for governmental agencies. The electric utility shall set forth
29 in the plan specific targets and allocations for level 2 electric vehicle charging
30 infrastructure, which must be developed in coordination with the Department of
31 Administration, the State Department of Conservation and Natural Resources, the
32 Department of Transportation and the Office of Energy with the aim of maximizing
33 the Program's effectiveness and utilization. An electric vehicle charging station
34 which is installed under the Program may be owned by a public agency, the electric
35 utility or a third-party provider.

36 (d) A Transit, School Bus and Transportation Electrification Custom Program
37 to serve the electric vehicle charging infrastructure, energy supply and energy
38 storage needs of transit agencies, metropolitan planning organizations, the
39 Department of Transportation, public school districts and nongovernmental
40 commercial customers in this State. The electric utility shall not allow a
41 nongovernmental commercial customer to participate in the Transit, School Bus
42 and Transportation Electrification Custom Program unless, as a condition of
43 participation, the nongovernmental commercial customer electrifies more than 50
44 company vehicles or more than 25 percent of its fleet, and satisfies such additional
45 qualifications as the electric utility may establish. As part of the Transit, School
46 Bus and Transportation Electrification Custom Program, an electric utility may
47 partner with a commercial site to allow for multiple ownership options for the
48 electrical supply, storage and charging equipment, including, without limitation,
49 ownership by the electric utility.

50 (e) An Outdoor Recreation and Tourism Program to serve the electric vehicle
51 charging infrastructure, energy supply and energy storage needs of the tourism and
52 outdoor recreation economy of this State. Eligibility for any customer participation
53 in the Outdoor Recreation and Tourism Program must be offered by the electric

1 utility on a nondiscriminatory basis to both the utility's bundled retail customers
2 and eligible customers, as defined in NRS 704B.080, who purchase or plan to
3 purchase electricity from a provider of new electric resources, as defined in NRS
4 704B.130. As part of the Outdoor Recreation and Tourism Program, an electric
5 utility may partner with a commercial site to allow for multiple ownership options
6 for the electrical supply, storage and charging equipment, including, without
7 limitation, ownership by the electric utility.

8 4. The plan filed pursuant to this section must include any proposed schedules
9 necessary to implement the programs set forth in subsection 3.

10 5. Not less than:

11 (a) Forty percent of the total program expenditures proposed in a plan
12 submitted pursuant to this section must be dedicated to investments made in or for
13 the benefit of historically underserved communities.

14 (b) Twenty percent of the total program expenditures proposed in a plan
15 submitted pursuant to this section must be dedicated to investments in the Outdoor
16 Recreation and Tourism Program pursuant to paragraph (e) of subsection 3.

17 (c) Twenty percent of the total program expenditures proposed in a plan
18 submitted pursuant to this section must be dedicated to incentives for behind-the-
19 meter investments in electric vehicle charging infrastructure or stations.

20 6. An electric utility shall submit to the Commission any program, software,
21 contract or other instrument that may be used for the billing, control, operation or
22 maintenance of the public and private chargers installed under a plan filed pursuant
23 to this section. The prudent and reasonable expenditures made by the electric utility
24 to evaluate the need for any program, software, contract or other instrument to
25 facilitate the billing, control, operation or maintenance of the public and private
26 chargers installed under the plan may be recovered by the utility through rates
27 charged to the customers of the utility.

28 7. Any electric vehicle charging infrastructure that is installed as part of a
29 plan which is accepted by the Commission pursuant to this section and which is not
30 installed by employees of the electric utility must be installed by a contractor who
31 holds a valid license in the classification required to perform such work issued by
32 the State Contractors' Board pursuant to regulations adopted by the Board and at
33 least one electrician holding a certification from the Electric Vehicle Infrastructure
34 Training Program.

35 8. Not later than 90 days after a plan is filed pursuant to subsection 1, the
36 Commission shall issue an order accepting or modifying the plan. If the
37 Commission issues an order modifying the plan, the utility may consent to or reject
38 some or all of the modifications by filing with the Commission a notice to that
39 effect. Any such notice must be filed not later than 10 days after the date of
40 issuance of the order. If such a notice is filed, any petition for reconsideration or
41 rehearing of the order must be filed with the Commission not later than 10 business
42 days after the date the notice is filed.

43 9. If the Commission fails to enter a final order on a plan filed pursuant to
44 subsection 1 within 90 days after the date on which the plan was filed, the plan
45 shall be deemed to be accepted.

46 10. Not later than 60 days after the Commission issues an order accepting or
47 modifying a plan, or a plan is deemed accepted pursuant to subsection 9, the
48 electric utility shall file with the Commission any schedules necessary to implement
49 the rate designs and programs approved in the plan. Any tariff filing made pursuant
50 to this section is not subject to the provisions of NRS 704.100.

51 11. Acceptance by the Commission of a plan submitted pursuant to this
52 section constitutes a finding that the investments contained in the plan, including,
53 without limitation, any proposed incentives to be provided to customers, are

1 prudent and that the utility may recover from the rates charged to the utility's
2 customers all costs that the utility prudently and reasonably incurs to operate,
3 maintain, develop and implement the plan, including, without limitation, any costs
4 associated with acquiring the right to use and develop private or public land. An
5 electric utility may recover the costs that it prudently and reasonably incurs as
6 follows:

7 (a) The electric utility shall begin recording in a regulatory asset, with carrying
8 charges, an amount that reflects the electric utility's investment in facilities under
9 the plan, including, without limitation:

- 10 (1) Any incentives provided to customers;
11 (2) The electric utility's authorized rate of return;
12 (3) Any depreciation of the utility's investment in the facilities; and
13 (4) The cost of operating and maintaining the facilities.

14 (b) Carrying charges shall not accrue for any month in which the electric utility
15 earns in excess of its last authorized rate of return. For the purposes of this
16 paragraph, the electric utility's earned rate of return must be calculated quarterly
17 using the 12-month period ending with the last month of the quarter and will apply
18 to the carrying charge calculation in each month of that quarter.

19 (c) An electric utility shall include a rate to recover all prudent and reasonable
20 expenditures made by the electric utility to develop and implement the plan,
21 including, without limitation, the electric utility's authorized rate of return, in the
22 electric utility's general rate application filed pursuant to NRS 704.110. The rate
23 must be charged to all of the customers in the service territory of the electric utility
24 in which the plan assets reside and reflect all costs incurred in the electric utility's
25 service territory.

26 12. As used in this section:

27 (a) "Electric utility" has the meaning ascribed to it in section 14 of this act.

28 (b) "Historically underserved community" has the meaning ascribed to it in
29 section 12 of this act.

30 (c) "Transportation electrification" means the use of electricity from external
31 sources to power, wholly or in part, passenger vehicles, trucks, buses, trains, boats
32 or other equipment that transports goods or people.

33 **Sec. 50.** The provisions of subsection 1 of NRS 218D.380 do not apply to
34 any provision of this act which adds or revises a requirement to submit a report to
35 the Legislature.

36 **Sec. 51.** 1. A resource plan filed by an electric utility pursuant to NRS
37 704.741, as amended by section 39 of this act, on or before June 1, 2021, is not
38 required to include, at the time the plan is filed, the transportation electrification
39 plan required by section 14 of this act and NRS 704.741, as amended by section 39
40 of this act.

41 2. An electric utility shall, on or before September 1, 2022, file an amendment
42 to its most recent resource plan filed pursuant to NRS 704.741, as amended by
43 section 39 of this act, to incorporate into the resource plan a transportation
44 electrification plan that complies with the provisions of section 14 of this act.

45 3. As used in this section, "electric utility" has the meaning ascribed to it in
46 NRS 704.187.

47 **Sec. 52.** The amendatory provisions of section 48 of this act do not apply to
48 an order issued by the Public Utilities Commission of Nevada pursuant to NRS
49 704B.310 before July 1, 2023.

50 **Sec. 53.** The amendatory provisions of section 46 of this act do not apply to a
51 contract entered into before the effective date of section 46 of this act.

52 **Sec. 53.5. The provisions of section 35 of this act apply prospectively.**

8 44 of this act.

9 2. As used in this section, “electric utility” has the meaning ascribed to it in
10 NRS 704.187.

12 repealed.

13 **Sec. 56.** NRS 701B.670 is hereby repealed.

15 committee may vote on this act before the expiration of the period prescribed for

17 and after March 22, 2021.

18 **Sec. 58.** 1. This section and sections 1 to ~~8.1~~ **8.5**, inclusive, 11 to 47,
19 inclusive, 49 to 55, inclusive, and 57 of this act become effective upon passage and
20 approval.

21 2. Section 10 of this act becomes effective on January 1, 2023, and expires by
22 limitation on June 30, 2023.

23 3. Sections 9, 48 and 56 of this act become effective on July 1, 2023.

24 4. Section 9 of this act expires by limitation on December 31, 2025.

25 5. Sections 27 and 31 to 34, inclusive, of this act expire by limitation on

31 otherwise.
