AN ACT relating to state financial administration; requiring a transfer to the State General Fund and authorizing disbursements of certain federal money in certain circumstances; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. As soon as practicable after receipt of the money from the
2 Coronavirus State and Local Fiscal Recovery Funds by the State of Nevada under
3 the American Rescue Plan Act of 2021, Pub. L. No. 117-2, the Chief of the Budget
4 Division of the Office of Finance in the Office of the Governor created by NRS
5 223.400, in consultation with the Senate and Assembly Fiscal Analysts of the Fiscal
6 Analysis Division of the Legislative Counsel Bureau, shall:

7 (a) Determine the reduction in the general revenue of the State of Nevada as a
8 result of the COVID-19 pandemic pursuant to the formula set forth in the Interim
9 Final Rule of the Department of the Treasury, 31 C.F.R. Part 35, RIN 1505-AC77;
10 and

11 (b) Transfer to the State General Fund an amount of the money from the
12 Coronavirus State and Local Fiscal Recovery Funds received by the State of
13 Nevada that is equal to the amount of money that is determined to be a reduction in
14 the general revenue of the State of Nevada pursuant to paragraph (a).

15 2. After the transfer to the State General Fund is made pursuant to subsection
16 1, the Chief of the Budget Division shall disburse the money received from the
17 Coronavirus State and Local Fiscal Recovery Funds by the State of Nevada in
18 accordance with the provisions of chapter 353 of NRS in the following order of
19 priority, after any other disbursements of such federal money required by the 81st
20 Session of the Nevada Legislature and as that money is available:

21 (a) Disbursement of \$335,000,000 to repay advances received by the
22 Unemployment Compensation Fund under Title XII of the Social Security Act, 42
23 U.S.C. §§ 1321 et seq.

1 (b) Disbursement of \$20,900,000 for the public health emergency of the
2 COVID-19 pandemic, including, without limitation, mental health treatment,
3 substance use disorder treatment and other behavioral health services, construction
4 costs and other capital improvements in public facilities to meet COVID-19-related
5 operational needs and expenses relating to establishing and enhancing public health
6 data systems.

7 (c) Disbursement of \$7,600,000 to address increased levels of food insecurity
8 resulting from the negative economic impact of the COVID-19 pandemic on low-
9 income families.

10 (d) Disbursement of \$6,000,000 to the Collaboration Center Foundation to
11 augment services and programs implemented to address the negative or
12 disparate impacts of the COVID-19 pandemic on persons with disabilities.

13 (e) Disbursement of \$5,000,000 to the State Treasurer to be administered
14 as grants to persons with disabilities who are under 18 years of age through
15 the Nevada ABLE Savings Program established pursuant to NRS 427A.889 to
16 assist persons with disabilities who have been negatively or disparately
17 impacted by the COVID-19 pandemic with expenses related to education,
18 housing, transportation, employment training and support, assistive
19 technology, personal support services, health care costs, financial management
20 and other qualified disability expenses.

21 (f) Disbursement of \$4,000,000 to the University of Nevada, Reno, to
22 establish a statewide program modeled after the Dean's Future Scholars
23 Program at the University of Nevada, Reno, to assist pupils who are in grade 6
24 or higher, are prospective first-generation college students and have been
25 negatively or disparately impacted by the COVID-19 pandemic. The
26 disbursement made pursuant to this paragraph must be used to provide
27 support and services related to mentorship, tutoring and access to food,
28 technology and activities and programs designed to address, support or reduce
29 learning loss caused or exacerbated by the COVID-19 pandemic.

30 (g) Disbursements for any other purpose authorized for the use of the money
31 received from the Coronavirus State and Local Fiscal Recovery Funds, within the
32 following categories:

- 33 (1) Increasing access to health care and community-based services;
- 34 (2) Strengthening public education;
- 35 (3) Supporting disadvantaged communities;
- 36 (4) Strengthening Nevada's workforce, supporting small businesses and
37 revitalizing the State's economy;
- 38 (5) Investing in infrastructure; and
- 39 (6) Modernizing and enhancing state government services.

40 **Sec. 2.** This act becomes effective upon passage and approval.
