1 WHEREAS, Each legislative session the Senate elects an officer  
2 to serve as the Parliamentarian and Chief Administrative Officer of  
3 the Senate; and

4 WHEREAS, The Senate of the 81st Session of the Nevada  
5 Legislature elected Claire Clift to serve as Secretary of the Senate  
6 for the ninth time; and

7 WHEREAS, The Secretary of the Senate is responsible for  
8 employing all of the staff of the Senate, including the Sergeants at  
9 Arms, Front Desk Clerks, Administrative Services Staff, Leadership  
10 Officers, Legislative Assistants, Committee Managers, Committee  
11 Secretaries and Proofreaders; and

12 WHEREAS, Many of the dedicated members of the staff of the  
13 Senate return to work each legislative session, some of whom have  
14 retired from other governmental service, bringing a vast amount of  
15 knowledge and experience, while others bring talent and expertise  
16 from a myriad of diverse backgrounds; and

18 COVID-19 global pandemic, the Secretary of the Senate and her  
19 able and dedicated staff worked tirelessly to ensure that the Senate  
20 was able to carry out its constitutional responsibilities under the
