INTRODUCTION, FIRST READING AND REFERENCE

By Assemblywomen Cohen and Krasner:

Assembly Bill No. 231—AN ACT relating to education; establishing the Account for Instruction on the Holocaust and Other Genocides in the State General Fund; authorizing the Council to Establish Academic Standards for Public Schools to establish standards of content and performance for instruction on the Holocaust and other genocides; imposing certain additional duties on the Governor’s Advisory Council on Education Relating to the Holocaust; requiring the State Board of Education to appoint a subcommittee to conduct an interim study on providing curriculum on the Holocaust and other genocides; and providing other matters properly relating thereto.

Assemblywoman Bilbray-Axelrod moved that the bill be referred to the Committee on Education.

Assembly Bill No. 232—AN ACT relating to legislative affairs; creating the Legislative Committee on the Reduction of Nonessential State Expenditures; prescribing the powers and duties of the Committee; and providing other matters properly relating thereto.

Assemblywoman Brittney Miller moved that the bill be referred to the Committee on Legislative Operations and Elections.

Assembly Bill No. 233—AN ACT relating to the Legislature; reducing the number of legislative measures that may be requested for a regular legislative session; codifying into statute certain provisions of the Joint Standing Rules of the Senate and Assembly that authorize requests for

legislative measures; and providing other matters properly relating thereto.

Assemblywoman Brittney Miller moved that the bill be referred to the Committee on Legislative Operations and Elections.

Assembly Bill No. 234—AN ACT relating to gaming; reviving an exception to authorize certain organizations to operate a charitable lottery without registering with the Chair of the Nevada Gaming Control Board; and providing other matters properly relating thereto.

Assemblyman Yeager moved that the bill be referred to the Committee on Judiciary.

Assembly Bill No. 235—AN ACT relating to education; requiring the board of trustees of a school district and the governing bodies of certain charter and private schools to provide support and assistance to certain pupils and their parents and guardians in completing the Free Application for Federal Student Aid; requiring the board of trustees of a school district and the governing bodies of certain charter and private schools to report certain information to the State Treasurer; and providing other matters properly relating thereto.

Assemblywoman Bilbray-Axelrod moved that the bill be referred to the Committee on Education.

Assembly Bill No. 237—AN ACT relating to real property; prohibiting a unit-owners' association for a common-interest community from charging or collecting any fee, fine, assessment or cost other than those that the association is expressly authorized or required by statute to charge or collect; revising provisions pertaining to the applicability of certain provisions of law governing the creation, alteration and termination of common-interest communities; increasing the cost of a demand or intent to lien letter; revising provisions relating to the

exemption from providing certain information in the case of certain dispositions of a unit in a common-interest community; requiring certain notice to be provided for a foreclosure sale; revising provisions relating to the sale of real property consisting of several lots or parcels; revising provisions regarding the ascertainment of title of real property to be partitioned; making certain technical changes and removing certain obsolete provisions; revising provisions concerning instruments that subordinate or waive priority of a mortgage or deed of trust of, lien upon or interest in real property; revising provisions relating to certain liens on real property; and providing other matters properly relating thereto.

Assemblyman Yeager moved that the bill be referred to the Committee on Judiciary.

By Assemblyman Roberts:

Assembly Bill No. 238—AN ACT relating to concealed firearms; revising the requirements pertaining to demonstrating competence with handguns for an active peace officer who applies for a permit to carry a concealed firearm; and providing other matters properly relating thereto.

Assemblyman Yeager moved that the bill be referred to the Committee on Judiciary.

Assembly Bill No. 239—AN ACT relating to law enforcement; authorizing a state or local law enforcement agency to enter into an agreement relating to the enforcement of federal immigration laws by officers of the state or local law enforcement agency; and providing other matters properly relating thereto.

Assemblyman Flores moved that the bill be referred to the Committee on Government Affairs.

Assembly Bill No. 240—AN ACT relating to mining; dissolving the Commission on Mineral Resources, the Division of Minerals of the Commission on Mineral Resources and the Mining Oversight and Accountability Commission; transferring the duties of the Commission on Mineral Resources to the State Environmental Commission; transferring the duties of the Division of Minerals to the Division of Environmental Protection of the State Department of Conservation and Natural Resources; and providing other matters properly relating thereto.

Assemblyman Watts moved that the bill be referred to the Committee on Natural Resources.

Assembly Bill No. 241—AN ACT relating to offenders; establishing a credit against the sentence of certain offenders incarcerated during a state of emergency declared due to a communicable or infectious disease; and providing other matters properly relating thereto.

Assemblyman Yeager moved that the bill be referred to the Committee on Judiciary.

By Assemblyman Hafen; Senators Hammond and Seevers Gansert:

Assembly Bill No. 242—AN ACT relating to taxation; revising provisions governing the amount of credits against certain taxes the Department of Taxation is authorized to approve for certain taxpayers who donate money to a scholarship organization; and providing other matters properly relating thereto.

Assemblywoman Cohen moved that the bill be referred to the Committee on Revenue.

By Assemblymen Orentlicher, Bilbray-Axelrod and C.H. Miller:

Assembly Bill No. 243—AN ACT relating to the administration of justice; creating the Nevada Police Reform Advisory Task Force and prescribing its membership and duties; revising certain provisions relating to the sentences of offenders who are less than 21 years of age; requiring each prosecutorial office to establish a system of race-blind charging to be used when determining whether criminal charges should be filed against a person; requiring each district attorney to establish a system of race-blind charging to be used when determining whether a petition alleging delinquency of a child should be filed; and providing other matters properly relating thereto.

Assemblyman Yeager moved that the bill be referred to the Committee on Judiciary.
