INTRODUCTION, FIRST READING AND REFERENCE

By Senator Seevers Gansert:

Senate Bill No. 167—AN ACT relating to taxation; revising the procedures for seeking judicial review of certain determinations of the Nevada Tax Commission or the Department of Motor Vehicles; revising provisions governing penalties for failure to pay the amount of certain determinations of

the Commission or Department when due; and providing other matters properly relating thereto.

Senator Seevers Gansert moved that the bill be referred to the Committee on Revenue and Economic Development.

Motion carried.

By Senators Lange, Brooks, Harris and Scheible:

Senate Bill No. 168—AN ACT relating to cannabis; prohibiting the Cannabis Compliance Board or a local government from imposing certain restrictions relating to the packaging of cannabis and cannabis products; authorizing a cannabis sales facility to engage in curbside pickup under certain circumstances; authorizing a cannabis establishment to satisfy certain requirements relating to the labeling of a cannabis product through certain alternative means; providing that the placement of certain signs inside a cannabis establishment does not constitute advertising by a cannabis establishment for certain purposes; requiring the Board to adopt regulations allowing for certain records of a cannabis establishment to be created and maintained in an electronic format; and providing other matters properly relating thereto.

Senator Lange moved that the bill be referred to the Committee on Health and Human Services.

Motion carried.

By Senator Dondero Loop and Assemblywoman Bilbray-Axelrod:

Senate Bill No. 169—AN ACT relating to education; revising provisions relating to pupils with disabilities to include developmental trauma and emotional or behavioral dysregulation; and providing other matters properly relating thereto.

Senator Dondero Loop moved that the bill be referred to the Committee on Education.

Motion carried.

By the Committee on Growth and Infrastructure:

Senate Bill No. 170—AN ACT relating to off-highway vehicles; revising the registration requirements for off-highway vehicles; requiring certain children to wear a helmet when operating, using or riding an off-highway vehicle; revising the membership of the Commission on Off-Highway Vehicles; eliminating exceptions from the registration requirements for certain off-highway vehicles; transferring certain duties related to the registration and regulation of off-highway vehicles from the Department of Motor Vehicles to the Off-Highway Vehicles Program of the State Department of Conservation and Natural Resources and the Commission, respectively; providing a penalty; and providing other matters properly relating thereto.

Senator Harris moved that the bill be referred to the Committee on Growth and Infrastructure.

Motion carried.

By Senator Hardy and Assemblywoman Hardy:

Senate Bill No. 171—AN ACT relating to pharmacy benefit managers; prohibiting a pharmacy benefit manager from requiring a covered person to obtain a drug by mail; and providing other matters properly relating thereto.

Senator Hardy moved that the bill be referred to the Committee on Commerce and Labor.

Motion carried.

By Senators Denis, Dondero Loop and Assemblywoman Tolles:

Senate Bill No. 172—AN ACT relating to education; revising provisions governing dual credit courses; requiring the board of trustees of a school district and the governing body of a charter school to submit a report regarding such courses to the Legislative Committee on Education and the Director of the Legislative Counsel Bureau; and providing other matters properly relating thereto.

Senator Denis moved that the bill be referred to the Committee on Education.

Motion carried.

By Senators Dondero Loop, Cannizzaro, Brooks, Denis, Donate, Harris, Lange, Ratti; Assemblywomen Anderson and Torres:

Senate Bill No. 173—AN ACT relating to education; authorizing the board of trustees of a school district and the State Public Charter School Authority to submit to the Superintendent of Public Instruction plans to address loss of learning that occurred as a result of the COVID-19 pandemic; requiring the submission to certain entities of certain reports relating to such plans to address loss of learning; and providing other matters properly relating thereto.

Senator Dondero Loop moved that the bill be referred to the Committee on Education.

Motion carried.
