Assembly Joint Resolution No. 7.

Resolution read.

Remarks by Senator Brooks.

Assembly Joint Resolution No. 7 urges the Congress of the United States to pass the National Infrastructure Bank Act of 2020, also known as H.R. 6422 of the 116th Congress, to facilitate efficient, long-term financing of infrastructure projects, business and economic growth and the creation of new jobs.

Senate Bill No. 431—AN ACT making appropriations to and authorizing expenditures of money by the Nevada Supreme Court for the replacement of computer hardware and software; and providing other matters properly relating thereto.

Senator Brooks moved that the bill be referred to the Committee on Finance. Motion carried.

By the Committee on Finance:

Senate Bill No. 432—AN ACT making appropriations to and authorizing expenditures by the Office of the Military for maintenance projects at certain facilities and the replacement of computer hardware and software, certain equipment and shop tools; and providing other matters properly relating thereto.

Senator Brooks moved that the bill be referred to the Committee on Finance. Motion carried.

By the Committee on Finance:

Senate Bill No. 433—AN ACT making appropriations to the Division of Public and Behavioral Health of the Department of Health and Human Services for maintenance and repairs and the replacement of certain equipment at certain facilities operated by the Division that provide mental health services; and providing other matters properly relating thereto.

Senator Brooks moved that the bill be referred to the Committee on Finance. Motion carried.

By the Committee on Finance:

Senate Bill No. 434—AN ACT making an appropriation to the Office of Finance in the Office of the Governor for the construction of a medical school at the University of Nevada, Las Vegas; and providing other matters properly relating thereto.

Senator Brooks moved that the bill be referred to the Committee on Finance. Motion carried.

By the Committee on Finance:

Senate Bill No. 435—AN ACT making appropriations to the Office of Finance in the Office of the Governor for the costs associated with the replacement of the Advantage Financial and Human Resources System with

the Enterprise Resource Planning System and furnishings for the operations center for the System; and providing other matters properly relating thereto.

Senator Brooks moved that the bill be referred to the Committee on Finance.
Motion carried.

By the Committee on Finance:

Senate Bill No. 436—AN ACT relating to administrative assessments; repealing the prospective expiration of a provision revising the distribution of certain money collected from certain administrative assessments; and providing other matters properly relating thereto.

Senator Brooks moved that the bill be referred to the Committee on Finance.
Motion carried.

By the Committee on Finance:

Senate Bill No. 437—AN ACT relating to justice courts; increasing the fee charged for certain actions and proceedings in justice courts; and providing other matters properly relating thereto.

Senator Brooks moved that the bill be referred to the Committee on Judiciary.

Motion carried.

Remarks by Senator Pickard.

Assembly Bill No. 150 requires the Department of Motor Vehicles to inform charitable organizations of the corrective actions they must take to end a suspension of the production and distribution of a special license plate and the collection of fees on behalf of the organization if such a suspension is warranted due to the organization's failure to comply with certain laws.

If a charitable organization does not take corrective actions or if the Department does not terminate the suspension after a charitable organization has taken corrective actions, the Department may either terminate the production and distribution of the special license plate and terminate the collection of the additional fees collected on behalf of the charitable organization, or it may distribute the additional fees to a different charitable organization that meets certain requirements.
