#### GENERAL FILE AND THIRD READING

Assembly Bill No. 35.

Remarks by Senator Kieckhefer.

Assembly Bill No. 35 consolidates two financial assistance programs for senior citizens and persons with disabilities, financed by the Fund for a Healthy Nevada, into a single program. This bill also revises eligibility requirements for the consolidated program and makes various conforming changes. Under the consolidated program, a person is eligible to receive assistance with prescription drug costs, pharmaceutical services and certain other services if he or she is a State resident and meets certain requirements prescribed, by regulation, of the Department of Health and Human Services. They must be 60 years of age or older and have a physical or intellectual disability or a related condition.

Assembly Bill No. 138.

Remarks by Senator Ratti.

I am proud to have my name associated with Assembly Bill No. 138. I brought a similar version of the bill forward, but when I learned Assemblywoman Martinez was working on a similar bill, I stepped back. I am excited to see this bill make it to our House.

This bill removes a provision in *Nevada Revised Statutes* that prohibits a person who has been convicted of a felony drug offense from receiving Temporary Assistance for Needy Families (TANF) or participating in the Supplemental Nutrition Assistance Program, which might be better known as food stamps. In the past, if one were convicted of a substance-use disorder, many hoops would need to be jumped through to demonstrate participation in treatment, maintenance of

sobriety or other steps taken. That framework demonstrates a clear misunderstanding of the journey that is recovery from substance-use disorder. On the face of it, this is inhumane, particularly when thinking about TANF. Temporary Assistance for Needy Families is for the whole family. To say that family would not get the basic support they need to have food, shelter or clothing because of the conviction of one of the family members related to substance-use disorder makes zero sense.

I am proud we are now going to recognize that, in order for people to move forward with their substance-use-disorder recovery journey. They need to have the basics of food, shelter and clothing taken care of, as in Maslow's hierarchy of needs. I strongly urge this Body to support Assembly Bill No. 138.

#### REMARKS FROM THE FLOOR

Senator Hansen requested that his remarks be entered in the Journal.

I would like to do a quick shout-out to my sister, Sharon Armstrong, who is a reading instructor in the Henderson area of the Clark County School District. I would like to expand on what was mentioned by my colleague from District 10. Today is National Nurse's Day. We need to realize that, in this COVID-19 window, the real heroes have been the nurses and doctors who have literally risked their lives to help and to protect all of us. The people in the medical community had the same fear many of us had about this virus, yet they went to work each day. Of my eight children, three are registered nurses: Sarah Hansen Gurries, Mallory Hansen Reed, and Larissa Hansen Brown, who will graduate on the 18th of this month. My daughter-in-law, Allie Hansen, is also a registered nurse, as is my Aunt Pat Davis and my Aunt Kathy Edwards. Two of my nieces, Paige and Kayla, are also RNs.

I would like to talk about someone who I wanted to talk about in 2019, but we had to cancel National Nurse's Day that year. Unfortunately, the nurse I would like to talk about passed away in October 2019. She started her nursing career in 1956, at age 12, when she was a Candy Striper at Washoe Medical Center. In 1962, she graduated from the Washoe Western School of Practical Nursing at Washoe Medical Center. She earned her LPN at that time. The person I am talking about is my mom. In 1975, she got her RN and had the highest score in the State of Nevada on the State Nursing Board examination. In 1994, she went to the University of Nevada, Reno, Orvis School of Nursing, and received her Bachelor of Arts degree in nursing. She was again honored as the top senior scholar out of 300 students in the school.

Her work career started in 1962 at Washoe Medical Center, and continued there until 1977. From 1977 until 2015, she worked as a floor nurse and supervisor. She had a career of over 50 years serving as a nurse. During that time, she had eight children, including me. She went on to teach for 20 years in the CNA program at Truckee Meadows Community College. Thousands of students went through her classes where they learned about being caring and sensitive and how to show compassion to all of the people who are vulnerable. She taught them how, as a nurse, to help preserve the dignity of their patients during this most vulnerable window of time.

She was an incredible woman. She had eight children. At her death, she had 46 grandchildren and 28 great-grandchildren. Several members of her family who are nurses carry on her legacy. They are heroes and work for all of us. They are still out there doing amazing jobs and following in the legacy of the grandmother and great-grandmother. My mom's name was Sharon Reva Corner Hansen, and I want to honor her for all of her accomplishments. In 1962, when she graduated from nursing school, she had a son who was three years old. I was that son, and she had me when she was 15 years old. Sometimes people think life can end when there are difficulties, but she overcame any difficulties and was honored, loved and revered by me. Thanks mom, and

thanks to all the nurses out there for being on the frontlines. I am happy to be able to honor the great nurses of our Nation and our State and, especially today, my wonderful mother.
