

Bills and Resolutions “Exempt” from Deadlines

Bills and resolutions may be determined to be exempt from the provisions of subsection 1 of Joint Standing Rule No. 14 (limitations on time for requests for drafting), subsection 1 of Joint Standing Rule No. 14.2 (limitations on time for introduction) and Joint Standing Rule No. 14.3 (final dates for action) at the time the bill or resolution is introduced or at a later date, or may be determined to be eligible for exemption, which means that the bill or resolution will become exempt upon referral to the Senate Finance Committee or the Assembly Committee on Ways and Means. Those bills that are determined to be exempt at the time of introduction have “EXEMPT” printed on the face of the bill. Those determined to be exempt after being introduced do not have “EXEMPT” printed on the face of the bill unless they are amended and reprinted. Following is a cumulative list of all bills and resolutions that, after being printed, have been determined by the Fiscal Analysis Division to be eligible for exemption or exempt:
